for La Grande, the meeting of the Hi Dads last evening, which was also attended by the baseball organization, harked back to the days when Jake Gilling was young and athletic, owned a bulldog and would lay off his engine run any day to match a fight with that dog.

The directors' room of the La Grande National bank last night was sporting headquarters. More baseball and high school athletics were talked during the three hour session than La Grande has known for some time.

Since the Stange saw mill needed the old fair grounds for its mill site La Grande is without a ball park and a new location is now being sought by J. H. Peary, Harris Crouch and C. H. Scranton as a committee representing the baseball organization. These gentlemen appeared with the Hi Dads to discuss the matter and it was unanimously decided that the athletic field at the high school is the logical location provided there is sufficient room, and it is believed that there is.

The baseball organization intend to erect a modern grandstand on whatever site is selected and if it could be built on the school grounds it would mean a permanent improvement and suitable for use by the schools and the public in all events.

To Review Condemnation
 Sam Harris appeared before the commissioners with a request that they review their decision of condemnation of his property, damaged by fire, on 13th street. This request was granted and action will be taken immediately.

Auto Park Discussed
 W. C. Perkins, chairman of the chamber of commerce auto tourist committee, was present and held before the commissioners a proposed site for a municipal auto tourist park in Connards. The property in question was not considered by the commissioners due to the fact that title has not yet been quieted and Mr. Perkins was given another week to investigate relative to some other site. The commissioner, however, authorized the city attorneys to begin legal action to quiet title on this property.

Gives State Rights
 At a special meeting yesterday held prior to the general meeting last evening, the city commissioners, by a resolution, agreed to turn over the city's portion of work on the proposed people highway to the state highway commission and also authorized them to advertise the work and superintend all construction.

A committee of citizens were present and requested the installation of an arc light on Spruce street behind the Greenwood grammar school building. An investigation of the question was authorized.

The city recorder was authorized to ask for bids on Sewers 1-3 on the north side.

Several other matters were intended to be heard adjournment.
