DAWES CONCISE REPLY

RYANSTON, Ill. (By the Associated Press)—Three issues, the fundamental principles of our constitution, the League of Nations and the World Court, were the principal subjects in the address of acceptance by General Charles G. Dawes of the republican vice-presidential nomination.

In discussing the constitution, General Dawes attacked the La-Follette movement, socialism and what he called "radicalism in the La-Follette movement and in one section of the democratic party."

He prefaced the address with figures on economy in public expenses effected by the republican administration.

"This," said Mr. Dawes, "is a campaign of brass tacks—not a bombast."

"This administration reduced the cost of government operation, and it was not by accident."

By this saving, he said, "approximately six million dollars per day less, for national purposes, will be collected in 1925 from taxpayers, than for the fiscal year of 1921."

In the last pre-budget year after debt payments, federal expenditures were 59 per cent and those of cities, states and towns 41 per cent, while in 1923, he said, the federal government took 41 per cent of the taxes compared with 72 per cent by the other three.

"The federal government," he added, "is headed in the right direction, and most of the state, cities and towns in the wrong direction."

Mr. Dawes said President Coolidge was "uninfluenced by motives of political expediency."

The republican party, he said, stands firmly on the constitution.

"Opposed to it," he said, "though the result may be to deadlock the presidency and make Bryanism succeed the Coolidge policy, is a movement of untried and dangerous radicalism." He said this movement had a platform drawn by one man, designed to soften "apprehension as to what the movement really means."

MANY VISIT WONDERLAND

Tourists Taking Advantages of New Accommodations at Wallowa Lake; La Grande People Numerous.

WALLOWA LAKE (Special to the Observer)—The popularity of the Wallowa Wonderland resort as a mecca for vacationists and those who delight in spending the week end away from home is undiminished and, in fact, has increased greatly during the past few weeks. It will probably reach its peak sometime about the latter part of August or the first of September, provided the summer weather does not "break" sooner.

One reason for the greater number of "wonderlandists" undoubtedly is the routing of tourists over the old Oregon Trail with the lake as the excellent brand of hospitality displayed by the owners of the resort through J. Ross Leslie, manager.

Another potent factor is that much better accommodations exist here than in 1923 and preceding years. Considerable money has been spent improving the resort this spring and the value of the added facilities are easily manifested.

Several new cabins and tents have been installed and at the present time all are occupied and it is necessary to reserve the best located cabins some time ahead in order to be sure to have one upon arrival.

Sundays, especially, are when the La Grande-Wallowa lake highway literally teems with travel, both local and tourist. Cars from every hamlet, town and city are usually in evidence, with the regular tourist trade that is received from every corner of the United States.

Wallowa lake and vicinity, often described as the sportsman's paradise, finds many an ardent disciple of Frank Walton, the hunter and the plain skier, who loves natural beauty and knows the value of a week out of doors.

Almost any morning or evening when the day's sport is over one can hear the man who caught, or didn't catch "a whopper" telling just how he did it—even down to the kind of bait used—spinner, fly or otherwise. In fact the writer is beginning to believe that a play-

er of posture makes could learn much of the art of preservation by listening in. It's really a magnificent entertainment to "time in" when some of the experts "go on the air."

Wallowa lake's natural surroundings, rugged, majestic and possessive of the beauty that was molded by a Genius, need no mention. They speak for more glowingly for themselves than a writer could for them. A master could not begin to paint an adequate picture.

Governor Pierce's suspension of the hunting season hasn't affected this resort yet and probably will not. By September 20 the forest fire hazard should be nil, although at present one must get a permit throughout the Wallowa national forest to build a fire out of doors. But the evenings at the lake always find the resort straddled with bonfires, surrounded with happy groups—often loaded with bear, using marshmallows or wafers as bullets.

Speaking of bears, the one here has grown "plenty big" during the winter and spring. Even the manager handles him with care and wrestling parties are practically taboo. The old boy still likes to be in the form of coffin pills, stogies of "chewin' tobacco." Throw him a lighted cigar and it's all the same—he merely stamps out the fire and then continues it. The only thing he can't do is smoke a corned — and therefore C. I. H. Haynes' police still letters him one.

Monday it sprinkled some and as a result cards, bowling and game rooms ruled the day. P. S. The cards were not played for "hinkies" though.

CLERGYMEN HIT CALLING; CHARGE IT IS TRIVIAL.

LONDON, (AP)—The reason for the shortage of clergymen in the Church of England was described in what he called "plain, blunt and even brutal language," by the Rev. N. L. Williams during a sermon he preached recently at Holborn.

"The work of a clergyman is, in a great part, of a dull, trivial kind," he said. "It consists mainly in the singing of choral offices which could be well rendered by a moderately efficient gramophone. The personality of the typical clergyman, developed by exclusive association with women and children, represent the sort of thing that no self-respecting boy wants to grow into."

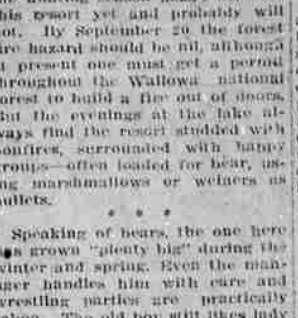
