Registration in the La Grande public schools with the addition of a few late students has now reached a total of 1804. This number includes 433 students in the high school, 422 in Greenwood school, 240 in Riveria, 540 in Central and 65 in the new Wilbur school. On the first day of school, 1743 students answered the call for enrollment. The first day attendance a year ago was 1601 thus 1924 showed a net increase of 188 students at that time. can Legion before he can gain admission to the order of Forty and Eight," declared Mr. Quinn, and it is proper that he should labor before he may trade, proper that he should toil before he may disport himself in the playground society.

"How well the Forty and Eight enters into the spirit of the legion is clear from the fact which it has played in seeking a solution for the problems presented by the orphans of our dead comrades and by the dependent children of those comrades who, maimed and broken wrecks of war, can no longer care for their children.

"Forty and Eight first saw those pitiful waifs of war, first saw with eyes that see to the heart of a problem and with souls that are stirred by a need to immediate effort to meet it. Forty and Eight perceived that here were 5,000 waifs, who had by the cruel decrees of war been deprived of the tender hand of a father to guide their infant steps through life. Forty and Eight made a high resolve that such cruel, such bitter, such mocking injustice should not be.

"Forty and Eight realized that a mother's care is necessary to these unfortunate little ones. It bent every effort to keep the child with the mother. Where that could not be, under the grim force of necessity and by the stern logic of circumstances, homes were found for them, homes in proper surroundings, where some loving heart would strive to its utmost to make good to them the place of the father and mother that were gone.

Erecting Bilets
"Today the legion is erecting children's bilets to care for these children, where the home cannot be kept together and proper foster homes cannot be provided. These bilets breathe the very air of home. The legion is determined that these children shall not be punished by lack of privileges because their fathers died for their country. It will see that the cruel blows of fate are warred and tempered insofar as they may. The disabled veterans of the war hold first place in the thought of the legion. Next after them come these helpless children."

Reviving Chief Speaks
ST. PAUL. (By the Associated Press)—Veterans of the Spanish-American and World wars heard the fortunes of battle, deeds of valor and the hardship and suffering of campaigns compared over more than two decades when Albert D. Alcorn, retiring commander-in-chief of the United Spanish War Veterans today addressed the convention of the American Legion.

"When you boys went to the World War, you remember that you were heroes in the eyes of those you were leaving behind," said Mr. Alcorn. "If you were fortunate to be among the first

In return from foreign fields, you were still heroes, but it among the last you saw very few celebrations in your honor. You were brought into the country, mustered out, and sent to your respective homes with barely mention of your service. The novelty of receiving returning troops had worn off. The people soon forgot. Many of you were lucky indeed to find your old jobs awaiting you.

"They Forget"
"The same thing applied to the Spanish-American war. They call it a little war, but they forget the days of 1898, when the people of the eastern coast and the Gulf coast were terrified and unweary with fear of a bombardment by the Spanish fleet. That had disappeared from the Azores and which was thought to be somewhere in the vicinity of our shore prepared to strike out most vulnerable spot.

"They forget that the bankers of the coast cities were so frightened and panic-stricken that they were shipping their money to interior points for safety.

"They forget that there were many anxious moments in homes from which the 212,000 volunteers came at that time.

"They forget that the terrible ravages of fever in camps in our own country caused a greater percent of fatalities than in any other war period.

"They forget that when we came home they were proud of us because the war was short; that we never lost a battle, never lost a flag, and never retreated from a single foot of ground.

"They forget that the display of fighting qualities of the men of that period opened the eyes of the world that this nation was amply able to back with force, if necessary, its ideas of freedom and justice to humanity. "We can see no reason therefore for discrimination against us in favor of the veterans of any other war in which this nation has been engaged. The same debt of gratitude and the same duty of service is due us.

Explains Matters
"See my comrades of the World war, if you have a comrade of the Spanish war, least of his service in a war that was 100 per cent volunteer, the veterans of which are grossly discriminated against, put themselves in his place. Remember, twenty years have elapsed between his war and your war. Do not think that because we are proud of our service and ask for equal consideration, that we were attempting to place obstructions in the way of your obtaining what is rightly due you.

"Numerically, we are only a small gnat as compared with you. Your power is in proportion to your numerical strength. We recognize that fact. As older veterans we need your continued help and support in order that we may receive something like the equal consideration with the veterans of all wars."
