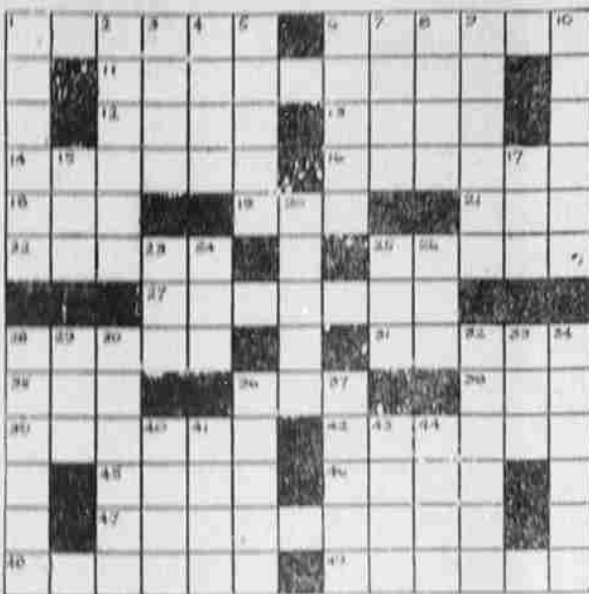

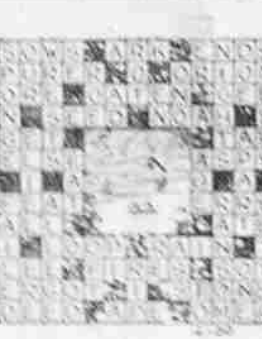
Observer Crossword Puzzle
