Notice to Contractors Highway Construction Union County Oregon

Sealed bids will be received by the county court at Union County, Oregon, at the County Court House, at La Grande, Oregon, at 10 a. m. on the sixth (6) day of June 1925 for construction work on section of the following described road in Union County, Oregon.

Between Alico and Lower Cove.

This work involves: Approximately six (6) miles of grading, approximately 25,000 cubic yards of common excavation, 200 cubic yards of solid rock excavation, 130 cubic yards of intermediate excavation, and 27,500 cubic yards of overhaul.

No bid will be considered unless accompanied by cash, bidder's bond, or certified check for an amount equal to at least five (5) per cent of the total amount of the bid.

A corporate surety bond will be required for the faithful performance of the contract in a sum equal to one-half the total amount of the bid.
