Spencer, Mar. 23. (AP)—The leaders of the Kuomintang National army, are crying for peace, giving as their reason a desire to save the country further bloodshed. Official declaration of the new policy was made today.

Threatened with an enveloping movement by the Kuomintang forces which threatened the communications between Tien-Tsin and Peking, and out maneuvered on the Lanchow Mukden railway with the possibility of Wu Pei-Fu moving from Honan province the Kuomintang had no other recourse but a hasty retreat while it was still possible.

The Kuomintang diplomatic headquarters has been removed to Kailan and this is taken to forecast the evacuation of everything beyond the Nankow pass. Thus far the retreat has been orderly.

SHANGHAI, Mar. 23. (AP)—The Shanghai Evening News says that the military governor of Shanghai has offered a reward of \$1,000,000 for the head of General Feng Yu-Shiang, leader of the Kuomintang.

Road Built 32 Years Ago. Longtime dwellers in the valley remember with what optimism they watched the laying of the first rails some 32 years ago. J. W. Shelton, a practicing attorney at Elgin, was the propagator. The railway was then known as Shelton's Motor line.

The tracks had been finished a long time before the railroad actually began to do business. Residents of the community remember. An engine from the O.-W.-R. & N. made the first runs. Later horse power was employed.

Finally the owners procured a car and a steam engine from the Oregon Street Railway company, at Elgin, Utah, where the stock had been used on an interurban line.

After several times changing hands, the road finally came under control of the late J. H. Hutchinson, father of Jim Hutchinson, a banker now at Union. The old name was abandoned for the Central Railroad of Oregon.

About nine years ago, the line was again reorganized and re-financed under the ownership of Charles Graham and a Mr. Hammer, both of New Jersey, who still control the corporation. The name was again changed, this time to the Central Railway of Oregon.

Some time before the road fell to the New Jersey company, an extension line was built from Union to Cove.

During the time that the sugar beet factory was running northeast of La Grande, the Central Railway of Oregon built another branch, extending from the Henne place, three miles beyond Union on the Cove line, to Hot Lakes. It made a few runs to haul beets from the valley ranches in that direction.

The little road is not much used these days. Outside of the daily mail trip, there is not a great deal of business. One open car serves to accommodate the mail, the baggage, the cream cans and the passengers, indiscriminately. For the most of the way, the rusty rails rest on the clover road bed, but at intervals an enduring the recalls the engineer abruptly to recollections of a day when he drove the locomotive over a regulation track.

Engineer's Duties Many. He stokes his own fire, that engineer, and his partner, the conductor, is also the brakeman. At the terminal, the traffic manager sells the tickets, dispatches the train and rustles the baggage.

But in spite of its shortcomings, the little road has one record that it proudly flaunts in the faces of its more powerful brothers: In all its 22 years it has never humped an automobile off a crossing.
