

HORSE BOLTS; RIDER IS HURT

WALLOWA, Ore. (Special).—Elyse Hunter, was seriously injured the latter part of the week when a young horse he was breaking to ride ran away with him. Hunter and Willard Bell were at one of the farms on the Hunter ranches getting their horses out and Hunter had mounted his horse and in some manner lost one of the reins when the horse started running going against a tree with such a force that the rider's collar-bone was broken. The horse continued to run for about two miles before it could be stopped. Bell got onto another horse and started in pursuit of the runaway and was also somewhat injured when his horse fell and rolled over him.

German Drive Against Immodest Dress Grows

BERLIN, Apr. 2. (AP).—The campaign against immodest dress and modern dance is spreading to all branches of the German nobility. Following the edict of former Bavarian royal houses that only waltzes and polkas were to be danced at elite social functions, the executive committee of the Deutsche Adelsgesellschaft, an organization of deposed nobility, has issued a statement that it is "unbecoming for women to be slaves of fashion and neighbors of the demimonde."

Women of noble birth ought never to wear gowns which expose too much of the body the statement continued. "Immoral" dances must be banned. HEALTH

GETTING THE TRUTH
(By Dr. Frederick Steicker)
The opinions of most people are largely based upon what they read and hear. The person who tries to avoid prejudice, to maintain what he calls an "open mind" and to get at the real facts often finds himself puzzled and confused by conflicting opinions.

To illustrate an example, a mother of a school child attended a meeting in which a representative of the state health department advised that all children under the age of 16 should be given toxin-antitoxin to protect against diphtheria. It is a simple and safe procedure, and if all children could thus be protected, this disease so often fatal to children would be eradicated. A day or two later she reads an article sent out by an organization, the purpose of which is to oppose vaccination, the use of anti-toxin, and everything which it calls "compulsory medicine." Toxin-antitoxin, this article said in substance, contains a powerful poison, its use is dangerous and unnecessary, and the health department are foisting it upon an unsuspecting public for the benefit of the medical profession.

Here is a direct conflict of opinion, and this mother no doubt asks the question, "What shall I believe?" She usually decides to accept the advice of her doctor whom she knows and in whom she has confidence. Her child receives the toxin-antitoxin and is protected.

"Shades of opinion may be hesitantly entertained by honest and truthful men," said Abraham Lincoln. However, when directly opposing views are expressed, one or the other must be wrong. Considerable misinformation is circulated by gossip, people who express positive opinions on subjects they know little about. They do little harm in a way, if their circle of influence is limited. On the other hand, a group of prejudiced and often misinformed people, thoroughly organized, with well paid publicity agents whose job is to oppose by hook or crook a scientifically established health measure, can do a vast amount of harm by misleading people.

We advise those who find themselves confused by conflicting opinions on health matters, not to jump at conclusions. Inquire into the source of the opinions and look for the motive back of them. The physicians, maintaining the health officers, in any community are men of standing with reputation to maintain. As a class, physicians are conservative. There is more money for the most of them in treating disease than in preventing it. When they advise a health measure it is because they believe in it. The sole purpose of the state health department is to protect the public health. To retain the public confidence it is bound to be conservative. It cannot afford to stand back of anything whose value and safety has not been established.

When there is an apparent conflict in evidence for and against a measure recommended by the health department, be sure and get the facts before drawing definite conclusions.
