"Conditions Intolerable"

"Present conditions as regards liquor are intolerable, and people are beginning to realize that those who propose a remedy are not necessarily marked with cloven hoofs and horns," said McLain.

"I think it possible to amend the eighteenth amendment by the insertion of the words 'except the government' which would permit the government to engage in the liquor business. The saloon is gone forever and nobody wants to see it come back."

SALEM, Ore., Apr. 15. (AP)—Seymour Jones, Marion county farmer and former member of the legislature, who until recently has been considered as a probable candidate for the republican nomination for governor on an income tax platform, announced this morning that he had definitely decided not to enter the contest.

MEDFORD, Ore., Apr. 15. (AP)—The Jackson County Dog Protective association, in a statement issued today, served warning that "if one more dog is killed inhumanly and illegally, the state humane society will be asked to take immediate action." The association in the statement alleged that dog catchers, choke their prey into semi-consciousness before taking to the pound, and the doomed dog died "in great agony from being hit on the head with a club or hammer." The city is urged to kill with gas, and the association suggests that some action be taken against chickens, "that scratch up flower beds and gardens, and cats that howl all night."

Eugene Candidate Is Opposing Dennis Plan

George, of Eugene, who yesterday filed with the secretary of state his declaration as a candidate for the republican nomination for representative in the legislature for Lane county.

Other candidates filing were: A. T. Peterson, Toledo, republican, representative from Polk and Lincoln.

CHILDREN ON PICKET DUTY

WASHINGTON, Apr. 15. (AP)—Children of the textile strikers at Passaic, N. J., appeared at the white house today to picket the grounds as a protest against conditions they said existed at Passaic.

The delegation, numbering six children and five adults, marched into the white house grounds with placards upraised but were told these could be displayed under the regulations.

The leaders of the pickets were received by Secretary Sanders who said he could see no warrant for action by the president. He referred them to the labor department. They first decided to depart, but changed their minds and decided to picket the grounds for a while and then parade down Pennsylvania avenue with their banners.

GOVERNOR WILL MAKE DECISION ON CODY TODAY

SALEM, Ore., Apr. 15. (AP)—Not until late today is Governor Pierce expected to announce his decision whether Archie Cody will go to the gallows at 8:30 o'clock tomorrow morning. This was indicated after a hearing in his office yesterday in which friends and relatives of the family and social workers from Portland made a plea for the man's life. Cody was convicted of killing Sheriff Goodman, of Harney county.

The argument for commutation of the sentence to life imprisonment was based mainly on the question of mentality. It was declared that Cody's mentality is about that of a child of 15 years. Twenty-one persons made the plea for the slayer's life.

between 1919 and 1923. Representative Hill, republican, Maryland, head of the wet bloc in the house, led off for the house advocates of a campaign in the dry laws, using his own acquittal some months ago by a Maryland jury as a precedent to support his contention that the making of drinks with a substantial alcoholic content is constitutional.

One of the three women representatives in congress, Mrs. Mary T. Norton, democrat, New Jersey, a former welfare worker, advocated a national referendum in question of bringing to an end the present "horrible condition." Questioned by Senator Reed, who said the effect of prohibition had been to "ruin a great many of our young people." She read a letter telling of the sale of poison in a veteran's bureau hospital with the result that some of the patients died. The name of the hospital was withheld.

Representative Kindred, democrat, New York, a physician, declared experiments which he had conducted on himself and others, had "proved conclusively" that the 275 per cent beer sold during the war was non-intoxicating.

The concluding testimony was given by Representative Lathum, democrat, Maryland, who said "the young buck of the present" had to carry a whisky flask if he wanted to be popular with his set.

It was agreed that the drys would begin presentation of their case tomorrow.

BOSTON, Apr. 15. (AP)—General Lincoln C. Andrews, in charge of national prohibition enforcement, should resign if he is not in agreement with the law he is set to enforce, in the opinion of Mrs. Henry W. Peabody of Beverly, chairman of the Women's National Committee of Law Enforcement. Mrs. Peabody, who headed a delegation of women in support of the Volstead act at the senate prohibition hearing, arrived here today. She criticized the manner in which the hearing was conducted.

WASHINGTON, Apr. 15. (AP)—Assistant Secretary Andrews, in charge of prohibition enforcement, in a formal statement today said he was advocating no change in the prohibition law.

He said the statement was issued to explain that his answer yesterday before the senate committee investigating prohibition that distribution of non-intoxicating beer might be helpful to enforcement, was in answer to a hypothetical question.
