WASHINGTON (By NEA Service)—Four new faces will be seen in the United States senate when it convenes in December.

Senators Cummins of Iowa, and Fernald of Maine, died during recess. David W. Stewart succeeds the former.

Senators Butler, of Massachusetts and Williams, of Missouri, do not come back like the other "lame ducks," but dropped out immediately upon being beaten at the polls, never having been elected senators, but only appointees, to fill vacancies.

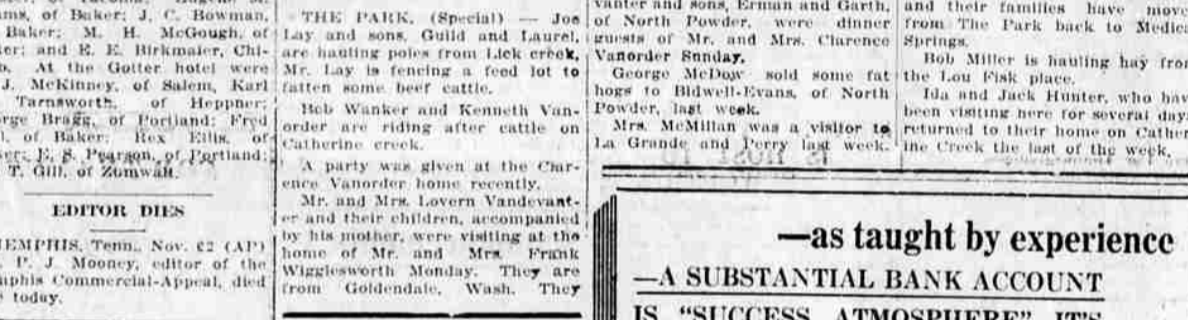

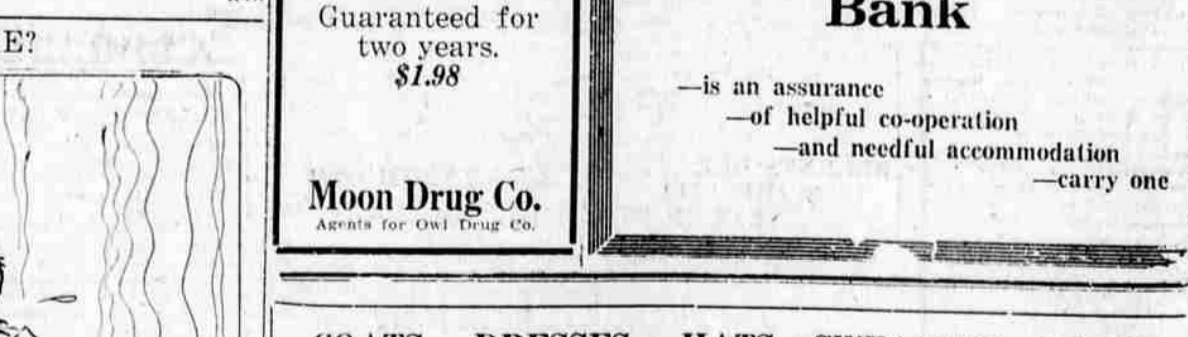
