Seed crops have proved to be among the most profitable grown on irrigated lands of Deschutes and Crook counties, county agents report. White, red and albino clover have already proved their worth and now plans are under way for a series of demonstrations showing the desirability of growing garden pea seed. Adaptability of the region to growing pea seed is well known, and it is with the expectation that central Oregon will become one of the principal producing sections that these demonstrations are to be conducted.
