64 GIVE SEATS TO SUCCESSORS
Eleven Senators and 53 Representatives to Serve No More
WASHINGTON, Mar. 5. (AP)—Eleven senators and 53 representatives, many of them wheel horses of their party organizations, returned to private life or went to other public offices with the death of the 69th congress.

The senate committee lost their chairman, while in the house only two minor committee chairmen retired.

Among the stalwarts of the senate to retire was Senator Oscar W. Underwood, democrat, Alabama, who closed a 30-year career in congress, where as democratic leader in both house and senate he held the highest places his party could offer him. He plans to take things easy in an effort to regain his health.

Less Two Veterans
The republicans lost two of their veterans in Wadsworth, of New York, and Lenroot, of Wisconsin, who were defeated for re-election after serving in the senate for 12 and nine years, respectively.

Wadsworth returns to his farm in New York, while Lenroot will practice law in Washington.

In the house, Ogden L. Mills, of New York, powerful factor on the ways and means committee, went out of office to accept post of under secretary of the treasury, and J. N. Tinscher, of Kansas, the largest man in congress and a picturesque figure in the republican party for years, will go back home to engage in the oil business.

Other spectacular representatives to leave the house were William D. Upshaw, democrat, Georgia, and John Philip Hill, republican, Maryland, who respectively represented probably the most outspoken views for and against prohibition in congress. Upshaw, who was defeated for renomination, will go on the chautauqua platform, while Hill, who failed to win a senate nomination, will retire to his Baltimore home to watch the prohibition battle from the side lines.

It provides that any person convicted of a felony the second time shall be sentenced to not less than the maximum penalty. A fourth conviction of a felony automatically requires life imprisonment.

Many believe that this law will serve as a decided check to Oregon's "crime wave" and it is said that the statute has the general support of the people of the state.

State Senator A. R. Hunter is of the opinion that the legislature accomplished much during its recent session, especially in reference to education and taxation. Besides the income tax measure, some other bills, including the one providing for equitable assessments of properties, are expected to increase the state revenue and also distribute the tax burden fairly.

Better Teacher Training
The outstanding education measure, in his opinion, was the bill to provide for better teacher training. It requires an increase to 48 weeks of training in 1929, a further increase to 60 weeks in 1931, and a final increase to 72 weeks in 1933. Senator Hunter explains that this "stepping up" process adopted was necessary so as to permit the state institutions to adapt themselves to the change. He also believes that the Eddy education bill, which lost out, would have been a step in the right direction.

Game laws were also beneficial to sportsmen. Several rivers were closed to commercial fishing and some changes were made in the game seasons. Hunter introduced a law providing for regulation of racks so as to permit game fish to pass through, but this was killed after passing the senate.

Of course, the passage of the Eastern Oregon normal school appropriation, which insures beginning of construction of the first buildings this year in La Grande, was the outstanding piece of legislation in the minds of most local people.

The next step, it is believed, will be the selection of a site for the building here from among the several which the city has offered to the normal school regents. This will probably take place in the near future. The general opinion of La Grande is that the site selected at the east house will be favored.

In today's issue of The Oregonian, among a list of 40 bills reported voted by the governor, is the following: "H. R. No. 559—providing for construction of Eastern Oregon normal school." When called, Senator Hunter declared that this must be an error, inasmuch as the bill providing for the construction of the Eastern Oregon normal school and also including appropriations, was a senate bill. This is printed to do away with any possible confusion that might result from the printing of the above item in The Oregonian.

U. S. Marines on Parade in China For "Exercise"
SHANGHAI, Mar. 5. (AP)—United States marines today gave Shanghai one of the finest military displays which the navy international troop concentrations have furnished. Fifteen hundred of them paraded through the streets of the city for two hours, not as a show of force, the authorities announced, but merely to provide exercise for the men.

Landing at the Bund, the marines marched to the race course, where Colonel Hill, commandant, reviewed. Then they marched down the historic Nanjing road with pennants flying, and their automatic rifles slung over their shoulders. The band blared "Valencia."

They marched through brilliant sunshine, as tremendous noonday throngs of thousands of Chinese looked on undemonstratively. The majority of the foreigners in Shanghai turned out for the review at the race course, where besides the Americans, several companies of British and Japanese drilled.

HANKOW, Mar. 5. (AP)—The Standard Oil motor vessel, *Monte Sun*, which was commandeered by Chinese nationalists near Shanghai on February 17, has been recovered by the United States gunboat *Pigeon*, near Hankow.

SHANGHAI, Mar. 5. (AP)—The southern Chinese army is making strenuous efforts to reach Shanghai by way of the Nanjing railway which is the main line of communication of Shanghai. His Shanghai forces, replacing the shattered remnants of Marshal Sun Shuan-fang, have the task of preventing the southern front encroaching on the pivotal city of Shanghai. The southern army is temporarily directed most of their attention against Soochow, 60 miles west of Shanghai; their advance guards are reported to be 12 miles from that place.

It first stated that this committee should be composed of seven members, the resolution stating that Governor Patterson, ex-Governor Pierce and ex-Governor West should be members and that the other four should be named by the speaker of the house.

Governor Patterson quickly objected, so the house renamed the personnel, leaving out Patterson and Pierce and putting in their places Attorney General Van Winkle and Colonel Alfred E. Clark, well known Portland attorney. West remained.

U. S. Marines on Parade in China For "Exercise"
SHANGHAI, Mar. 5. (AP)—United States marines today gave Shanghai one of the finest military displays which the navy international troop concentrations have furnished. Fifteen hundred of them paraded through the streets of the city for two hours, not as a show of force, the authorities announced, but merely to provide exercise for the men.

Landing at the Bund, the marines marched to the race course, where Colonel Hill, commandant, reviewed. Then they marched down the historic Nanjing road with pennants flying, and their automatic rifles slung over their shoulders. The band blared "Valencia."

They marched through brilliant sunshine, as tremendous noonday throngs of thousands of Chinese looked on undemonstratively. The majority of the foreigners in Shanghai turned out for the review at the race course, where besides the Americans, several companies of British and Japanese drilled.

HANKOW, Mar. 5. (AP)—The Standard Oil motor vessel, *Monte Sun*, which was commandeered by Chinese nationalists near Shanghai on February 17, has been recovered by the United States gunboat *Pigeon*, near Hankow.

SHANGHAI, Mar. 5. (AP)—The southern Chinese army is making strenuous efforts to reach Shanghai by way of the Nanjing railway which is the main line of communication of Shanghai. His Shanghai forces, replacing the shattered remnants of Marshal Sun Shuan-fang, have the task of preventing the southern front encroaching on the pivotal city of Shanghai. The southern army is temporarily directed most of their attention against Soochow, 60 miles west of Shanghai; their advance guards are reported to be 12 miles from that place.
