NEW YORK, July 6 (AP)—Easing credit conditions and the increased investment demand created by record-breaking dividend and interest disbursements acted as a strong stimulant in the stock market today, offsetting the earlier decline of the commodity price index and a continuance of mixed industrial conditions.

Some exceptional gains were made, Commercial Solvents "B" moving up 10; Nashville, Chattanooga and St. Louis and Laclede Gas & Sterling Products, 8 1/2; Houston Oil 5 1/2; South Porto Rico Sugar (old) 5, and several other shares were quoted materially above yesterday's final figures.

Stocks which have been nourishing a large short interest went up rapidly, including some of the rears. Baldwin touched 237 1/2, a new peak. Total sales approximated 1,700,000 shares.
