BALDWIN LOCOMOTIVE UP; OTHER ISSUES ON SLIDE

NEW YORK, Oct. 22 (AP)—A spectacular rally in Baldwin locomotives which jumped from \$200 to \$252 1/2 a share in the last 15 minutes of trading, was the outstanding feature of the stock market today when prices in practically all other sections of the list were well below yesterday's closing levels.

So great was the volume of trading in the last few minutes that

final quotations did not appear on the ticket tape until 25 minutes after the market closed. When Baldwin was quoted on the tape at \$243 1/2 a share, it was actually selling on the floor of the exchange at \$252 1/2.

It was the fourth consecutive day in which prices generally closed lower and the fifth of the week. Extreme losses ranged from fractions up to 3 1/2 a share in Case Threshing Machine and Henthin Oil, while several other issues at times were 1/2 or more below their previous final figures. Baldwin got down \$6.50 a share just before its final spurt, which transformed the loss into a net gain of \$5 a share.

New lows for the year were recorded among the sugar shares, and by several other such issues as Lackawanna, Lehigh Valley, Advance Rumely common and preferred and International Mercantile Marine preferred.
