NEW BUDGET
IS ADOPTED
FOR SCHOOLSElection Here Saturday
Results in Victory by
Four VotesINCREASE DUE TO
BOND RETIREMENTBoard of Education to Pay
Off \$15,000 Outstanding
Bonds Yearly Instead of
\$10,000.

Both measures on the ballot for the school election for district No. 1 (La Grande) were adopted Saturday, although by a slight margin.

The election was marked with a light vote and quietness, only 204 voting on the adopting of the budget and voting of a tax, and 798 on the measure to expend more than six per cent over last year's total.

New Budget \$121,664.20

The amount of the budget voted Saturday is \$121,664.20 compared with \$115,591 in 1926 and \$109,413.55 in 1925. The increase in the new budget is due to a refunding of outstanding bonds which provides that \$15,000 principal of that outstanding bonds will be retired annually, beginning with the new year, instead of only \$10,000. Deducting this amount the increase over last year only amounts to about \$1,000.

In the new budget, reduction of expenses are arranged in repairs, buildings and grounds and other miscellaneous items and an increase is called for in the personal service account, due to increased teachers salaries and additional teachers.

Close Election

There are three regular sources of money for the upkeep of school districts: county, state and elementary school funds. When these three items are not sufficient, additional taxes are necessary, which is almost always the case in towns and cities.

The vote Saturday follows:

To expend more than six per cent over last year's total:

Central school: yes 84, no 55;

Greenwood school: yes 17, no 42;

total: yes 101, no 97.

Adoption of school budget and

voting list:

This was one of the closest school elections in local history, although there was nothing to indicate any unusual interest on either side. Some school authorities feel that a recent decision resulting from the petition to remove the city, extended their efforts to reduce principal of bonds in a much larger amount than the school board provides.
