IS ADOPTEDAddition of \$114.40 to the
High School Tuition
Fund Only ChangeCOURT COMMITTEE
DECIDE YESTERDAYTotal to Be Raised by Tax-
ation \$383,650.40—Ex-
penditures for the Year
About \$426,000.

Union county's budget, totaling \$426,000 of which \$383,650.40 is to be raised by taxation, as arranged by the budget committee at a meeting Nov. 4, was adopted yesterday, with an additional \$114.40 to be added to the high school tuition fund, when the committee met for a hearing in the county judge's office at the court house.

The additional sum was necessary as required by law, to take care of the expense of a Union county student who is attending school in Willamette county. It brings the high school tuition fund to \$25,114.40, instead of \$25,000 as planned in the budget originally, increasing the amount to be raised by tax levy in the county for schools and libraries to \$383,650.40, instead of \$383,075.

Total Receipts
The total receipts for the year, as outlined in the budget, amount to \$212,950, leaving the amount to be raised by tax levy \$383,650.40.

A committee from the Union county chamber of commerce visited the committee in the interest of a county health unit, but no action was taken until more information in reference to the workings of a unit of this kind is available.

The matter will probably come to the attention of the county court, Dec. 15, at which time a meeting has been set to make the tax levy, as the state figures will probably be on hand by that time.

Sheep Men Will
Gather Tonight
At Local HotelTo Discuss Problems and
Elect Officers; Indus-
try Shows Gain in This
County in Year.

Leaders of one of Union county's principal industries will discuss their progress of last year, their prospects for future years when they gather tonight at the La Grande hotel in the second annual meeting of the Union County Wool Growers' association.

A full evening into which a lengthy program, intensively interesting to the sheep man, will be heeded, so to speak, and during which the year's business including election of officers will be transacted in a store for some 20 or 30 growers who are to assemble tonight. S. E. Miller of Union, will preside.

On the eve of a completed year the association members appropriately look back over the year's accomplishments. This year they may make this retrospection with deserved pride for they have gone decidedly forward in 1927. A net gain of six per cent in the number of sheep in the county as compared to last year has been made. Union county now has 25,000 head of sheep, about 6,000 of which are farm sheep. The gross income of wool and lamb was more than \$300,000 during the completed year. This figure, gleaned from Harry Avery, county agent, he speaks a steady climb of the industry.

While no definite answer has yet been received from Hugh Sprout, secretary of the Oregon Wool Growers' association, Mr. Avery fears that Mr. Sprout will not be able to be here tonight. Another out-of-town speaker is scheduled for the program, however, in J. C. Kuhns, supervisor of the Whitman national forest who will speak on "A Range Sheep Industry and the National Forest."

NEW MARK IN
CIRCULATIONLocal Institution Loaned
More Than 10,000 Books
During NovemberIS BEST RECORD
IN ITS HISTORYMiss Mabel Doty, Librarian, Believes Growth Is
Largely Due to Children's Book Week.

This is an era of record-breaking. FARM RELIEF
BILL FILED
BY McNARYNew Measure Contains
Controversial Equalization
Fee ProvisionOREGON SENATOR
EXPECTS SUCCESSBelieves Coolidge Will
Find a Way to Sign It—
Vote Is Expected by
Early February.

WASHINGTON, Dec. 10 (AP)—The McNary-Haugen bill—vetoed last session by President Coolidge—has been started on its way through congress again in slightly modified form.

Senator McNary, republican, Oregon, new chairman of the senate agricultural committee, put the new bill in the senate legislative hopper late yesterday soon after it was formally opened for business. The new measure contains the controversial equalization fee provision—objected to by the president as unconstitutional in vetoing the original bill—as a means of raising funds to meet the cost of marketing surplus crops.

The equalization fee, however, would now be invoked only after cooperative marketing associations with the aid of government funds found themselves unable to handle the surplus and the fees then would be applicable to all commodities, when required, instead of to only a part.

An early start on the farm relief issue, already involved somewhat in the republican presidential campaign, seems certain in congress, Chairman Haugen of the house agricultural committee, co-author of the McNary-Haugen measure, announcing today he would begin hearings next week.

A majority of republicans in the senate also have given assurance to the western independent group of their party that a vote on the McNary-Haugen bill in some form would be permitted by early February.

Senator McNary has been looked upon by President Coolidge as the leader in efforts to work out the farm relief program on a basis acceptable to himself and congress but how near the new bill of the Oregon senator comes to a compromise acceptable to the president is problematical.

Senator McNary said last night he had "every expectation" but no definite information that Mr. Coolidge would find a way to sign the new measure. But other administration leaders seemed to doubt that the president would find it possible to approve the equalization fee even in modified form.

Jury's Verdict
Is: Not Guilty

WILLIS BEACH GIVEN TEN YEARS

MAYS LANDING, N. J., Dec. 10 (AP)—Mrs. Margaret Lilliendaahl and Willis Beach, convicted of voluntary manslaughter for the killing of the woman's aged physician husband, Sept. 15 last, today was sentenced to 10 years each at hard labor in the state prison at Trenton.

Mrs. Lilliendaahl had to be assisted to her feet when she rose to receive sentence. As Justice Campbell slowly pronounced the words "hard labor for ten years" the widow's shoulders heaved. She breathed with apparent difficulty then burst into tears. Beach's face remained impassive.

LITHUANIA AND
POLAND FRIENDS

"Peace or War" Question
Brings Dramatic Reply:
"It Is Peace!"

GENEVA, Dec. 10 (AP)—"Peace or war" that was the question Premier Pludskis, of Poland, dramatically asked Premier Waldeckmaras, of Lithuania, at a secret session today of the council of the league of nations at which an agreement "in principle" was reached on the Polish-Lithuanian controversy.

"It is peace," answered the Lithuanian leader, clearly, looking the Polish leader full in the eye. Then the two statesmen undertook certain reciprocal engagements to guarantee peaceful settlement of the controversy which had caused such tension in the Baltic states and for that matter in all Europe.

Crisis Dramatic
The crisis in the negotiations over the Polish-Lithuanian controversy was supremely dramatic as described by those present at today's secret session of the council when the Baltic quarrel, in the view of the council members, was liquidated.

Premier Pludskis, Poland's iron marshal, his face grim and haggard with lines caused by the fatigue of his journey from Warsaw and exhaustive conversations with various statesmen, leaned suddenly over the table. He pointed his finger at the diminutive, but energetic professor

PORTLAND, Dec. 10 (AP)—State Treasurer Thomas B. Kay is quoted today by the Portland Telegram as saying that he would be a candidate for the republican nomination to succeed himself.

Slayer Of Bride
Is Found Guilty
By Kansas Jury

EUREKA, KANS., Dec. 10 (AP)—Ivan M. Hart, confessed slayer of his bride of three weeks, today was found guilty of second degree murder by a jury in district court here.

The case was given to the jury at 9 o'clock last night after defense attorneys pleaded "communicative insanity" caused the 31-year-old bank employee to slash his bride's throat when she demanded he kill her because she feared motherhood. The verdict was returned shortly after 2 o'clock this morning.

After several days of testimony, including that of scores of Hart's business associates who appeared as character witnesses, he testified he was unable to resist his wife's plea for death and that after slaying her he attempted to end his own life.

21 MORE MAY
BE ADDED TO
STORM TOLLCrew of Steamer Agawa,
on Reef Near Manitoulin
Island, Faces DeathRESCUE PARTIES
AID OTHER SHIPSGales in Midwest Subsid-
ing Somewhat—Milder
Temperatures Reported
in the Lake Region.

CHICAGO, Dec. 10 (AP)—Fear that 21 more deaths might be added to the toll of more than 300 exacted by the nation wide storm and intense cold wave was expressed in word reaching here from Providence Bay, Ontario.

Scant hope was held for the rescue of the 21 members of the crew of the steamer Agawa fast on a reef near Manitoulin Island, since Wednesday. Shore watchers, waiting abatement of the storm to go to the rescue, feared the men either had died from exposure or had been trapped in the forward part of the boat by the sheet of ice. Ice encased the portion of the ship in view above the surface, and with the temperature still below zero, was gradually thickening.

Rescue Parties Out
Rescue parties hastened to the aid of many other wind-whipped ships from various Great Lakes ports. The coast guard at Eagle Harbor, Michigan, prepared to proceed to the wrecked steamer Altadoff off Keweenaw point. No word had been received at Calumet of the crew's rescue, although such a report had reached Sault Ste. Marie, Ont. A cutter from two Hudson's Bay posts, was reported on the way to the Altadoff's aid.

An unidentified freighter, coated with ice, was driven ashore in Lake Superior not far from Marquette, Mich., but members of the crew could be seen from shore and appeared in no immediate danger.

Gales Subsidizing
The gales which have swept from coast to coast have subsided in the Lake region, and the Middle West today was greeted by milder temperatures.

Minnesota, Wisconsin and the Dakotas continued their attempts to restore train and highway travel to normalcy, although the mercury refused to budge upward in far northern points.
