AT THE THEATERS

Super-Mystery Comedy Feature At Arcade

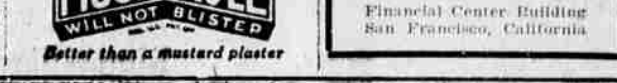
