HICKMAN TO LEARN FATE ON SATURDAY

(Continued from Page 1)

...on a street corner that rang with the shouts of newsboys. In the home of the family of Little Marian Parker, where grief still clings, the news of the verdict was received almost listlessly. The mother of the school girl victim received it in stony and immobile silence.

"I'm satisfied — satisfied and wanting only to forget," said her father, Perry M. Parker.

Plans Made for Appeal
Hickman's attorneys announced an appeal would be taken on the legality of the entire proceeding and the constitutionality of the new California law under which the plea of "not guilty by reason of insanity" was entered and received.

In addition to the notice of appeal which they intend to enter tomorrow his attorneys will file a motion for a new trial.

Entrist Attorney—Ann Keyes said he would fight every attempt to delay the case but admitted that if Hickman were sentenced to be hanged, court action probably would delay the execution for several months.

The prosecution also said it was probable that the prosecution of Hickman on a second murder charge—the killing of C. J. By Thomas, druggist, during an attempted holdup—would not be pressed until the present case had been settled in the higher courts.

Hickman's attorneys said they anticipated that the Thomas trial would be delayed especially if Hickman's accomplice in the holdup, Wesley Hunt, pleaded guilty and placed himself on the mercy of the court.

State Wins "By Neck"
Hickman's own lawyer would not have indicated that he expected to be hanged. In addition to his remark about the state winning "by a neck" he considered a request said to have been telephoned from the University of Chicago asking for his body in case the death sentence were carried out.

He discussed the request in a luncheon with his attorney and would consult his attorney about it.

Others connected with the trial found nothing humorous about it. The matter of procedure and punishment must be threshed out according to the provisions of the new statute. The jury in the case did not pass upon the question of Hickman's guilt, nor the facts concerning the commission of the crime. Its sole duty was to declare him sane or insane. Hickman's plea of "not guilty by reason of insanity" was a legal admission that he committed the offense charged.

Seeks Stipulations
Judge Trabucco sought stipulations from prosecution and defense whereby the trial testimony might not be used in determining Hickman's guilt. This would obviate the necessity of calling the witnesses again and expedite the matter of fixing punishment.

Although the defense attorneys declared they would use every opportunity under the California law to save Hickman and even might carry the case to the United States supreme court, observers here be-

Receive 4 Bids For Government Steamship Lines

WASHINGTON, Feb. 10, (AP)—Four bids were received by the shipping board today for three government owned steamship lines operating from the Pacific coast. They were turned over to the merchant fleet corporation for investigation.

The Matson Navigation company and the American Hawaiian Steamship company bidding jointly for a corporation to be formed, offered \$1,281,552.50 for the 21 ships of the American-Australian-Orient line. The Eastern division of the Admiral Oriental line owned by the Dollar interests, bid \$670,257 for the seven ships of the American Oriental line.

The Tacoma Oriental Steamship company which is to be organized bid a total of \$638,300 for the American Oriental line, while for a company to be formed, K. I. Dawson of Portland, Ore., bid \$1,965,900 for the Oregon Oriental line.

All bids were accompanied by the necessary 22 1/2 per cent of the bids. It was noted there would be no plea for leniency.

PERFECTING APPEAL

LOS ANGELES, Feb. 10, (AP)—Attorney for Marion Parker's slayer, William Edward Hickman, who yesterday was adjudged sane by a jury, announced today that they appeal to the state supreme court would be based principally on Judge J. J. Trabucco's charge to the jury.

The judge, said Jerome Walsh, chief of counsel for Hickman, failed to instruct the jurors that they might, if they wished recommend leniency for the prisoner.

"I'm all ready for sentencing tomorrow," Hickman said today but not in the joking mood he displayed late yesterday after the jury verdict had been returned. He was in the sullen, half smirking frame of mind that characterized his conduct during most of the trial.

"It hasn't got me scared any," he insisted. "I won't grow grey hairs because some one passes a death sentence." He appeared to be usual studied and sullen control of his feelings.

File Appeal Tomorrow
Walsh engaged himself with his associate, Richard Carlton in going over the trial transcript, preparing the appeal, which they will file tomorrow.

Hickman asked newspaper men today for information on the manner and details of hangings they had witnessed. He wanted to know if "they passed out in a hurry" or if "it hurt them any."

When told that hanging usually breaks the condemned man's neck he wanted to know if "they die right away."

The answer that some do not die immediately that all feeling was extinct, seemed to reassure him. He laid back in his cell bunk, his hands under his head and asked for "more, all the details."

The youthful murderer thanked his interviewers for the information, but still he didn't seem to care that probably he soon would hang. He failed to display any fear.
