10 Doukhobors Arrested After Using Tear Gas

GRAND FORKS, B. C., Jan. 29 (AP) — Holding ten prisoners, taken with the aid of tear gas, police stood victorious today in their second clash with the Doukhobor fanatics.
The first skirmish was won last Friday by naked fanatics, when they put to rout two provincial policemen sent to arrest members of the colony for taking their children from school.
Returning to the attack yesterday, 14 police found 50 members of the colony, men and women, mobilized in a house. The fanatics resisted the invaders and a lively battle ensued in which the women joined.
Leader Stands Pat
When the officers turned the tear gas into the house there was a rush for windows and the beating of pots and pans. The smoke from the overturned stove, Strennikoff, leader of the colony, refused to leave the house. Police dragged him naked into the snow before he ceased to resist.
The Doukhobors, otherwise known as the sons of freedom, are Russians whose religious tenets include the belief that Christ was wholly human. The rules of their sect also forbid the wearing of clothing even in sub-zero weather.

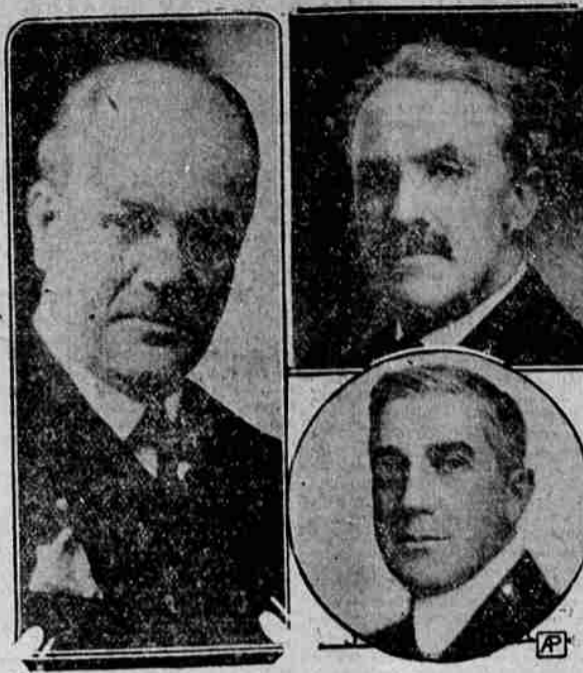

land, whereby counties cooperate to the extent of an average of about 25 per cent, the cost to the counties will be about \$5,000,000. In some cases, he says, the counties contribute as high as 50 per cent.
Also the state has authority under the highway act to provide federal money to the counties for the construction of primary arteries as the Roosevelt and Burns highways. The legislators are said to be agreed that they will favor no proposal contemplating the issuance of more bonds and members of the bloc this morning stood unshaken in their position in the face of agreement by R. W. Sawyer and C. E. Gates, highway commissioners, with Governor Patterson and sponsors of the bond proposal to issue \$1,000,000 in bonds annually to match federal aid appropriations, if they can be shown where the money to carry the bond load is coming from.
Opposed to New Jobs Now
Asserting that his position as relating to the highway program has been misinterpreted Senator Bell, Lane county, now declares that he is opposed to the addition of any new roads to the highway program until those already on the program are completed. He also says that he speaks the sentiments of a large number of the upper house when he insists that no more bonds be issued for any purpose.
The first bill of the 35th legislative session to resolve the signed approval of Governor Patterson was Senator Strayer's bill No. 4, which removes the limit of the number of mining claims one person may file on a mother lode. For many years the limit has been to one claim.
February Bill In
A bill providing for an appropriation of \$50,000 for the construction of an infirmary at the University of Oregon was introduced to the house this morning by Representative Lowman and Senator Norblad. The bill provides that the appropriation is to be matched by a similar sum to be raised by private subscription.

She appeared to be perfectly composed, confident and friendly, giving the general impression of trying to be helpful to the legislators.
"Isn't it a fact," she was asked, "that Mrs. Kennedy (the evangelist's mother) said to you she didn't see why Judge Hardy should be worth \$2,500 when all he had done was to use the temple radio to make political speeches?"
"No, that would have been totally untrue."
"Did you ever pay him anything until this trouble came up?"
"No trouble."

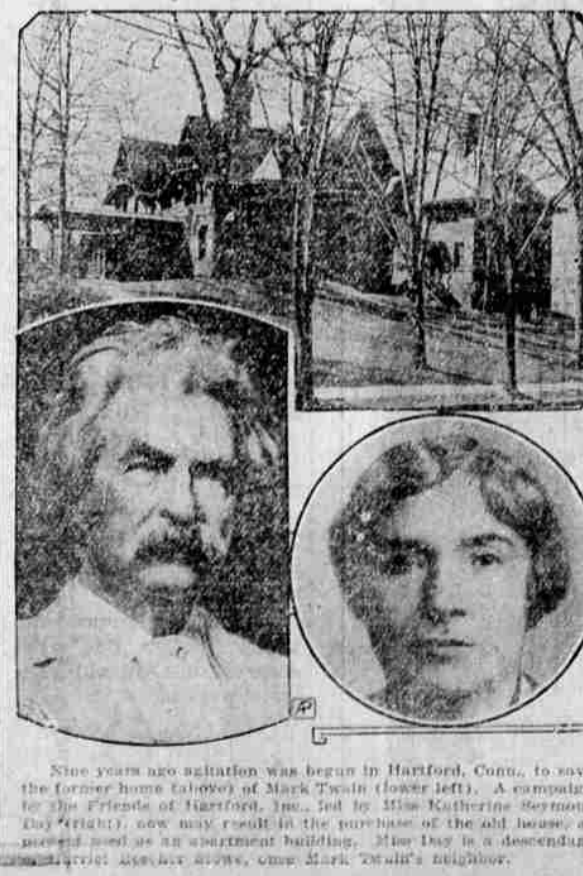
SEVEN BIDS RECEIVED ON TRAIL WORK

SNOW IN WEST OREGON

PORTLAND, Ore., Jan. 29 (AP) — After a brief respite during the early morning hours a heavy down-fall of snow was resumed in Portland today, and great snowplows and augmented crews of men were set to work keeping arterial streets and highways open to travel. When the snowstorm halted temporarily shortly after midnight four inches of snow remained in the downtown district. In the residential districts and suburbs great drifts, piled by a stalling wind, blocked streets. In the business section emergency crews were successful in keeping the streets and sidewalks clear.

The snowfall proved a windfall for the unemployed today. The city hall was emptied of the drifters who sought a night's protection from the elements, and the public service companies engaged all who would work.
Relieves Unemployment
Good fortune came wholeheartedly to the hundreds of unemployed in Portland and those more fortunate gazed with interest at men shoveling snow—and laughing and shouting at the time.
The fresh storm today blew out of the north as its predecessor had. A strong gale swept the Columbia river gorge and the highway. Little hope was entertained that the highway would remain passable today.

One of Multnomah county's newly purchased snowplows was snowed under on the Columbia highway.

While Union Pacific trains were operating through the Columbia gorge today, and traffic was moving both ways over the Columbia river highway during the morning, reports from Hood River predicted that blockades would exist before nightfall if the blizzard-like snowstorm raging there continued.

Heavy Snowfalls
Six inches of new snow fell at the river level at Hood River between 5 a. m. and 7:30 a. m. today. Seventeen inches of snow was reported at the brink of the river gorge here, and at Parkdale it has reached nearly 50 inches. County road crews were battling to keep
