Failure to Realize Dignity Of Labor Given as Cause of Crime—Because they don't realize the dignity of common labor, they get into trouble. To learn the dignity of work is the greatest asset a person can have even if he becomes a millionaire. Men who get between the clamps of the law have many times said, "I'll steal before I'll do that kind of work,"—and they do. Driven to the last extremity and confronted with the necessity of earning a living a man starts with writing a bad check. If he is lucky with his first crime gradually he becomes a hardened criminal. This is the opinion of Hugh E. Brady, judge of the justice court in La Grande. Mr. Brady bases his convictions on his experiences with juveniles and regular work of the court, on his years of practice as an attorney in Portland, on his experience in foreign countries and on observation of people as he has worked in relief activity in the Red Cross, Kike lodge, American Legion and other organizations. "Lack of concentration in life and inattention with the vigor of ambition peculiar to the American people, is the basic cause of much crime," he states. The reason for these dangerous attitudes of conceit and false pride, Judge Brady believes to be found in the home. These young persons are the products of either neglect in the home or lack of discipline. "People of the western civilization are the product of force—dating back in the days of the military Roman empire and we are yet too used to it to grow to maturity without a certain amount of discipline. It is only in the Eastern countries where the 'peace on earth good will to men' attitude is as yet successful, for the Easterners have flourished under a mild and gentle discipline through the ages. It is the ideal but it cannot be carried out in western civilization all at once—the change must come gradually, he says. The majority of the men and women who come before the justice court are less than 30 years of age, says Mr. Brady. One of the most common reasons why these persons get into trouble with the law is that of "no work," either because of laziness or shiftlessness. In most cases an economy of resources would enable them to get along with the amount of money they earn, he states. Many of these persons believe that society owes them a living and that's where the trouble begins, Mr. Brady says. Generally they follow the path of least resistance and when they come in the grip of the law they are usually sorry but they think they were justified in doing what they did even though it lead to trouble.

CARKIN BILL GOES BEFORE LEGISLATURE (Continued from Page 1) which a public hearing held Wednesday night developed no serious objections, and the Carkin bill increasing the fees on gross insurance premiums to a level with those charged in California. Although the rate to be charged in the excise tax measure has not been written in as yet, it is expected to be placed at 4 per cent, which would also mean \$500,000 and \$700,000 a year it is estimated. It is predicted, however, that this revenue shall be diverted to reduce the direct property taxes now being paid for state purposes so it will not feature in the problem of funding the \$2,000,000 deficit the state is facing. House Finance Bill—House members voted this morning to increase salaries of district judges in Multnomah county from \$2900 to \$3500 and to increase the number of judges from three to four. At the same time they passed H. B. 227 which slightly increases district court fees in Multnomah county. The house also passed a repeal
