MURDER CASE NEARS JURY LATE TODAY

cutting pies and cakes at a party. Bryant said, "I had no intention of using the knife against Dickerson, or anybody else."

During his testimony as to the fight itself, Bryant maintained that he had only meant to ask Dickerson not to proceed to the Troxel home with Mac, and to tell his rival that he was engaged to the girl and resented Dickerson's attentions.

"I couldn't seem to get the words out," he continued, telling of an impediment in his speech. During his testimony, however, the defendant spoke without hesitancy or stammering.

Testimony Conflicting—Bryant's statements that Dickerson hit him first and that he used the knife only when he felt sure that the football coach would "choke me to death," varied with the stories told by Miss Troxel and William Gates, friend of Bryant, who was a witness to the assault.

"I had forgotten the knife in my belt until it cut my leg as I lay there with Dickerson on top of me," Bryant testified. "Then I used it in self defense. I couldn't tell whether I hit him or not."

Although it was predicted that the defense would claim that the death of Dickerson, five days after the fight, was due to pneumonia, rather than directly to the knife thrusts, Dr. Harry J. Anderson, who testified decisively that the death was caused by a "penetrating knife wound," was not questioned by Bryant's counsel.

JIMINEZ IS EVACUATED

Apparent evacuation of the town of Jiminez in southeastern Chihuahua was reported by federal airmen today.

The insurgents were proceeding northward in the direction of the rebel stronghold of Chihuahua and the government looked for a battle at Bachimia Pass, strong strategic point south of that city.

The rebels, on the other hand, indicated that a clash was expected in the vicinity of Jiminez, no confirmation being given of the reported evacuation of that town.

General Esteban, rebel commander-in-chief, has repeatedly asserted that he would lead an advance on Mexico City itself.

Strict Censorship

Otherwise a strict censorship veiled the plans of the insurgents. Federal relief forces were expected to reach Mazatlan on the west coast today, relieving the garrison which successfully held off a rebel attack early this week.

The governor of the northern district of lower California today denied that loyal Mexican troops had been transported across Arizona territory to reach Naco where a federal garrison is holding out.

The federals at Naco, strongly entrenched, were still awaiting a long delayed attack by the rebels encamped ten miles away. Unless an attack develops soon, they declared they would start "some activity" themselves.

CAPTURE REBEL POST

TUCSON, Ariz., Mar. 28 (AP)—In a brief fight early today, Mexican federal troops captured a small rebel post across the international line from Sasabe, Arizona, the United States immigration office announced here.

The federals were believed to have come from San Luis, Sonora.

Dirigible Winds Up Long Journey

FRIEDRICHSHAFEN, Germany, Mar. 28 (AP)—The dirigible Graf Zeppelin returned to her base here this morning, completing a voyage of 3½ days and 5,640 miles over the eastern Mediterranean to the Holy Land and return.

The Zeppelin was pulled down to land near its hangar at 10:17 a. m. (4:17 E. S. T.) just 81 hours and 31 minutes after its departure last Monday morning, shortly after midnight.

It was the second long cruise of the giant dirigible, and its mileage exceeded that of either the trip to America, or the return last year.

Young, declining the committee's invitation to appear on the farm issue. Rockefeller said he had never made a study of the farm problem and was therefore not qualified to testify.

Schwab said he had other engagements and Young's assistant said the financier would be kept in Paris for some time on reparations.
