Three Declare Drys' Claims Of Benefits False

WASHINGTON, Apr. 23 (AP)—The dry's claims of benefits from prohibition were contradicted today with testimony from an industrialist, an army officer and a representative of women who depicted conditions under the dry law as deplorable.

Appearing in the house judiciary committee hearings as a witness, to answer contentions made by the prohibitionists, the opponents of the eighteenth amendment included Pierre S. Du Pont, of the Du Pont interests of Delaware; Major General Clarence Edwards of Boston, World War commander of the twenty sixth (Yankee) division; Representative "Tinkham" republican, Massachusetts; the Women's Organization for National Prohibition Reform.

Du Pont said many most upright citizens were "in open revolt."

Affirm Conviction Of R. L. Wilkins

OLYMPIA, Wash., Apr. 23 (AP)—The conviction of R. L. Wilkins for the murder of John W. Brooks, Walla Walla attorney, was affirmed today by the state supreme court. As the decision was handed down by a department of the court Wilkins still has a right to appeal to the entire court for a rehearing of his plea.

Brooks was shot Dec. 2, 1923, as he sat in his home playing cards with his housekeeper. Wilkins was convicted largely on testimony furnished by his 16 year old son, Alfred, who accompanied him in their automobile on the night Brooks was shot.

Opposes Measures Against Mergers

WASHINGTON, Apr. 23 (AP)—Opposition to legislation to suspend railroad consolidations was voiced before the senate interstate commerce committee today by Walker D. Hines, counsel for the Great Northern and Northern Pacific railroads stockholders.

Hines contended that to enact such legislation would be "to throw the situation once more on the old anti-trust laws, and to prevent progress and stabilization now going on."

LOS ANGELES MAN ADMITS 1922 MURDER

Head of the police homicide squad Rinaldo, who said he came here recently from Tucson, Ariz., voluntarily confessed to the murder which for eight years has remained an unsolved mystery. Investigation, however, said several discrepancies appeared in Rinaldo's story.

According to the story told to police, Rinaldo alleged he was a friend of a woman picture actress who visited the Taylor bungalow early in the evening of February 1. He said he followed in a taxi cab when the actress went to the Taylor home, and later overheard a violent quarrel between the film executive and the woman.

The actress left after a short stay, he said, after which he entered the Taylor apartment and remained with Taylor for his actions during the quarrel. Taylor, he said, drew a revolver. In the scuffle that followed, Rinaldo said he gained possession of the gun and shot the moving picture director.

Since then, Rinaldo said, he has been living in various Southern California cities and in Tucson, where he resided until he returned to Los Angeles recently. Inquiry of Tucson police disclosed that Rinaldo is known there as a world war veteran suffering from shell shock.

"Although Rinaldo's story coincides in minute detail with the known facts in the case, we are far from convinced that it is telling the truth," Detective Taylor said. "There still remains a lot of investigation and checking to be done before we are sure that anyone has the actual slayer of Taylor in custody."

"We have been working on several angles of the case for several weeks. These phases involved Rinaldo. We have been looking for him for questioning, but had been unable to locate him until late last night. Shortly after we began questioning him, he told us that he was the man who shot Taylor and described in detail circumstances surrounding the crime. We will investigate carefully, however, before we are convinced we have the right man."

Mrs. Alice Rinaldo, Glendale, Cal., said her husband, Gary, of 5150 Sunset, was identified early in the case.

day. She was unable to clear up details of the confession, but said her husband was erratic and suffered from shock received during the war. The Rinaldos have been separated for two years.

The murder of Taylor in his lavishly furnished Hollywood bungalow eight years ago has provided one of the most baffling murder mysteries in the criminal annals of the country. His body was found by a negro servant, Henry Peasey, on the morning of February 2, 1922. No clue was found to indicate the identity of the slayer, although events which followed involved several persons prominent in the motion picture colony.
