He said part of the records were still in the possession of the Reed committee which investigated campaign expenses in 1926. Caraway promised to try to get them. At the conclusion of testimony, Chairman Caraway said a committee investigator would go to the headquarters of the league at Westerville, Ohio, to examine his records.
