Press Comment

A short time before the primaries the story became current that Norblad had made a political deal with certain paving interests whereby, if he became governor, he would dismise Commissioners Van Duzer and Sawyer and appoint in their places men favorable to a certain type of paving, in return for the political help of the paving company's contract man. At the time the story was taken half seriously and half politically. It was denied by Norblad's campaign manager, but it lost the candidate hundreds of votes.

The deed has not yet been done, and it would be premature and unjust to indict the governor on evidence from press reports and rumor—but if Al Norblad, by his own act, so soon proves the truth of the pre-primary story, and as merely temporary governor upsets the personnel of the one commission that has been so eminently satisfactory to the people, the act will be most significant and the people of Oregon will have cause to congratulate themselves upon what they apparently escaped.—Enterprise, Oregon City.

Governor Norblad's declaration that he will unseat Judge Sawyer as highway commissioner is a good touch of Norbladism, is indicative of what might have happened as to nominate him, and is ample evidence of the people's wisdom in relegating him to the political junk heap.—Salem Capital-Journal.

mission, a body which hitherto has been singularly free from such influences.

It is a shocking thing even on the part of a short-time governor, embittered and emboldened by defeat. It will be noted that the governor declines to give any detailed explanation other than an intimation of discontent with Roosevelt highway progress. It will not be so easy to pass the deed off.

The governor himself, when asked pointblank about the situation, though not so candid as might have been desired, declared that he would let Judge Sawyer serve to the end of his term next March. Coming at this time, and out of its background of circumstances, Governor Norblad's removal of a fine public servant without cause must inevitably attract suspicion and distrust.

With his defeat for governor Norblad may imagine himself at the end of his public career. But he is making a grave mistake if he figures his duty runs to those small cliques which have been personally helpful rather than to the entire state. Governor Norblad is sacrificing an opportunity to leave the governorship respected and admired for unselfish and high-minded performance even in a short term of office.

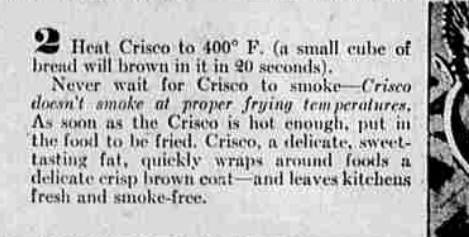
In his big moment he has shown himself a venturesome politician whose departure from public life will bring no regret.—Eugene Guard.

French-fried potatoes — as quick as broiling a steak



1 All you need is a large saucepan, a wire deep-frying basket (or strainer) and a 3-lb. can of Crisco.

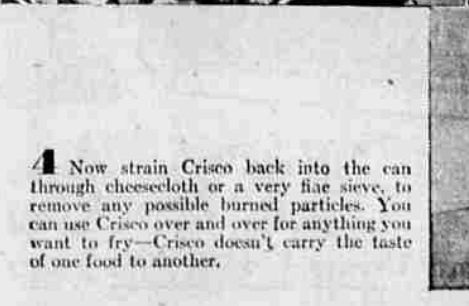
