vation would affect five or six British bases near the United States. Senator Reed paid tribute to the American naval officers, many of whom have opposed the treaty terms. He said the officers themselves were in disagreement on the needs of the navy and therefore the American delegation to London had to differ with some.

Midget Course For Golfers Is Completed Here

La Grande golf enthusiasts will now have the opportunity to indulge in the ancient Scotch pastime night or day, and without going out of the city limits. A midget golf course has just been completed and opened to the public at the corner of Spruce and Adams streets. Although the new course occupies a space of ground only 75 by 120 feet there will be 18 holes with a probable par of 47. There are miniature fairways and greens that go uphill and down, clever traps and hazards, and every possible feature for making play interesting.

On a midget course a player is allowed to use only one club—the putter. Clubs and balls are furnished at the gate, and play proceeds just as in ordinary golf. No previous experience is necessary, so anyone can play, and children find the game especially attractive.

L. A. Danbacker, of Los Angeles, and C. R. Hokenson, of Salt Lake City, are the owners, and have considerable experience in laying out midget golf courses. They say that midget golf is extremely popular throughout the country, there being more than 30 courses in and around the city of Los Angeles. The La Grande hole has three courses, two regular size and the midget course.

OPEN CLIFFORD HEARING TODAY

Game Commission Hearing Charges Against State Warden.

PORTLAND, Ore., July 15 (AP)—Mayor Bert Cole, chairman of the law enforcement committee of the Oregon Game Protective association, was the first witness called by the game commission today in its investigation of charges of inefficiency brought by various sportsmen's organizations against Harold Clifford, state game warden, and E. H. Clark, assistant warden.

Cole told of extensive investigations of salmon poaching on the Clackamas and Willamette rivers in 1928. In several instances, he said, he had attempted to report violations and get action, but had been unable to find Clifford in his office. He said both Clifford and Clark had been lax in not seeing that equipment for deputies was kept in shape. Cole said he on one occasion helped seize 1800 pounds of illegally taken salmon in a local market, but the fish afterward were turned back to the merchant.

C. W. Robinson, attorney for Clark, asked on cross examination if it were not true the dealer had later produced a bill of lading from the Umpqua river for the fish. Cole said it did not know. Wright in Attendance David Evans of Eugene presided at the hearing. Other commissioners present were L. A. Wright, Union; H. W. Poole, Klamath Falls; Wilfred Allen, Grants Pass, and J. E. Cullison, Portland.

The Marion County and the Yamhill County Game Protective association indorsed the charges. The charges accuse Clifford of being

ing "lax and inefficient" in management of the affairs of the commission; of failure of "securing maximum of efficiency from his office"; of failure to secure "vigorous and efficient enforcement" of the game laws. As to Clark, it is charged that he "lacks that degree of executive ability to render efficient service" and that "by his example he has seriously impaired the efficiency of the entire personnel of the field forces under his control." Clifford said he would introduce resolutions from a number of sportsmen's organizations expressing satisfaction with his administration.
