District Meeting Of East Oregon Editors Is Held

Problems Discussed at Session This Morning, Followed by Luncheon at the La Grande.

ASSOCIATION FORMED

Early this morning newspaper men of Union, Umatilla and Walla Walla counties organized a district group, appointing F. B. Finlay, of the Observer, as president, and George Cheney, of the Enterprise Record-Chief, as executive vice president, and Mrs. Sander, son, of the Enterprise, as secretary. The next place of meeting was left vacant pending organization of editors of Baker, Grant and other southeastern Oregon counties. Possibly a joint meeting may be arranged in the future.

The problems of advertising, news gathering and circulation, which harass the lives of newspaper editors, were discussed this morning by leading editors and publishers of Eastern Oregon when members of district No. 9 of the Oregon Press Association met at the La Grande hotel at 11 o'clock for an all-day convention. George K. Aiken, editor and publisher of the Ontario Argus, was discussion leader, and G. B. of Eugene, field manager of the State Editorial association, was a guest.

About 15 newspapermen and women attended the meeting to discuss, mainly, developing local advertising, as well as what the editor owes to his community. A definite stand was taken against so-called shopping news sheets which are really a means of advertising, and it was pointed out that advertising is substantial and lasting only when the publication is "free" and able to hold its readers over a period of time.

New advertising, so called, when business schemes are clothed in a mass of verbiage, was condemned as unbusinesslike and should not be published in the columns of the newspaper, in spite of the fact that to refuse it is to cause friction.

Mr. Aiken stated that the discussion was discussed at length, and the newspaper men were agreed that it is better to shorten the working week than to lower wages, although according to the discussion leader, some printers are asking for a lower wage of their own accord.

At noon the delegates and their wives lunched in the small dining room of the hotel, and following the luncheon a round-table discussion began, with Mr. Aiken in charge.

Harold Boone, executive secretary of the Oregon Press Association, attended the luncheon and invited all visitors who cared to play golf to be guests of the country club and chamber of commerce during the afternoon.

Mr. Aiken, before leaving the luncheon room, suggested that district editors might desire to form a local branch of the association, in order to have better opportunity to work out district affairs.

1930 PROFITS OF LEADING FIRMS 6 PCT.

Some of "Depression" Year's Performances Very Successful.

REVEAL INCREASE IN INVESTMENTS

Insurance Companies in Oregon Show Gain of \$6,582,052 Over That of Previous Year.

CLEVELAND, April 18 (AP)—Despite 1930's unemployment, depression and failures, the country's leading industrial corporations made better than six per cent profit on their capital investment. Ernst & Ernst, nationwide firm of accountants, revealed today.

The accountants showed that compared to depressions of previous decades, some of 1930's performances were astonishingly successful.

The analysis covered 407 representative corporations in 20 widely diversified branches of industry. It showed their 1930 average profits on capital investment were 6.49 per cent as compared with 1.39 per cent in the depression years of 1929.

On approximately the same basis of comparison these corporations had profits of 11.35 per cent in the bonanza year of 1929.

Additional figures from 130 of these corporations showed inventories which were 41 per cent of net plant investment in 1929, were held down to 33 per cent in 1930; sales were 4.14 times inventories in 1929 as compared to 5.21 times in 1930; net profits on sales were less than half of one per cent in 1929 compared to 5.7 per cent in 1930.

Better Than in 1929

Ernst & Ernst pointed out that the 5.7 per cent profits on sales in the bad year of 1930 were better than the 5.02 per cent rate of profit in the so-called "good year of 1920."

Commenting on the 1930 status of inventories, sales and profits, Ernst & Ernst said "all of these are favorable factors and serve to suggest that management of the larger companies has improved materially in the past 10 years. The study also raises doubts as to whether plants of the larger corporations are as much over-expanded as is generally assumed."

INCREASE REVEALED

SALEM, Ore., April 18 (AP)—Insurance companies engaged in all classes of business in the state, showed an increase of \$6,582,052 invested in Oregon securities during the past year, a report made today by A. H. Averill, insurance commissioner, revealed. The total invested was reported as \$126,373,700 at the close of 1930, representing a 6.5 per cent volume over the year previous.

While a substantial gain in investment was shown, the report also revealed that the volume of business in the state had declined.

TOOZE MAKES DENIAL OF SALE CHARGE

Portland Attorney, on Stand in Liquor Trial, Brands Story as False.

DEFENSE SECURES TWO DISMISSALS

Turn Efforts Toward Proving Remaining 16 Defendants Innocent of Conspiracy.

PORTLAND, Ore., Apr. 18 (AP)—Having secured dismissal of two of the 18 defendants in the Tooze-Brown liquor conspiracy trial, defense attorneys today in federal court renewed their efforts to prove their remaining 16 clients innocent of conspiracy to violate the national prohibition law.

The defense began its case late yesterday by placing Walter L. Tooze, Portland attorney, on the stand in his own defense and when court adjourned Judge Charles C. Cavanaugh announced the usual Saturday recess would not be observed today.

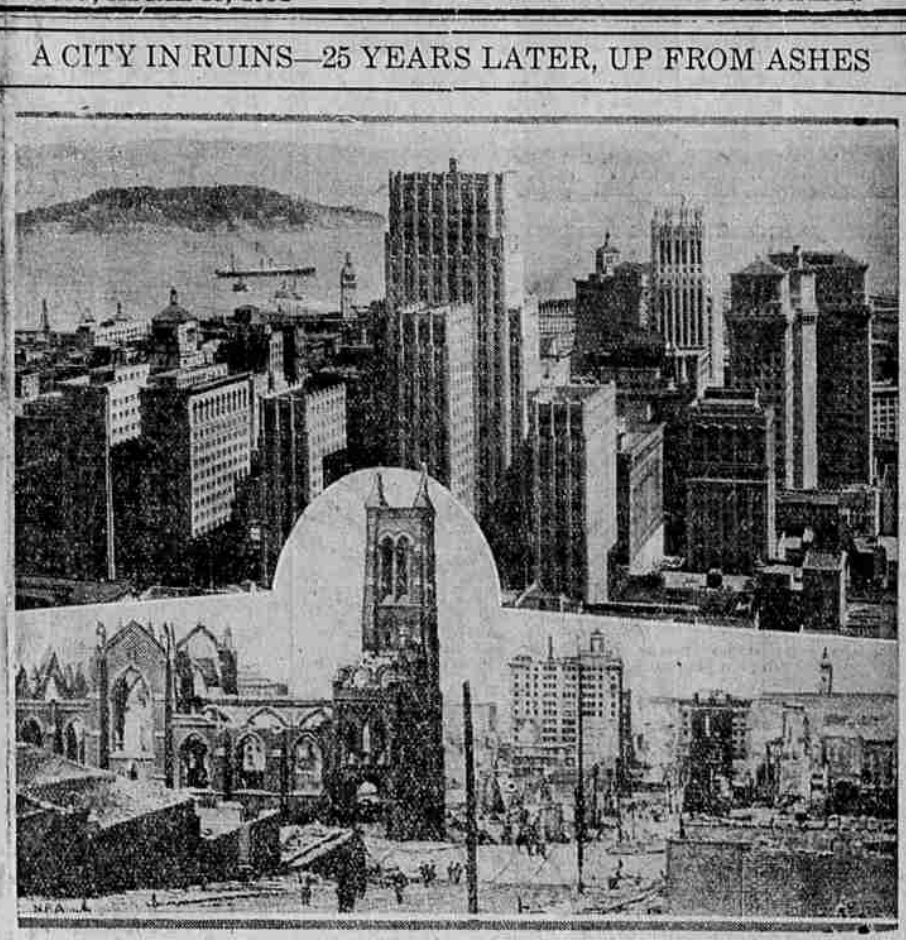
Tooze declared "absolutely false" testimony given by Bert J. Martin, that Tooze had sold ten gallons of liquor to Roy Salling at Tillamook, Ore., in December, 1928. Martin, as a government witness, had testified he was present when Tooze arranged to sell the liquor to Salling for \$80 and that he had accompanied the two men to a cache and obtained the liquor.

Questioned about his associations with Joseph Brown, alleged leader of what the government said was a liquor manufacturing and distributing syndicate, and with his brother, William, Tooze testified he had transacted considerable legal business for them.

Routine Testimony

The routine presented several prohibition agents and automobile dealers as its final witnesses. Their testimony was a routine nature.

Thirty-six persons were indicted by the federal grand jury in connection with the alleged conspiracy. Ten have pleaded guilty and eight are fugitives.

MEER DOWNS PROTESTS OF KAY AND HOSS

Governor Overrides Their Objections in State Prison Hearing.

"LET CHIPS FALL" EXECUTIVE SHOUTS

Hearing Postponed at Noon Until Tuesday Morning, After New Witnesses Testify.

SALEM, April 18 (AP)—The public as well as the board of control is sitting in judgment at the hearing of the charges of incompetency preferred against Superintendent Henry Meyers by Governor Julius L. Meier, developed as the session neared its adjournment at noon today. The board adjourned the hearing until Tuesday morning, when testimony of witnesses will be resumed.

"The people have a right to know," declared the governor in a voice which could be heard over the cheering of the crowd when he answered Secretary of State Hal Hoss, who protested the board be made to listen to testimony on events preceding the present prison administration and which he said had no bearing on the issue at question. "I want the people to hear the testimony as well as the board. I don't want to carry the load and have it told that I am not filling my job."

Both Hoss and State Treasurer Tom Kay had objected to voluntary information presented by Robert Crawford, former superintendent of the flax industry at the penitentiary, on events occurring more than six years ago. Kay had asked Crawford if it wasn't a fact he had been asked to resign three different times while he was superintendent. Crawford admitted it and then attempted to explain reasons, when the objections were raised.

The governor declared, as "chairman of the board I overrule the objections of both of you." Kay answered that Crawford had been asked to resign three different times while he was superintendent. Crawford admitted it and then attempted to explain reasons, when the objections were raised.

"We are going to get to the bottom of this," the governor asserted, "and have all the facts, and let the chips fall where they will. When I start something I finish it and I am going through with this thing from A to Z, and I don't want any interference, because of the fact that the testimony that can or will be given might be damaging to either of you or to my administration. I am charged with incompetency and it has been proved beyond a doubt. Now let's proceed."

"The business of the state is very important and I am not going to let a monkey of by nobody, and I am going to have a lot to say about this state before I am through."

His statement was greeted by cheers.

MOTHER, GIRL DIE IN MYSTERY FIRE, FRISCO

SAN FRANCISCO, April 18 (AP)—A mother and her 18-year-old daughter died early this morning in a mysterious fire which swept the flat where they resided.

When the flames had been controlled sufficiently for firemen to enter the building they found the bodies of Mrs. Annie Silen, 39, and her daughter, Edith, lying side by side in bed. They apparently were killed by smoke inhalation.

The Nathan Silen, 16, a son, was missing. Neighbors said they did not know whether he attended school or worked but they said he had no occupation which kept him away at night.

The cause of the fire is undetermined. The firemen reached the room where the two bodies were found, gas was escaping in large volume. They had to turn off a main.

Police and fire officials began an investigation into the cause of the blaze and the deaths of Mrs. Silen and her daughter. A husband, a glassblower, works at night.

U.S. Employment Service Changes Hit All Areas

WASHINGTON, April 18 (AP)—Secretary Doak today announced complete reorganization of the United States employment service.

The secretary announced there would be 48 state employment bureaus and one for the District of Columbia to be operated under seven special divisions to cover various trades.

There will be a supervising director to which Post John R. Alpine, of New York, has been appointed.

PROSECUTION OF ROYALISTS SEEN

New Spanish Leaders Investigating Former Premier Berenguer, Others

MADRID, April 18 (AP)—The Republican government plans now to hold elections in May for members of a "national assembly," the Associated Press learned today from "reliable sources."

MADRID, April 18 (AP)—The possibility of prosecuting former Premier Damazo Berenguer and Monarchist leaders in the dictatorship of the late General Primo de Rivera was being studied today by the Republican government.

Neither Senor Berenguer nor others will be actually arrested, spokesmen say, until the government has investigated their acts and formulated definite charges against them. The former premier surrendered and was liberated on his pledge that he would present himself when needed.

Senor Berenguer's alleged responsibility for the execution of General Galan and Hernandez, who were leaders in the Jaca revolt in December, is one of the accusations pending.

Plan their inquiries

The government also plans to investigate the administration of General Martinez Anido as governor of Barcelona and a right hand man of Senor de Rivera. General Anido was praised for vigorously disturbances against the dictatorship and it is alleged he personally was responsible for deaths and injuries to civilians.

With the agreement of the Catalan Republic temporarily to accept state autonomy within the Republic of Spain, the government's chief problem has been solved. No actual

Newton D. Baker Does Not Seek The Nomination

CLEVELAND, April 18 (AP)—A statement by W. B. Gungwer, Cuyahoga county Democratic leader, after a conference with former Secretary of War Newton D. Baker, was interpreted today as revealing that Baker will not seek the presidential nomination, but that he would not refuse it should it come his way.

Baker is pressed over the candidacy of his name, Gungwer said but "he has shown no interest in possible candidates, and I do not believe he has changed his former judgment on the subject. This has always been the fact that he had no desire for further political preferment of any kind."

Political leaders who heard Gungwer's statement said its expression of "no desire" was evidence that Mr. Baker would not seek the nomination, but its failure to make a refusal was interpreted by them as evidence he would be willing to accept if the national Democratic convention should demand it.

MUNICH, Bavaria, April 18 (AP)—The Voelkischer Beobachter, official newspaper of Adolf Hitler, today demanded the resignation of President Paul von Hindenburg.

This is the first time the opposition party has thus openly attacked the venerable president. The nationalist opposition is due to President von Hindenburg's recently proclaimed emergency decree curtailing freedom of speech, publication and assembly.

McCormick, publisher of the Chicago Tribune, urged in a speech before the American Society of Newspaper Editors today that newspapers avoid the possibility of failure because of rising competition, by improving themselves to overcome developing obstacles. He cited the radio, the billboards, and the television as the newspapers' active competitors. He declared that readers are equally appreciative of independently written, fearless editorials "even if the readers disagree with them."

Americans Remain In Nicaragua At Own Risk, Government States

PUERTO CABEZAS, Nicaragua, April 18 (AP)—Americans in the Puerto Cabezas district harried by insurgent and outlaw attacks, were moving into more protected areas today, evacuating their homes and businesses.

Their action follows killing of nine American citizens in this general area since Friday of last week, and receipt of a telegram from Alvin T. Rowe, American consul at Bluefields, warning that the United States government cannot undertake their general protection.

"Advise Americans this government cannot undertake their general protection in Nicaragua with American forces," the state department recommends that Americans who feel insecure withdraw from the country or seek protection in coast towns, where they may be evacuated if necessary. Americans remain in Nicaragua at their own risk and must not expect protection from American forces."

Under Cover Man's Sentence Upheld

OKLAHOMA CITY, April 18 (AP)—A prison sentence of 50 years for Jeff D. Harris, under cover man for W. W. (Snake) Thompson, federal prohibition agent, was affirmed by the Oklahoma criminal court of appeals today in upholding his conviction for slaying James A. Harris and Oscar Lowery near Tecumseh, July 4, 1929.

The killings occurred in a raid on the James A. Harris farm in which no liquor was found. The court found that Jeff Harris visited the farm without a search warrant.

EARTH SHOCKS FELT FRIDAY IN NORTHWEST

SEATTLE, April 18 (AP)—Earth tremors of moderate violence were felt over a 50 to 75 mile radius in Northwestern Washington and Southern British Columbia early last night. The shocks were felt in three cities, Bellingham, Vancouver and Victoria, and several towns. They occurred a few minutes before 8 p. m.

Wheat Today

CHICAGO, April 18 (AP)—Big export buying hoisted wheat today to a new high price record for the season, 99 cents a bushel December delivery. It was estimated that European countries bought 2,000,000 bushels or more from North America. Upturns were in the face of selling of Chicago July delivery by houses with connections southwest. The official weather forecast gave little hope of important moisture next week in the United States grain belt.

Wheat closed strong, 1/4c off to 1/4c up, corn 1/4c lower to 1/4c higher, oats unchanged to 1/4c advance and provisions unchanged to decline.

ALASKA VOTES FOR REPEAL OF BONE DRY LAW

JUNEAU, Alaska, April 18 (AP)—The Alaska territorial house was on record today by a 10 to 6 vote for repeal of the bone dry law. A memorial asking congress to approve the action accompanied the repeal measure.

With no debate or subsequent remarks by house members, the two proposals were passed yesterday. They will next go to the senate.

The memorial explained the movement for repeal of the prohibitory legislation in Alaska but added that Kappa Epsilon Alpha, a fraternity, is under arrest charged with the bone dry law.

Jazz Blamed For Slaying Of Two
