Robleto Decisions Israel In Seattle

SEATTLE, Apr. 30 (Special)—Canto Robleto, Pasadena, bantamweight, was awarded the verdict over Able Israel, Seattle, in the fifth round of their scheduled six round main event boxing bout here last night when the latter was disqualified for holding. It was a re-match, Robleto having given Israel a beating here two weeks ago. The Californian hurt the Seattle lad with a barrage of body punches in the first two rounds and then Israel resorted to holding the rest of the way. After being warned several times, the referee halted the fracas and raised Robleto's hand. Freddy Palacio, Los Angeles welterweight, fought a sizzling draw with Don Fraser, Spokane, in the six round semi-final. Fraser was fouled in the last stanza but he refused to take a two-minute rest allowed by the Seattle boxing commission. Cecil Geyzel, Seattle middleweight, knocked out Cowboy Brooks, San Antonio, Texas, in the third round of their scheduled six round go. Geisel knocked Brooks down twice before finishing him. Verne Butler, Minneapolis lightweight, won on a foul from Ah Wing Lee, Portland Chinese, in the second round of a four rounder.
