PEACE MOVE TURNED DOWN BY JAPANESE

JAPAN OPPOSES INTERFERENCE. TOKYO, Feb. 3 (AP)—Japan is unalterably opposed to any proposal for neutral participation in negotiations regarding Manchuria.

Foreign minister talked for two hours with the 84-year-old prince whose advice always is sought when the empire's vital interests are involved, and as soon as he got back he went into conference with Premier Inukai.

Different Problem Japan, he said, refuses to consider the Manchurian problem in the same category with the present situation at Shanghai.

"We are eager to maintain the friendship of the other great powers," he said, "but at the same time we must protect the rights and interests of Japanese citizens in China."

Japan cannot accept the fifth proposal of the powers providing for negotiations to settle Sino-Japanese controversies in the spirit of the pact of Paris, he said, because of the stipulation that neutral observers participate in negotiations which are intended to include the Manchurian issue.

In official Japanese circles doubt was expressed that it would be possible to bring about peace by the proposals as quickly as it would be brought about by force as a result of the fighting at Shanghai.

The German government, official circles indicated, instructed its diplomatic representatives at Tokyo and Japan and China similar to those of the powers but to avoid anything resembling pressure.

CHINA ACCEPTS PROPOSAL. NANKING, Feb. 3 (AP)—China accepted the British and American peace proposals today to bring about a cessation of hostilities between herself and Japan.

The acceptance was announced by the foreign office and steps were immediately taken to avoid further fighting shortly after a group of Chinese aviators, with dramatic ceremony, made their wills and been photographed, resolved to give up their lives in China's defense.

The acceptance was accompanied by an agreement between Chinese and Japanese officials that neither would resort to further hostilities at Nanking "unless provoked."

A conference between officials of the foreign office, Chinese military authorities and Japanese consular and naval officials, was held on one of the Japanese warships.

Martial Law Declared The commander of the Nanking garrison ordered Chinese troops and police to make a special effort to protect foreigners. The truce alleviated public nervousness and fears that a Japanese attack on the city was impending.

In the meantime the Chinese and Japanese warships in the river proceeded to put distance between them. The Japanese ships moved up the Yangtze and the Chinese ships sailed down the river until they were eight miles apart with the British and American naval vessels between them.

The foreign office announced that China had replied to the Anglo-American note and accepted the proposals as a whole.

RUSSIANS CRITICIZE LEAGUE. By Andre Berding. GENEVA, Feb. 3 (AP)—The Russian delegation to the disarmament conference, sitting in haughty isolation today in a British boarding house on Philosophers' road, in the outskirts of Geneva, summed up its reaction to yesterday's attempt to bring about peace in the Far East by saying: "It won't do any good."

Yesterday's action of the powers, spokesman for the delegation said, was only another of the series of fruitless steps taken by the league in recent months, "each of which resulted in a hop, skip and jump forward by the Japanese."

"The league has delayed too long," the spokesman said. "While it deliberated the Japanese acted, taking up one position after another in Manchuria. Why didn't the Manchurian commission start immediately when it was appointed last December? Why does it now choose the longer route to China by way of the United States?"

"We received a telegram this morning from Moscow, saying the Trans-Siberian and the Chinese Eastern railways are running regularly. The events are developing in the Far East as our government and press predicted."

The spokesman for the Russians was emphatic in asserting the soviet declined to be brought into the conflict, although he admitted they were not consulted in yesterday's combined action of the powers. "We never yet participated in any political action of the league," he said.

Pressed for Russia's plan for solving the Far Eastern conflict, he answered: "Complete disarmament."

U. S. MARINES IN GOOD SPIRITS. SHANGHAI, China, Feb. 3 (AP)—Lieutenant R. A. Boone, U. S. M. C. of Twin Falls, Idaho, reported today after a tour of the Chinese military lines about Shanghai that the men were well equipped and in high spirits, apparently not at all nervous under fire from the Japanese which was still going on.

RUSSIANS NOTE NAVAL DISPLAY. MOSCOW, Feb. 3 (AP)—The military organ Red Star today devoted a quarter of a page to American naval maneuvers in the Pacific, declaring they increased tension in the Far East.

"The maneuvers undoubtedly are a demonstration of the military force of American imperialism against Japan, whose appetite had gone too far," the Red Star stated.

Most of the article was devoted to a detailed description of plans for the American naval drill and was accompanied by a map of the Pacific.

PURPOSES OF STATE BOARD MADE CLEAR

(Continued From Page One) is composed of the governor, the secretary of state and the treasurer, actually forming a third branch of government—the executive administrative.

State Funds Safe Touching briefly upon the financial situation, Mr. Holman declared that the "state funds never were so safeguarded as at this moment" due to a revamping of securities.

Twelve state institutions come under the board of control activities, and Mr. Holman is particularly interested in these. The dozen institutions are exclusive of the five institutions of higher learning, which come under the more direct supervision of the board of higher education.

Wants Facts Mr. Holman is at present making an Eastern Oregon tour to acquaint himself with seasonal conditions and problems at the Eastern Oregon institutions. He regularly makes trips over the state in order to satisfy himself of the progress of the work and operation of the institutions under his control.

Going at some length into the problems that confront the board, he said that every effort was being made to halt waste, carelessness, incompetence, etc., in the ranks of state employees. "Most of them are serious-minded people, doing their best," he said, "but there are those who are either incompetent, or worse—dishonest."

He spoke of many savings made by the board, including \$10,000 per annum saved by taking advantage of cash discounts almost everywhere. He also spoke of savings by using a master meter for the light and power at the state buildings instead of separate meters. Changes in the state printing department personnel saved more thousands of dollars without reducing the efficiency.

Checking Many Things At present Mr. Holman is checking thoroughly into the expense account of state employees. "In an effort to reduce the 'graffiti' that may be going on, he cited one example of a state employee who turned in an expense account for 37 miles driven on one day, yet another state car daily ran 17 miles in going over the given route. All these things together represent a huge drain on the taxpayers, and it is the board's intention to change things as rapidly as they can be discovered," the speaker asserted.

"My notion is to let the light into the dark places," he said, "and that's my purpose in telling you these details. . . . If it cannot stand the light, it must stop."

The speaker also praised former Governor Walter M. Pierce for his work in connection with opening the lime plant and other similar institutions.

He discussed the changes he has made in the superintendency of the blind school, defending his actions and citing examples to prove his point. He also stated that corporal punishment has been abolished at the state training school with a noticeable decline in escape attempts following the rule change.

"We must sail—not drift or lie at anchor," he said in opening his address and throughout his talk, Mr. Holman followed this thought.

He was introduced by State Senator Colonel B. Eberhard of La Grande, after President George Walker turned the meeting over to Harley Richardson, of the program committee.

JAP WARSHIP SINKS TODAY UNDER FIRE

(Continued From Page One) The United States marines, now aboard the cruiser Houston in the river, are expected to land tomorrow.

The second battalion of Argyll and Sutherland Highlanders, comprising 800 officers and men, landed from the British cruiser Berwick and marched from the customs jetty along Nanking road which was crowded with masses of Chinese. At that time Japanese planes were bombing Chapel and there was a continuous roar of bursting bombs and rattling machine guns.

Two "dud" shells fell on the property of the British-owned Asiatic Petroleum company on Nanchang island in the Whangpoo, halfway between Shanghai and Woosung.

"They fell just clear of the oil tanks but it could not be determined immediately whether they were Chinese or Japanese."

Foreigners Endangered Toward evening foreign residents were continually endangered by shells which landed in the water in front of the Asiatic Petroleum company plant on Gough island, near the American-owned Texaco company property. An American destroyer was tied up alongside a Texaco barge in the Whangpoo.

One "dud" struck one of the Texaco buildings and several shells which fell in the river narrowly missed the American destroyer.

Reports from the fort area tonight said Japanese aviators came back after dark and bombed a Chinese oil storage plant near the forts and set it afire.

Fifty British soldiers whose enlistments had expired were on the British steamer Fengtien on the way to Tientsin when the Japanese vessels opened fire on the forts.

The Fengtien was coming in as the destroyers were going out, and the steamer was right in the line of fire. Without warning the soldiers said, the destroyers fired across the steamer's bows at the fort and the fort replied while the steamer raced ahead to get out of the way.

JAPANESE TO ENTER HARBIN. CHANGCHUN, Manchuria, Feb. 3 (AP)—General Jiro Tamon, the man who took Tatsihar, reached the outskirts of Harbin tonight and stopped there, preparing to enter the city tomorrow with the division of troops he took up from Changchun.

Tamon had come up 30 miles from Shauncheng on the last stage of the advance and could have entered the city tonight but preferred to avoid the unnecessary risk of night fighting such as that which preceded the capture of Tatsihar.

The Chinese forces under Ting Chao had retreated to the east and it looked as though Tamon would be able to take the city without resistance.

The temperature was 30 degrees below zero, Fahrenheit.

Dawes, Jones and Couch Take Oath, Assume Duties

WASHINGTON, Feb. 3 (AP)—The reconstruction finance corporation officially started upon its duties Tuesday with a forecast from one of its officials that loans would be going forward very shortly.

Charles Gates Dawes, president of the corporation, Jesse H. Jones of Houston, Texas, and Harry C. Couch, of Pine Bluff, Arkansas, took the oath of office as directors.

It was administered by James L. Dougherty, a temporary counsel of the corporation.

Eugene Meyer, chairman of the board of directors, Paul Bestor, member as chairman of the federal farm loan bureau and Ogden Mills, under secretary of the treasury, did not take the oath as they already are government officials.

Wilson McCarthy, of Salt Lake City, the other director appointed, has not yet been confirmed by the senate.

Mills said that after taking the oath there would be an immediate organization of the board, followed closely by actual loan-making activities.

After taking the oath Meyer handed Dawes, Jones and Couch their commissions.

Inquiries about loans up to approximately \$100,000,000 have been received by the corporation.

The board went into a meeting behind locked doors immediately after taking the oath.

After formally naming Meyer chairman of the board and General Dawes as its president, the corporation selected G. R. Cooksey, of Washington, as secretary.

Hugh Leach, now connected with the federal reserve board, was chosen treasurer, and G. S. Marr of Salt Lake City, was made general counsel.
