

'CHAUTAUQUA' WILL CLOSE LATE TODAY

Final Session of Cooking School Under Way This Afternoon.

EUROPEAN DINNER THURSDAY FEATURE

Attendance on Third Day Near 500 Mark — Miss Hester Heath Demonstrates Dinner.

A continental dinner of typical dishes from the countries of Europe, was prepared yesterday afternoon by Miss Hester Heath at the third day's program of the "Kitchen Chautauqua," which has been held in La Grande this week at the Sackajaw Inn.

The chautauqua continues to draw a large group every day, with each day's attendance hovering around 500.

After touring in Spain, Italy and the continent, Miss Heath brings her "cook's tour" back to America this afternoon, preparing a dinner of minted grapefruit from California; baked oysters with crab sauce from New Orleans; broiled steak from the middle west; apricot fritters from New England; sweet potatoes and bacon and succotash from the south; spoon bread from the south; and ice cream with chocolate cake, which she terms as all-American.

France furnished onion soup to yesterday's menu, which was appetizing with onions well browned in butter and added to strong beef broth with pepper salt, a small bit of onion, a bit of beef, a Hungarian dish, was prepared by Miss Heath from onions, lean beef, paprika and seasonings, cooked to which thinly sliced potatoes and sour cream are added. The Gulyas is economical, tasty and when evenly browned and garnished furnishes an attractive main dish for a dinner.

Pretty color combinations in salads add a touch of color to a table, and the salads themselves are more attractive.

STATE POLICE ON WATCH FOR DEPREE POE

SALEM, Mar. 11 (AP)—State police headquarters today are preparing circulars describing Depree Poe, alleged third member of the group who were declared slayers of James Iveson, Silverton policeman on the morning of May 2. Officials announced their confidence that he would be captured within a short time.

The second of the trio of youths claimed to be slayers of the officer, is in the Marion county jail and has confessed his part in the crime. It was announced last night, Frank Manning, 26, driver of the car in which Robert Ripley and Poe drove to Silverton in the early morning before the shooting of Iveson, was arrested 12 days ago under another name on charge of car theft.

First degree murder charges will be placed against Manning, officers announced, and also against Ripley, now in the Washington state reformatory serving time. The latter was expected to be commuted by Gov. Roland H. Hartley in order to permit Oregon authorities to place the charge. Both had confessed to their part of the crime, but allege Poe shot the officer.

Lumber Business Gains During Week

PORTLAND, Ore., Mar. 11 (AP)—An increase of 10.6 per cent in current new business over the previous week was reported by the Western Pine Association for the week ending Mar. 5. Both production and shipments increased.

The association said that of its 127 reporting mills in the pine sections of the western states, only 35 were operating, and these at an average of 27.7 per cent of capacity. Production for the week was 12,352,000 feet; shipments totaled 37,493,000 feet; orders 36,355,000 feet. Unfilled orders decreased slightly.

Germany's High Tariff on Grain Will be Reduced

France and Italy Considering Similar Action — American Wheat Expected to Benefit.

BERLIN, Mar. 11 (AP)—A reduction of Germany's high tariff on wheat and an increase in the percentage of foreign wheat which may go into German made flour will be put into effect on or about April 1, according to reliable information received today.

The proposed action here is one phase of a similar move, although not so extensive, planned in France and Italy.

In authoritative circles here it was predicted that the reduction of Germany's wheat tariff will be from 250 marks a ton to from 180 to 200 marks (this would be a reduction of about 50 cents a bushel).

At present the amount of foreign wheat which may go into German made flour approximates 30 per cent as a maximum but most millers use no more than 20 per cent of foreign grain. A partial withdrawal of the restriction, however, would be likely to give a fillip to world grain markets, particularly those in North and South America, authorities here said they believed.

In Berlin grain circles today it was said the Russian government seemed to be making a strenuous attempt to corral grain for foodstuffs and for seed.

Anti-Hoarding Campaign Active In 2395 Places

WASHINGTON, Mar. 11 (AP)—President Hoover announced today the anti-hoarding campaign now was active in 2395 communities and had shown positive and useful results in bringing money back into circulation, increasing bank deposits and swelling the sales of government bonds.

Speaking at his bi-weekly press conference the president said he was announcing progress in the drive on behalf of Col. Frank Knox, chairman of the citizens reconstruction organization.

He reported that in addition to the 2395 communities organized in the anti-hoarding campaign, new organizations were being formed constantly.

He praised the nation's press for contributing what he said was millions of dollars worth of advertising without cost.

More Fishermen Are Taken From Gulf Ice Floes

HELSINKI, Finland, Mar. 11 (AP)—A second group of 100 fishermen whose lives have been imperiled on an ice floe in the Gulf of Finland since early this week, was rescued today.

Approximately 300 others still remain on the floes upon which they had been fishing earlier in the week and which broke away and drifted out to sea. A large number of horses also remain adrift.

An icebreaker picked up the group of 100 today near Suursaari island and brought them back ashore. Another group of 100 was rescued yesterday.

The condition of those who still remain on the floes was reported to be fairly good but the horses were said to be suffering extremely. Three airplanes left Viipuri this morning carrying sacks of oats for the horses.

The group which is still adrift is somewhere in the extreme eastern portion of the gulf.

Boloff Sentenced And Given Parole

PORTLAND, Ore., Mar. 11 (AP)—Ben Boloff, 38, who on Mar. 2, last year, was sentenced by Circuit Judge Ekwall to a term of not exceeding 10 years in the state penitentiary for criminal syndicalism, today was re-sentenced by Judge Ekwall to 10 years in the penitentiary with credit for the time already served on the former sentence, and the balance of the sentence was suspended on condition that Boloff hereafter obey the laws of Oregon and of the United States.

Sherwood Funeral Sunday Afternoon

The funeral of Shirley Ann Sherwood, who passed away Wednesday evening, will be held Sunday afternoon at 2:30 o'clock at the Presbyterian church with Rev. J. George Walz in charge of the services. Burial will be in the family plot in Masonic cemetery.

EAST CHILLS AS MERCURY GOES LOWER

New York, With Temperature 13 Above, Has Coldest Night of Winter

CROPS SUFFER IN SOUTHERN STATES

Forty Men on Government Dredge Grippd in Ice Floes on Lake Erie — Fish Tug Rescued.

Winter, a furious oldster, continued to larrup Uncle Sam's boys and girls today.

Over much of the land, Americans climbed out of bed shivering to find the uncomfortable phrase "not much change in temperature" still in the papers after five days of storm and the season's worst chill.

On the Atlantic the long spasm continued during the night. The crippled collier H. P. DeBardeleben, her crew fled in the nick of time, sank 500 miles off Boston. The freighter Harburg, off Nova Scotia, lumbered rudderless for help, and the tug Foundation Franklin, slicing the waves toward the scene, lost her steering gear and cried for aid.

Seven coast guardsmen on the patrol craft "218" were missing with their boat off Delaware capes. Twelve vessels sought them.

Ice floes grip dredge
On Lake Erie a government dredge, with 40 men, was gripped in ice floes; a fish tug was saved after a

LEARN NEW FACTS ABOUT KIDNAPING

Anne Was Not With Colonel When Baby Was Stolen; on Second Floor

HOPEWELL, N. J., Mar. 11 (AP)—Mrs. Charles A. Lindbergh was on the same floor as the nursery when the kidnapping of her baby was discovered a week ago last Tuesday, it was learned today, and the mother and nurse were not immediately alarmed, both thinking Colonel Lindbergh must have taken the child downstairs.

All previous reports have indicated that Mrs. Lindbergh was downstairs with her husband and that Betty Gow, the nurse, found the crib empty and rushed down to the parents with the announcement of the kidnapping. But it was authoritatively determined today that at 10 o'clock, of that night Mrs. Lindbergh was in a bathroom on the second floor, where the nursery is situated, preparing to take a bath.

When Miss Gow, who had only been called to the Lindbergh estate that afternoon despite previous announcements that she spent the weekend with the baby, found the crib empty she went to the bathroom and asked if Mrs. Lindbergh had the child there with her.

The mother said she did not have the baby but even then no feeling of consternation was experienced by the two women, though Mrs. Lindbergh did immediately begin to dress. "I guess the colonel must have taken him downstairs," Miss Gow is reported to have said, in effect, and she went down to ask the father.

When Miss Gow learned that the colonel did not have the baby, however, she suddenly realized the serious situation.

CAMPBELL AND LINDEN GIVEN PRISON TERMS

SEATTLE, Mar. 11 (AP)—Adolph Linden and E. W. Campbell, former presidents of the defunct Puget Sound Savings and Loan association here today were sentenced to five to fifteen years in the penitentiary upon conviction of embezzling about \$200,000.

Trapped by Posse, Drug Addict Kills Girl and Commits Suicide

SAN JOSE, Cal., Mar. 11 (AP)—Trapped by a posse after shooting Deputy Sheriff Ed Lowell, a young man tentatively identified as James Mooney, Wenatchee, Wash., aviator, shot and killed his blonde woman companion near here last night and then fatally wounded himself.

Officers sought to learn whether Mooney was the man who shot and wounded Eugene Kane, San Francisco policeman, after a drug store holdup there and also whether the man and woman were members of a Los Angeles gang whom police have been hunting for three months.

Couple questioned
The shooting started after Lowell and Deputy Sheriff Earl Hamilton came upon Mooney and the girl in the Santa Cruz mountains. Believing they were drug addicts, the officers questioned the couple and received what they said were unsatisfactory answers.

ROOSEVELT'S STOCK GAINS DURING WEEK

More Strength Shown in East and West Than Any Other Candidate.

G. O. P. VOTES GO FOR MR. HOOVER

WASHINGTON, March 11 (AP)—March's most active week of presidential politics is ending with the Democratic banners of Franklin D. Roosevelt a little higher in east and west, while the Republican rally behind President Hoover with increased manifestations of returning confidence.

Roosevelt's parade through the New Hampshire primaries was hailed universally as a potent boost for his candidacy. Because it was a test at the polls, and because he upset a whole slate of candidates pledged to Alfred E. Smith in that New England sector where Smith was assumed to be strongest, the New Hampshire result overshadowed the Roosevelt capture of the larger, convention-instructed Minnesota delegation.

Hoover enters Ohio
Among the Republicans, the week's significant offering was the decision to put a slate of Hoover delegates into the Ohio primary of May 10. The administration's reverses in recent elections have taught the party managers a manifest caution. Besides, they have seen no reason to take unnecessary risks, and involve themselves in the local quarrels that attend primary contests, when the president's renomination already is a foregone conclusion. With studied purpose they stayed out of the primaries in North Dakota and Illinois.

The die was cast in Ohio after the most careful survey. An active anti-Hoover group there sought to enter Calvin Coolidge, and later Hiram Johnson, as their candidate. Evidently the Hoover managers are fully satisfied now that this group will have no formidable candidate and no dangerous strength. The decision shows more confidence than has been apparent for a long time in the Republican organization.

Murray enters picture
The troubles of the high-riding Roosevelt boom now are transferred to North Dakota, where Governor "Alfalfa" Bill Murray has been swinging round the rural circle asking for votes at next Tuesday's primary.

Murray had some rousing meets, and his visit was followed by a telegram from Governor Roosevelt to North Dakota leaders asking them to support of farm relief.

Roosevelt has the state
The crowd cheered gathered on the street in front of the registry, anxious to catch a glimpse of the girl commoner who was to wed a prince of Sweden's royal house. The crowd cheered her as she stepped out of her motor car, and camera clicked as she walked up the steps, leaning on the prince's arm.

WIFE OF SLAIN MAN REQUESTS NEW INQUIRY

MEDFORD, Mar. 11 (AP)—A request by Mrs. Everett Dahack Hood that he call a special grand jury to undertake a new investigation of the death of Everett Dahack, her former husband, was refused by District Attorney George Coddling here Thursday.

Dahack was found dead, a bullet through his head, after county and state officers had raided a liquor still on Reese creek in the Eagle Point country Nov. 14, 1930.

The woman declared new evidence brought out in the libel suit of Roy Parr, a game warden, against a weekly newspaper here, warranted the investigation. The district attorney said all evidence that had been heard had previously been examined by regular and special grand juries. He said, however, he would put the question to Circuit Judge H. D. Norton.

Needle In Man For Sixty-Six Years

ADAIR, Ill., Mar. 11 (AP)—Sixty-six years ago, R. C. Baby, now 70 years old, swallowed a needle.

Yesterday he saw the point of it sticking out between his toes so he reached down and pulled it out.

During the 66 years it was in his body it never gave him any trouble.

Reorganization Bill Is Given Setback

WASHINGTON, Mar. 11 (AP)—The senate today by a vote of 34 to 32 refused to consider a bill giving the president authority to reorganize the government.

The test vote came on a motion by Senator Vandenberg (R., Mich.) to add the George reorganization giving the executive full authority to cut down and abolish bureaus of the interior appropriation bill.

Senator Robinson, Arkansas, Democratic leader, contended the proposal was not germane to the supply measure.

New York Daily News Says Communication Established, Then Broken

CENSORSHIP LID TIGHTENED TODAY

State Police Announce Two Bulletins Will Be Issued Daily From Lindbergh Home.

SEARCH TURNS WEST
HOPEWELL, N. J., Mar. 11 (AP)—The underworld move to return the kidnapped Lindbergh baby to its parents pointed today toward the west—possibly to Michigan.

A statement by New York counsel for Salvatore Spitalo, go-between named by Col. Lindbergh to deal with kidnapers of his son, with Spitalo would "leave for the west" on a tip that "looks pretty good" was followed by a dispatch from Detroit quoting a lawyer, identified by the Detroit News as Spitalo's attorney, as declaring the baby was safe.

This statement was attributed to Irah Leebow, in a dispatch to the News from Clare, Mich., which also quoted Leebow as saying the ransom would be higher than \$50,000, generally mentioned as the sum demanded by the kidnapers in a note pinned to the window sill of the baby's room.

Trig. Gen. Jay Morrow, Mrs. Lindbergh's uncle, revealed that members of the family had urged Col. Lindbergh to arrange for recovery of the child and payment of the ransom through the help of a criminal lawyer with underworld contacts.

Rich Fur Taken From Ship, Word From North Says

PORTLAND, Ore., Mar. 11 (AP)—Evidence pointing to the conclusion that the valuable fur cargo of the Hudson's Bay company trading steamer Baychimo, was removed from the vessel before she was abandoned to Arctic ice near Point Barrow last year, was contained in a letter received here from Hans Mirow, Alaskan flier, formerly of Portland.

Mirow was one of the pilots who transported 22 members of the Baychimo's crew to Nome, and later took the remaining 17 men from Point Barrow to Fairbanks after the steamer was abandoned.

In a letter to Frank P. Bell of Swan Island airport here, Mirow said: "I guess I'll have to make two more trips to bring out their cargo of fur which they left at Point Barrow." He enclosed a picture showing him holding two fox furs.

William Graham Alaskan flier, and Mrs. Edna Christofferson, Portland sportswoman, are now in the north-land preparing for a flight to the Baychimo in hope of making salvage claims against the ship's fur cargo, believing this cargo was left on the boat when it was abandoned.

France Refuses Apple Shipment

HAVRE, France, March 11 (AP)—Twenty thousand barrels of American apples, which arrived today on the Ile de France were not allowed to be unloaded because of the embargo recently declared on fresh fruits suspected of carrying the San Jose scale.

American fruit importers estimated that \$100,000 worth of fruit already in port or in transit will rot on the piers because of the government ban. Five hundred tons in barrels and several thousand cases of apples are due tomorrow from California and other shipments are on the way from the Pacific coast. The dealers said it is impossible to re-ship large quantities elsewhere.

Recount Reveals Democrat Victor

WASHINGTON, Mar. 11 (AP)—A house elections committee decided Thursday that Stanley H. Kunz, Democrat, is entitled to represent the 8th Illinois district in the house of representatives.

It agreed that an official recount should be held, and was entitled to election instead of Peter C. Granata, Republican incumbent.

This decision, which will be represented to the house for action next week, was based on a recount which gave Kunz 16,345 votes and Granata 15,037.

Wheat Today

CHICAGO, Mar. 11 (AP)—Grain values paralleled a downward trend of securities today.

An apparent pause in export demand for wheat from North America counted also as a drag on cereal prices. Unfavorable crop comments, however, from the western third of Kansas were effective in checking declines.

Wheat closed unsettled 1/4 @ 1/2 cents under yesterday's finish, corn 1/4 @ 1/2 down, oats 1/4 @ 1/2 off, and provisions unchanged to 7 cents decline.

PORTLAND, Mar. 11 (AP)—There remains a stagnant tone in the wheat market. There was no trading during the Friday session of the Portland futures market. All deliveries were lower, May losing 1/4 @ 1/2 and July and September each 1/4 @ 1/2 bu.

On the merchants exchange cash wheat lost 1/4 @ 1/2 bu.
