for the facility with which it was conducted after the county health nurse had worked out the details of organization. The merchants of the city co-operated in making the round-up a success by making appropriate window displays.

Last year more than 1800 children were examined in the state of Oregon and many defects corrected, the most common of which are defective tonsils, teeth, malnutrition and poor posture. Oregon ranked 16th among the 48 states in the work, under the able chairmanship of Mrs. Claude A. Lewis, who will serve again this year for the fourth time.

This yearly round-up of children to correct remedial defects before entering school has proved an economic project inasmuch as the number of failures in academic work has been reduced since this effort has been made, it is believed. Children are sent to the family physician and dentist for medical care when defects are noted, since no effort is made to give free health service outside of the examination. The entire program of the 36th annual convention of the National Congress of Parents and Teachers, which will be held May 15-20 at Minneapolis, Minn., will be built around the theme: "Safeguarding Childhood Through the Crisis." This theme will be divided into three parts: "Safeguarding Childhood Through the Home, Through the School, and Through the Community." The speakers at the general sessions will develop these aspects of the theme. Conferences will follow the addresses. The usual program of teas, banquets, and lun-

cheons will all have their places on the program. Following an established custom a tree will be planted May 15th on the campus of the University of Minnesota. This tree will be dedicated to the late Dr. Randall J. Condon, former vice president of the National Congress of Parents and Teachers, and a prominent educator. Dr. Condon was in Oregon last fall shortly before his death.
