## 6-Hour Rail Day Hearing on May 11

WASHINGTON, Mar. 29 (AP)—The interstate commerce commission has announced that on May 11 it will open hearings on the six-hour day as a means of relieving railroad unemployment.

The investigation is being undertaken by order of congress under a resolution instructing the commission to ascertain the effect upon operation, service and expenses of applying the principle of a six-hour day in the employment of railroad workers.

**OREGON TO BE REPRESENTED**  
SALEM, Mar. 29 (AP)—Oregon will be represented at the interstate commerce commission hearing on grain rates, opening in Chicago April 5. Charles M. Thomas, public utilities commissioner, announced today. A. P. Harvey, in charge of the transportation division of the commission, will leave this week for the hearing.

Thomas said the outcome of the hearing, and the decision of the federal commission will have an important bearing on the grain rates in Oregon.

**Propose Candy Levy**  
The committee also proposed a 5 per cent levy on candy to bring in \$12,000,000 and a 10 per cent levy on safety deposit boxes to bring in \$1,000,000.

Applauded by Republicans and Democrats alike, Garner spoke in slow measured tones, unlike his former fiery addresses as a minority leader.

With a husky voice and obvious emotion, he said:  
"You have arrived at the conclusion you will have no sales tax, but I appeal to you for the sake of my party and your country to do your duty and restore some taxes to that bill by which this country's financial integrity may be maintained."  
"My only object in taking the floor was to make this appeal," he had

declared before. "As sure as I stand in the will of this house I believe that unless congress makes it evident there would not be a bank in the United States in six days that could meet its depositors."

He cited the effect on the nation's exchanges and international money markets of the house's action last week and the resulting belief congress would not raise sufficient taxes to balance the budget.

"We found the foreigners selling the dollar. We found United States securities dropping lower," he said.

**Voice Husky**  
Then with a voice so husky it was difficult to hear in the galleries, he appealed:  
"I don't care what taxes you impose. This committee of yours is going to bring in a program but if you don't like them, won't you have the patriotism enough and the manhood enough to offer something else."

During his remarks to a crowded floor and overflowing galleries, Garner said he was opposed to the sales tax which was rejected last week but had been willing to accept it, believing that "the worst taxes you could possibly levy would be better than no taxes at all."

**House Applauds Garner**  
Three times during his speech, the full house membership stood and applauded. The first ovation came when he stood up and addressed the chair, the second when he appealed to the membership to evidence its determination to balance the budget by rising in their places, and the third when he left the floor after concluding his remarks.

In a humorous tone, Garner said that while some spokesmen had been severely critical in speeches outside the house, "the membership of this Republican side has been quite decent."

"I have always been what is known as a party man," Garner said. "I have never cast a vote contrary to the principles of the Democratic party but let me say this to you Democrats: 'Don't get critical; don't throw bricks; don't point your finger at somebody and say he is not a Democrat.'"

This appeal for Democratic harmony closed the speakers remarks and the house plunged immediately into consideration of the tax bill.

Marking the first time the speaker has taken the floor since his elevation to his post of leadership.

## Prudential To Be Returned To Its Shareholders Soon

SALEM, Mar. 29 (AP)—The Prudential Savings and Loan association group is expected to be returned to the shareholders. Owners of the associations, and not to the directors, within the next six months. James W. Mott, state corporation commissioner has announced. His statement came in answer to a letter from Carl R. Johnston and C. A. DeGrace, former president and vice president of the group.

The letter from the former officers and directors demanded Mott turn over the books and records and assets of the companies to them at once. The letter, received by Mott today, stated "Unless you (Mott) cease promptly your illegal control of these institutions and pursue the course, imposed upon you by law, the undersigned will take immediate action in behalf of the 13,000 shareholders."

In their letter Johnston and DeGrace said ostensibly directors of the associations requested him to take possession of these institutions, but that the request was "coerced by your threat to force these bodies into immediate liquidation to the detriment of thousands of innocent shareholders, unless your will was done." They further declared the possession by the corporation commissioner was "illegally procured."

Mott in a statement Monday said the associations were taken over last November, not for liquidation, but for operation, and that the alleged impairment of \$80,000, claimed by Mott as the result of the former management, would be restored within the next six months. Mott added that through the department's action, the companies will be saved and "not a single depositor will lose a dollar."

**Relish Salad**  
(Excellent with chops or roasts)  
1 package lemon flavored gelatin mixture.  
1 cup pineapple juice.  
2-3 cup boiling water.  
2 tablespoons lemon juice.  
4 tablespoons sugar.  
1 cup chopped pineapple.  
1/2 cup chopped celery.  
1/2 cup chopped pimentos.  
2 tablespoons chopped olives.  
1/2 teaspoon salt.  
1/2 teaspoon pepper.  
Heat pineapple juice and when boiling add gelatin mixture and boiling water. Stir until gelatin has dissolved. Add sugar and lemon juice. Cool until a little thick. Add rest of ingredients and pour into shallow mold which has been rinsed out with cold water. Set in cold place to stiffen. Unmold on lettuce and top with salad dressing.

**Blitzed Torte**  
(A ready frosted cake)  
4 tablespoons fat.  
1/2 cup sugar.  
1 teaspoon lemon extract.  
1/2 teaspoon salt.  
4 tablespoons milk.  
4 egg yolks.  
1 cup flour.  
1 1/2 teaspoons baking powder.  
Cream the fat and sugar. Add rest of ingredients and beat 3 minutes. Pour to thickness of 2-3 inch in shallow pan fitted with waxed paper. Cover with meringue.

**Meringue**  
4 egg whites.  
1/2 cup sugar.  
1/2 cup shredded almonds.  
1 teaspoon cinnamon.  
Beat whites until stiff. Add sugar and beat until creamy. Roughly spread over cake batter. Sprinkle with almonds and cinnamon. Bake 30 minutes in slow oven. Serve out in pieces.

## VACATION BEGINS HERE ON FRIDAY

Students of Schools to Enjoy Spring Outing—Teachers to Make Trip

Spring vacation in the public schools will start Friday afternoon at 3:30, and many of the members of the teaching staff are planning to attend the 34th annual session of the Inland Empire Education association at Spokane which will be held on April 6, 7 and 8. The Eastern Oregon Principals and Superintendents association will meet in La Grande on Saturday, while on Monday, Tuesday and Thursday afternoon, the Northwest Association of secondary and higher schools will hold sessions in Spokane.

Superintendent H. E. Inlow, A. L. Grallapp, principal of the La Grande High school; and Clive Moore, of Riveria, plan to attend both the Northwest association and the Inland Empire association meetings.

Dr. R. E. Russell, professor of secondary education at the University of Idaho, will be one of the principal speakers at the Eastern Oregon meeting which opens Saturday morning at 10 o'clock. Dr. Russell is an important figure in Idaho educational circles since he is the director of the reorganization of high school curricula in the state of Idaho.

The accrediting committee is an important part of the Northwest association which opens on Monday morning in Spokane. The committee consists of a representative from each state who meet to determine the credited standings of high schools and colleges who are members of the organization. Mr. Longfellow is a member of the accrediting committee. The entire organization has been formed to foster cooperation between high schools, colleges and universities in the Northwest. George Huff, superintendent of the Salem schools, is president.

On Thursday afternoon Dr. P. E. Bolton will present the report of the commission on accrediting higher institutions. Dr. Bolton is dean emeritus of the school of education at the University of Washington. Henry M. Hart, of Lewia and Clark High school at Spokane, will report on the secondary school. Charles L. Harlow, director of training at the Lewiston State Normal in Idaho, will report for the revision of standards committee. Mr. Longfellow is a member of this committee also. P. L. Stetson, professor of education at the University of Oregon, will speak on the introduction and use of the 60 minute class period. Others on the program will be L. O. Swenson, of Olympia; and Kenneth Shumaker, of the University of Oregon, in charge of freshman English, and M. P. Moe, of Helena, Mont.

The Inland Empire association will meet on Wednesday. Owen D. Speer, superintendent of city schools, of Deer Lodge, Mont., is president of the association, and President H. E. Inlow, of La Grande is a member of the executive committee.

Speakers of the general sessions will be Judge Florence Allen, of the supreme court of Ohio; Dr. Ernest Horn, head of the college of education, State University of Iowa; Dr. Robert E. McConnell, president of Washington State Normal college, Ellensburg; George H. Derr, governor of Utah; Alden G. Alley, League of Nations association, New York City; and Norbert C. Hoff, president of Mt. St. Charles college, Helena, Mont.

Various branches of educational activities will hold separate meetings during the sessions, including such subjects as English, mathematics and so forth.

Captain Bean had the company at his command and displayed real leadership when he was able to direct the movements of the entire company, squad by squad, with ease and facility.

Inspection of the company included close order drill by squad, platoon and the company, military courtesy and customs of the service, personal hygiene and first aid, riot duty, bayonet training, combat principles of the platoon and company, extended order drill, visual signaling, scout, patrolling and several other events on which the company has been training since the summer camp at Camp Clatsop in June.

An official report of the inspection will not be received for several weeks.

Colonel Allen is one of the most picturesque personages in army life in Oregon, having served since he was 16 years old. He has been in the army in Cuba, France, Panama, the Philippine Islands and China.
