

Butter Market Unchanged; Egg Trade Tone Slow

PORTLAND, April 12 (AP) — There was little, if any, material change in the market for butter either locally or generally along the coast for the day. Conditions throughout the country appear steady. Make continues to gain in practically all positions. There was a greater increase in shipments from out-state points during the last few days than the local manufacture even though the latter was considered very liberal. Lower prices named a short time ago in retail shops for butter have created an abnormally keen demand. Demand is best for standards with just a fair call for the so-called 92 scores and better. Call for under-grades is very active and especially in shops that cater to price rather than to quality. There is no further change in the butter situation. There remains a very slow trading tone in the egg market although the volume of business is fairly liberal in a retail way. Demand for cooler operation is slow and receives are forced to store for their own account. Unchanged prices continue generally in the market for live chickens. Prices are generally unchanged. Demand for small broilers is being curtailed by the extreme bearish talk of the killers. There is a stronger tone generally in the market for country killed birds. Sales are shown up to 10c for selections. Lower prices are being named for country killed hogs with further declines in the live stuff price list. Salaries are now being made very seldom above 6c for best blockers with some steady 4-4 1/2c lb. Market for country killed spring lambs is a trifle easier although the former extreme is still available for fancy goods. Prices range 10-15c lb. Yearlings are holding 12-13c with a few 13 1/2c. Ewes generally 4c lb. Supplies of onions at Oregon country points are dwindling with most of the business in small truck lots. Trading in primary sections mostly at a nickel. Local market remains slow and unchanged. Cowing to the wide spread in prices asked between local and California asparagus, the former is selling very slowly up to \$1.50 doz. pointed bunches. California stock is quoted 5-6 1/2c lb. Notes of wholesale trading: Top quality cauliflower is scarce but the supply is slowly gaining from local places. Carload of strawberries from Los Angeles arrived and was again quoted \$1.75 for 12s. Radishes are plentiful and down to 45c doz. bunches. Kennebec asparagus is finding a fair sale around \$1 for 12s. Hothouse tomatoes show a slight increase with demand just fair on account of the extreme price asked. Cabbage market is firmer but without further price change.

Unknown Soldier's Tomb Completed

WASHINGTON, Apr. 12 (AP)—The marble tomb beneath which rests America's unknown soldier was completed today at Arlington national cemetery. After six years, a design commemorating "peace, victory and valor" was finished on the monument by Thomas Hudson Jones, New York sculptor. The unknown soldier was buried at Arlington on Armistice day, 1921, to symbolize forever the nation's reverence for those who sacrificed their lives in the World war. Five years later congress authorized appropriation for a simple sarcophagus of white marble eleven feet high and nine feet wide. It was set in place last December and, while a sentry paced his post beside the tomb, the sculptor completed his task.

Nine Widows Lose Insurance Money

CHICAGO, Apr. 12 (AP)—Nine widows lost out on the \$10,000 life insurance policy of Clarence Holmes, a negro war veteran. The decision was given by Assistant Probate Judge Oscar Caplan who looked at the nine women and said: "Now if any of you happened to be the tenth wife, it would have been different. She was the tenth in this accounting, but the first in order, as Holmes got around to marrying her before any of the rest of you. "But unfortunately, my friends, she is dead." Holmes was killed by one of his wives last June. The \$10,000 was awarded to his sister.

Hoover to Keep In Touch With Business Heads

WASHINGTON, Apr. 12 (AP)—President Hoover will continue in close touch with business leaders throughout the country in an effort to better economic conditions, but he has no intention of making any dramatic move for a White House conference with groups of leaders at this time. Various questions have been directed at the chief executive as to whether he intended to hold a series of economic conferences. Mr. Hoover feels that economic conferences are being held more constantly between various government departments and business interests.

Selling Pressure Relaxes Somewhat

NEW YORK, Apr. 12 (AP)—While selling was not altogether stemmed in today's stock market, pressure relaxed markedly, and the list closed with a steady tone. There was a mixture of narrow net gains and losses. Transfers approximated 1,700,000 shares. Short covering, prompted by vague rumors of a bullish announcement impending in Washington, caused a temporary upturn early, which was lost when selling developed in the rails. The list recovered again late however, notably the industrials and utilities.

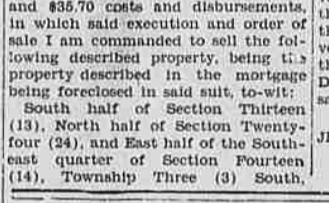
