OCTOBER, 1931 — Greets parents on return from flight to Orient.

MARCH 1, 1932 — Kidnaped from nursery in parents' farm home near Hopewell, N. J.

MAY 12, 1932 — Baby found dead near Lindbergh estate by Hopewell, N. J. neighbors.

HOPEWELL, N. J., May 12 (AP) — Formal announcement that a body of a baby, identified through clothing and other means as the missing son of Col. and Mrs. Charles A. Lindbergh, has been found was made late today at the Lindbergh estate.

The Formal Police Statement: "We have to announce apparently the body of the little Lindbergh baby was found at 3:15 p. m. William Allen, a negro, was riding from Mount Rose, N. J. to Hopewell with Orville Wilson on a truckload of timber. They stopped the truck near a woods. He, Allen, went into the woods on the Mount Rose hill in Mount Rose, N. J. Going under the bush he lowered

his head and as he raised a branch he saw a skeleton on the ground, and a person's foot. "He called back to Mr. Wilson. Mr. Wilson ran into the woods, saw what it was and decided to go to Hopewell to get police. They notified Chief Wolf of the Hopewell police who notified these headquarters. Inspector Walsh of Jersey City, Sergt. Moffett of the Newark police, Lieut. Keaton of the New Jersey state police and a number of other detectives immediately went to the scene.

"They reported finding the body of a child estimated to be between 1 1/2 and 2 years old in a bad state of decomposition, having blonde hair and wearing what appeared to be an undershirt and a flannel band around the body. "Not satisfied with this identification the men sent back to Hopewell to the Lindbergh estate to get samples of the undershirt the baby wore and of the flannel shirt the baby had on the night of the kidnaping (March 1). This flannel shirt had an embroidered collar on it. These articles were taken back to the scene and were compared with the clothing found on the body and were matched closely enough to afford an identification of the body as that of the Lindbergh baby.

RECOGNIZED AS LARGEST IN DISTRICT (Continued From Page One)

The Commercial Survey of the Pacific Northwest is one of a series of regional studies made by the commerce department for the purpose of providing business men with basic information as to the wealth, resources and marketing possibilities of the principal economic areas of the United States.

La Grande, the government points out, is the largest city in the north-eastern quarter of Oregon, and the principal trading center of Union and Wallawa counties.

The city showed a very favorable growth from 1920 to 1930, it is further noted, despite the fact that in its surrounding territory some decline was observed.

The principal source of wealth for Union county is from crops, it is shown, while in Wallawa county livestock ranks first. Pay rolls of railway shops and lumber mills at La Grande are seen as providing important supplements to the income from agriculture. The tourist trade during the summer season is noted as a further source of considerable income.

The report discusses in detail the geographical and population factors which determine the methods of retail and wholesale distribution in the La Grande area.

The Commercial Survey of the Pacific Northwest paints a broad picture of the economic life of the great area embracing the states of Washington, Oregon, Northern and Northwestern Idaho, and Western Montana. The study portrays the wealth and importance of the entire section as a market for a wide range of the manufactured goods and other products of all sections of the country.

The people of the Pacific Northwest, the government report points out, buy and sell in every market of the United States. Their relation in export and import trade extends to practically every country in the world.

Agriculture, lumbering and manufacturing alone, according to the survey, are found to add more than \$1,000,000,000 potential buying power to the pockets of Pacific Northwest residents annually.

With 2.5 per cent of the total population of the country, it is shown, the Pacific Northwest cuts over 35 per cent of all the timber, mines 15 per cent of the copper, produces nearly 25 per cent of the lead and about 15 per cent of the zinc. Its wheat farms grow one-eighth of the country's entire crop, and its orchards more than 35 per cent of the commercial apple crop and 28 per cent of the pears. On the Northwest ranges 15 per cent of all the wool is produced, while the coast fishing industry accounts for about 5 per cent of the annual American catch of fish.

Mme. Doumer, heavily veiled, sat motionless throughout the mass and whispered a word of thanks to the cardinal as he imparted the blessing at its close.

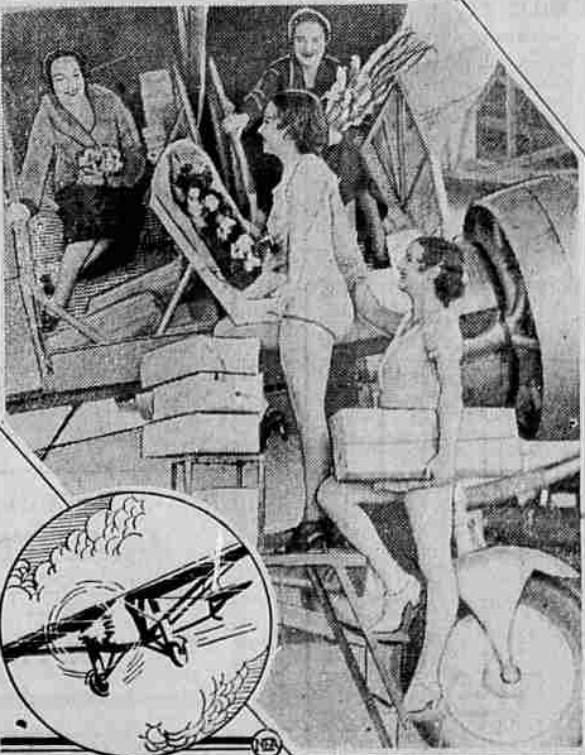
The funeral procession left the presidential palace a few minutes before 8 a. m., and began the journey to the cathedral.

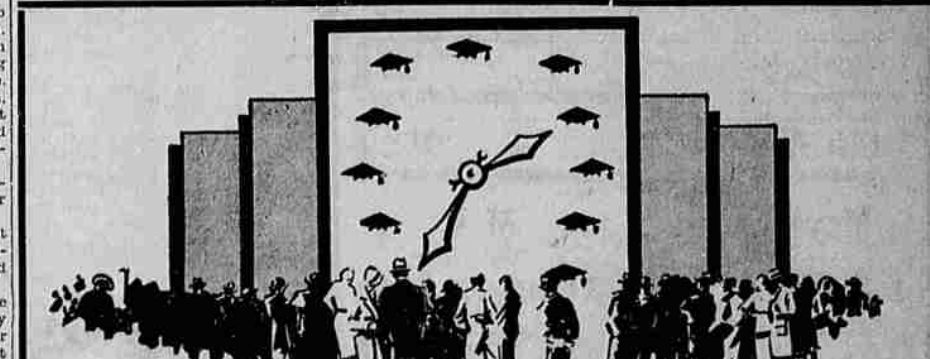
After the services at the cathedral the cortege continued the march to the Pantheon.
