last night and was to be pressed today.

Curtis Watched Closely
Curtis is being watched closely by the police for fear his "remorse" may tempt him to commit suicide, a high official revealed today. Curtis' every movement is being watched, it was said.

Later information from Norfolk told of police taking mud scrapings from a green sedan owned by Curtis to determine whether any Jersey mud was on the car.

The first confidential announcement of the kidnaping of the Lindbergh baby March 1, sent on the interstate police alarm system said the child had been spirited away in a green automobile. During a recent telephone conversation with the Norfolk public safety commissioners Curtis described a green car to him and said discovery of that automobile

might prove the key to the whole mystery.

The only car which could be found in Norfolk answering the description was one owned by Curtis and found in his shop yard. It is from this car that scrapings have been taken for possible analysis.

Col. H. Norman Schwarzkopf, superintendent of state police, announced today the examination of Curtis was continuing but did not disclose the nature of the questions asked. He did say that any action against Curtis had been deferred pending completion of the examination.

Police were today awaiting the arrival of Rev. H. Dobson-Peacock, another of the Norfolk negotiators. In his confession yesterday that he had been contacted by Curtis in his whole story of contacts with the kidnapers was a hoax, Curtis said that Dean Dobson-Peacock "could have prevented this trouble."

The minister was invited to come here voluntarily but no reply had been received from him this morning.

Dr. John P. Condon, Bronx mediator who paid a \$50,000 ransom to supposed kidnapers of the baby, was resting at his home today. He expressed no surprise when told of the Curtis confession and said Curtis' activities had broken his own contact with the kidnapers.

Dr. Condon and Curtis were taken to the Lindbergh home for questioning Thursday night, when the baby's body was found. Dr. Condon was released the next day and Lindbergh wrote him a letter thanking him for all his efforts. Curtis was detained, however, and his examination continued until he suddenly broke down yesterday and typed out his confession.

All Work Co-ordinated
Gov. A. Harry Moore of New Jersey announced today that "all police work, state and federal" is now co-ordinated and all forces are working along with the same purpose in view.

Gov. Moore said it was probable Curtis would be arraigned today after a complaint had been sworn out against him by the police. A state charge, if made, the governor said, would probably be that of making false statements "which in effect means hampering the ends of justice."

There were reports here today, also, that Curtis would be charged by the federal government with hampering the functions of the government. On the strength of his story the coast guard patrolled the coast.

A report disseminated by a news service (not the Associated press) that Curtis had actually attempted to take his life, was officially denied at the state box.

Major Charles Schoeffel, assistant superintendent of state police, made the following statement through John Toopy, secretary to Gov. Moore:

"We have information from a confidential source in Norfolk that this man (Curtis) became involved in financial difficulties and attempted suicide and after receiving that information, for his own protection we placed a guard over him 24 hours a day." He has neither attempted suicide nor has he had an opportunity. He is still being detained for questioning."

Mrs. Curtis, shortly after the announcement that her husband had confessed to have faked his negotiations, said Curtis was at home on the night of March 1.

BOOTLEGGER ACCUSES CURTIS
MINNEOLA, N. Y., May 18 (AP)—Inspector Harold R. King of the Nassau county police said today that one hour before John Hughes Curtis confessed his whole story about the Lindbergh kidnaping hoax he was confronted in Hopewell with a Long Island bootlegger who charged him with having double-crossed him in a deal involving a substantial sum of money.

King said the bootlegger was found by John Fogarty, a private detective employed from the alert by Col. Henry Breckinridge, Col. Lindbergh's friend and attorney.

He withheld the name of the bootlegger, who he said, lived in Rockville Center, Long Island.

The man's story, according to King, was that last December he paid Curtis a substantial sum of money with the understanding Curtis was to use it to purchase influence for him with the authorities at Norfolk. This, he said, Curtis failed to do.

How to Vote Monday
Over in the house a vote will be had Monday on whether the O'Connor-Hull bill to levy a tax of three cents a pint on beer of 2.75 per cent alcoholic content by volume will be taken up for consideration.

Indications are the vote will be heavier than that there on the Cullin bill amendment to the revenue bill, which was defeated 216 to 123.

Exactly 145 members signed a petition to discharge the house ways and means committee from consideration of the O'Connor-Hull bill. About 30 more have indicated they will vote for it.
