row, promise to add 40 more. That will make, in all, a claimed total of 573, with only a small percentage of the claims disputed. A convention majority is 578, and 770 are needed to nominate. Nearly 200 remain to be selected.

**Roosevelt's Problem**  
It all depends the conviction that Roosevelt's problem will be, in the convention itself, to pick off 100 or so recruits from the ranks of the opposition. This will be much easier to do if he can go to Chicago with an undisputed majority behind him.

The opposition appears just as determined as ever. During the present week Alfred E. Smith took the Connecticut delegation of 16, bringing his total to 92, and an anti-Roosevelt delegation of 32, also claimed for Smith, was chosen in New Jersey.

It cannot yet be determined who will be the beneficiary of the Young renunciation, but for the time being talk of favorite sons and dark horses has been to such figures as Newton E. Baker and Governor Albert C. Ritchie.

Now Young is free to take leadership, as he undoubtedly will, in framing the economic policies of the party. Among the Republicans, events have rolled along conventionward with no new sign of trouble. Prohibition still agitates state conventions and candidates everywhere, but quiet efforts at a solution continue.

All members of the cabinet have given the president their views, but the impression continues Mr. Hoover will say nothing, awaiting the decision of the convention.

## Two New Bishops Are Elected At M.E. Conference

ATLANTIC CITY, N. J., May 20 (AP)—With the vacancies in the Episcopacy filled by the election of two new bishops, the Methodist general conference today returned to its speculations on the transfer and resignation of bishops.

Most of the discussion centered on where Bishops-Elect J. Ralph Magee, Seattle, Wash., and Ralph S. Cushman, Rochester, N. Y., who were chosen by the conference yesterday after five days of balloting, would be assigned to serve their first quadriennium.

There was no indication as to what Episcopal areas the two men would receive. Bishop-Elect Cushman was chosen last night on the nineteenth ballot. Bishop-Elect Magee was elevated to the Episcopacy on the seventeenth vote earlier in the day.

The two men have served thirty years each in the ministry of Methodism. Mr. Magee rising to prominence through his pastoral work, and Mr. Cushman gaining his reputation through work in "Christian stewardship" which is connected with church finance. Prior to election, Mr. Magee was the district superintendent of the Seattle, Wash., area and Cushman was pastor of the Aabury church in Rochester.

The formal consecration of the two bishops will take place Sunday afternoon.

## BARRETT DOING TIME

PERNAMBUCO, Brazil, May 20 (AP)—Captain William Barrett, formerly of Hillsboro, Ore., wanted for the alleged larceny by baillee of about \$125,000 worth of jewelry from Mr. John D. Spreckles Jr., daughter-in-law of the San Francisco sugar king, in 1920, now is serving six years in federal prison here for counterfeiting. He was convicted and sentenced in October, 1931.

**FARM BILL REPORTED.**  
WASHINGTON, May 20 (AP)—The three-fold farm relief plan of the major farm organizations, calling for the equalization fee, export debentures, and a domestic allotment plan of distributing was reported favorably today by the senate agricultural committee.

The committee made only minor changes in the wording of the measure as presented by the national grange, the national farmers union, and the American farm bureau federation, which agreed upon and drafted it.

The measure authorizes the farm board to put into effect any one or combinations of the three plans when considered necessary to assist agriculture.

The vote was not announced by Chairman McNary.

Banking authorities say that one of the chief difficulties in the way of the rapid and successful operation of the federal reserve's credit expansion has been the concentration of funds in New York, principally because bankers in other parts of the country are either unwilling or unable to make use of their funds.

As the federal reserve has purchased "government" bonds put into the market have tended to concentrate in New York, even though much of the securities purchased by the board have been sold by banks in other parts of the country.
