BROWNE STILL ON LAND SEATTLE, May 28 (AP)—Lack of a Southern try to aid him in attempting to take off, with an almost dead calm surrounding the airport, early today delayed an attempt by Nat C. Browne, New York aviator, to get his plane "Lone Star" into the air on a Seattle-Tokyo flight.

Old Glory Floats Over Saunton Club

SAUNTON, Devonshire, England, May 28 (AP)—For the first time in history, the Stars and Stripes flew alone from the staff of a British golf club today. The Saunton Golf club raised the American flag in honor of Maureen Orcutt's sensational 73 in the first round of qualifying play in the British women's championship yesterday. Hitherto the American flag has flown with the Union Jack during international play at British golf clubs, or with the flags of other nations.

SAUNTON, Eng., May 28 (AP)—Maureen Orcutt, of Englewood, N. J., today led the field of qualifiers in the British women's golf championship, posting a 73 for her second round for a 36-hole total of 151. Enid Wilson, defending champion, was in second place, three strokes back of the American girl. Virginia Van Wie was third in the field with an 81 today and a 36-hole total of 158.

The veteran packer had fallen from his window to the alley at the rear of the North State street apartment. Death was instantaneous. He was the son of the pioneer packer, Guatavus Franklin Swift, founder of the firm that became the world's largest.

While other great Chicago families had relinquished their hold on the industries that made them great, the Swifts had clung to active leadership in their international packing business. At his death, Edward F. Swift was chairman of the Chicago house and president of Campana Swift International, which does an extensive business in South America.
