State Board Favors Salary Cut

Governor's Plan Wins Approval In Salem Today

SALEM, May 31 (AP)—The state board of control today passed a resolution calling for the reduction, readjustment and standardization of the salary schedule of all state employees, including those salaries fixed by law. The resolution presented by Governor Julius L. Meier was passed unanimously. Under provisions of the motion, the governor as chairman of the board was authorized to appoint a committee of three to make a study of salaries and wages and to report its findings and recommendations to the board not later than July 1. The governor announced he would name the committee later today. The action was suggested by the governor, he stated in his resolution, because "the present administration inherited from preceding administrations an accumulated deficiency aggregating approximately \$3,000,000."

"In addition to the said deficit," the resolution continued, "a survey of the present financial status of the state reveals that there will be a probable shrinkage in revenues due to the depressed economic condition of the country as a whole. In view of this situation, additional and further rigid economies must be introduced into the administration of state affairs if we are to have a balanced budget for the next biennium and that it was consistent with the practice uniformly adopted in private business."

Church Pew Spaced
