Men Who 'Make' Presidents — No. 2 Jefferson, Hamilton Were The First Party Bosses

Washington, June 11—The first important political bosses in this republic, who gave us a system that still endures in 1932, were Thomas Jefferson and Alexander Hamilton.

They were the great rival and bitter enemy of Jefferson, Hamilton saved the presidency for Jefferson in 1800. He could not stomach Burr or the plot joined in by some Federalists who sought to aid Burr in his trickery.

Burr was an adroit and unscrupulous politician. After the Jeffersonians tossed him overboard in 1824, refusing to let him be vice president again, he ran for governor of New York and was again thwarted by Hamilton. His famous duel with Hamilton followed.

Martin Van Buren, another great political boss, came upon the scene in 1812, the year he managed DeWitt Clinton's unsuccessful campaign against Madison. He proved one of the smartest, most resourceful bosses on record. He came to be called "the Little Magician."

Under Andrew Jackson, Van Buren's power increased. The patronage of Jackson became a revered national institution, and professional politicians—men who held no public office—came into being.

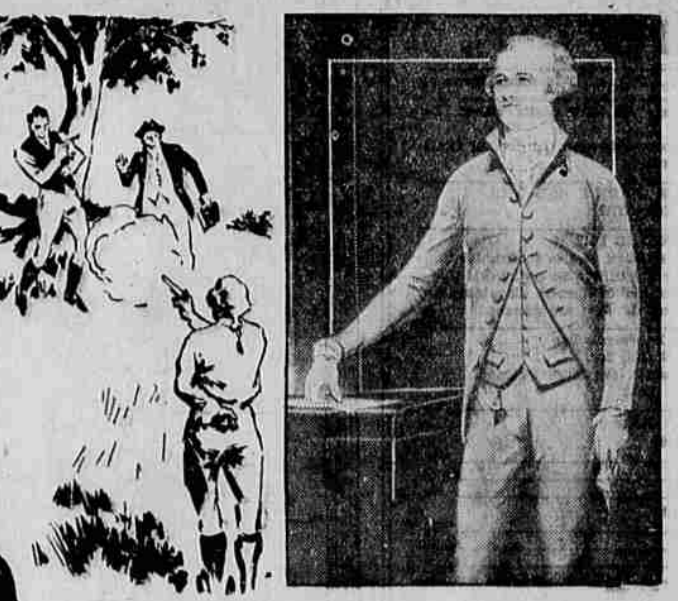

First "boss" in American politics, Thomas Jefferson, extreme left, held tremendous power for a quarter of a century. He founded the Democratic party, "elected" three presidents and enjoyed a reign never equaled in political history.

He engineered the election of James Madison as his successor by a series of deals and dictated the selection of James Monroe for another eight years. Just before his death in 1806 he is said to have been instrumental in the 1824 election of John Quincy Adams.

Hamilton, undisputed leader of the Federalist party, was a very practical politician. His theory, as opposed to Jefferson's, was that the government should be operated for the people by the aristocracy.

Though he was the great rival and bitter enemy of Jefferson, Hamilton saved the presidency for Jefferson in 1800. He could not stomach Burr or the plot joined in by some Federalists who sought to aid Burr in his trickery.
