Wage Scale May Be Considered

SALEM, June 30 (AP)—Consideration of the wage scale for emergency highway work may be up for discussion at the meeting of the state highway commission in Salem tomorrow. Prosecution May Not Be Dropped

SALEM, June 30 (AP)—Jackson, Douglas and Multnomah counties may continue prosecution of former officers of the Empire Holding corporation, James W. Mott, state corporation commissioner, announced last night in a letter to Barnett Goldstein, special prosecutor. These counties will be provided with all evidence in the case and the matter will rest with the district attorneys of the counties.

Mott declared that while most of the stockholders considered that justice had been sufficiently served through the conviction of Frank Keller, there was quite a general feeling that the outcome of the cases against the other officers might have been different had the corporation department been permitted to submit the results of its investigations to the grand jury in counties where the major operations of the company were centered.

Two Accused Of Embezzling Funds

PORTLAND, Ore., June 30 (AP)—Indictments charging Wynner R. Patterson and H. Lawrence Reynolds with conspiracy to embezzle funds from the Citizens National bank in violation of the national banking law and against Joe Tenny, accusing him of violation of the Mann act, were returned yesterday by the federal grand jury.

Three secret indictments, 19 general indictments and two not true bills were returned. One of the not true bills cleared Cecil J. Jennings of a charge of possession of intoxicating liquor in Medford Mar. 14, 1932.

SHIELDS HOLDING LEAD
PORTLAND, Ore., June 30 (AP)—Johnny Shields, Seattle's only remaining hope in the Pacific Northwest Golf association's championship tournament, found easy going today and completed the first half of his quarter-final match 6 up on Joe Brown of Portland.

Brown roamed all over the course and carded a big 82, while Shields came around in 75.

Eddie Togan and Vincent Dolp, both of Portland, played neck and neck and were on even terms at the lunch hour. Both posted 74's, two over par.

H. Chandler Egan, of Medford, playing for the Waverley county club, was hitting the ball hard and straight and held a three-hole lead over Dr. O. F. Willing at the half-way mark. It was a hard fight between the two former champions but neither could get under par consistently. Egan scored 74 and Dr. Willing 77.

Johnny Robbins, of Alderwood, a favorite was 4 up on George Mead, of Peninsula. Robbins got one under par with 71 while Mead checked in with a 74.

ROOSEVELT'S NAME PLACED IN NOMINATION

being unable to muster even the number of seconds needed to insure a roll call.

Woman's Amendment Accepted
The only amendment adopted to the platform as it came from committee was one proposed by a woman, Miss Caroline O'Day of New York, expressing the interest of the party in human welfare work, particularly among children.

As the nominating began, accompanied by its usual interlude of cheering and demonstrating for the convention favorites, it appeared it would be well on in the evening before it ended.

The first name to be put before the convention was that of Governor Franklin D. Roosevelt, whose legion of supporters greeted the eulogy of him with long and loud cheers as his managers went about the floor seeking the first-ballot rush which they hoped would about tell the story.

Alabama yielded to New York to allow the governor's old friend, John E. Mack to place his name before the convention.

Pictures Unfurled
As Mack read on in a soft voice and making no gestures huge pictures of Roosevelt were unfurled and attached to various standards. Large American flags were brought in, placards proclaiming him to be "the people's candidate" were carried to strategic points.

As the nominator named his man, at the end, a demonstration that rocked the rafters broke across the convention floor.

When he pronounced the name of Roosevelt, the followers of the New York governor blanketed the whole delegate arena with mouster lithographs and banners, and started a parade which trumpeted all before it as it circled dancing and shouting about the vast hall.

No one could tell who started it. New Hampshire and the District of Columbia, by virtue of their positions at the head of the center aisle got away to a running start. But they

were hand pressed by Nebraska and Montana, by Georgia and New Mexico, and so many more it appeared the entire convention was on the march.

From every state standard was unfurled a five-foot bust length likeness of Franklin D. Roosevelt. A variety of other banners and placards shouted the praises of the candidate in letters large and multi-colored.

Pipe Organ Music Deafening
The pipe organ pealed the old marching songs in deafening tones as the paraders circled the delegate enclosure again and again, cheering their leader shouting jubilantly to one another, doing jigs to the tripping organ notes.

Georgians bore a huge placard reading "Georgia, his southern home." Wisconsin advertised in letters a foot high "Wisconsin for Roosevelt." One delegate carried a placard "prosperity and the full dinner pail, back with Roosevelt."

A discussion whether the New York standard should join in was settled in the affirmative by Dave Lee of Birmingham. He carried the New York standard away and Tammany leaders did not object. Nearly half of the Empire state delegation joined the marchers, but James A. Farley—the Roosevelt manager—John P. Curry, Tammany leaders, and Mayor Walker, of New York, kept to their seats.

Mrs. Stewart Mills, of Brinard, Minn., was carried about the hall on the shoulders of two husky Roosevelt fans, as the organ turned to "Hail, Hail, the Gang's All Here."

"Big Jim" Farley, the Roosevelt manager and head of the New York state boxing commission, mounted to the speaker's platform to have a good look. The marching delegates also got a good look at him, smiling and bowing, and they set up a cheer for him.

Not to be outdone by her Minnesota neighbor, Miss Mary Quigley of Valentine, Neb., took a ride about the hall high on the shoulders of two men.

Governor's Son in March
The New York standard was handed over eventually to James Roosevelt, son of the governor, in his twenties, and he marched along jostled and buffeted by the crowds, smiling and joking.

Former Governor Byrd and his Virginians, close to the front of the hall, stood on their chairs and watched as the march went by. So did many in the other favorite son delegations. In the Texas delegation, however, lithographs of Speaker Garner were held high.

Many of the marchers fell out and returned to their places after they had been at it for twenty minutes, but the organ started things up again every time the parade began to languish.

The speaker's platform was jammed to the rails with officials and committeemen who stood smiling as the organizer went into "Smile, Smile, Smile."

43-Minute Demonstration
Forty minutes after the demonstration started, Farley began waving the demonstration down. "Call it off," he shouted to his scouts on the floor.

but he forgot to telephone the organizer. The music continued.

Later Chairman Walsh rapped off order. Most of the delegates were back in their places and the sergeants at arms piloted the others home. The demonstration had lasted 43 minutes.

Mrs. John C. Greenway, of Tucson, Ariz., who was a bridesmaid at Franklin D. Roosevelt's wedding, seconded his nomination.

MISSOURI TO SPLIT
CHICAGO STADIUM, June 30 (AP)—The Missouri delegation today voted to permit delegates to change their votes before the tabulation of the first roll call.

Six members served notice they would switch from James A. Reed to Governor Franklin Roosevelt before the end of the roll call.

The remainder indicated they would cast at least one vote for Reed.

The delegation, Eugene Guadoni of St. Louis said, would give Roosevelt 30 votes on the second ballot.

Reed appeared before the delegation at a hurried called caucus at

the stadium.

When asked if he had released the delegation, Reed shouted "No, and I was not asked to."

AMENDMENTS DEFEATED
CHICAGO STADIUM, June 30 (AP)—The Democratic convention today rejected a platform plank calling for bi-metalism; recorded itself as opposed to immediate cash payment of the bonus, and defeated the minority plank on banking offered by William G. McAdoo. All three were by viva voce vote.

An amendment to the platform calling for representation in congress for the District of Columbia was defeated and an amendment to the platform calling for the coinage of silver and an international monetary conference also went the same way.

Mrs. Caroline O'Day's amendment to the platform on child welfare was passed by a viva voce vote.

The report of the resolutions committee as amended on the floor then was adopted by the convention.

The convention was ready for nominations for president at 3:58 p. m.
