Short-Term Fish License Favored By Game Bureau

PORTLAND, July 12 (AP)—A proposal to provide special short-term fishing licenses for visitors, tourists and residents was tentatively approved by the state fish commission at a meeting here Monday.

The suggestion was offered by Matt Corrigan, chairman, who said the commission is losing much revenue because the state legislature has made no provision for the short-term permits. "Thousands of tourists and residents," Corrigan said, "who never have a chance to fish except during their vacation would be willing to buy a special one week license, for instance, at a reduced price, but they cannot afford to pay \$3 for a yearly license."

The commission agreed to recommend that the next legislature make provision for the sale of the special permits.

On petition of the Lakeview chamber of commerce, Hugh Leyva, game warden of Lake county, was authorized to kill from three to 10 pelicans on Drews reservoir and to send the birds to biologists to determine if pelicans are detrimental to game fish.

The commission replied to H. B. Howell, representing the governor's relief council in Josephine county, that it has no authority to issue a permit allowing the use of nets to catch salmon in Rogue river to be canned and used later for relief of the poor of the county.

Purchase of two additional fish tanks and pumps for use in liberating trout from the Oak Springs and Fall River hatcheries was authorized although Commissioner Carl D. Sivren of Baker, protested that \$350 for each pump was too expensive.

Supreme Court Denies Plea of Guardian Head

SALEM, July 12 (AP)—The state supreme court today refused to quash four indictments against S. Moltzer, president of the Guardian Building and Loan association of Portland, in an opinion handed down by Justice Kelly. The indictment charged Moltzer with unlawfully loaning the funds of a building and loan association without security.

Defendant appealed from the indictments returned by a Multnomah county grand jury on the grounds that indictments were not tried within the next term of court as by law provided. The opinion affirmed the decree of Judge W. A. Ekwall.

A writ of mandamus proceedings was denied Carl H. Johnson and C. A. Degraze by the state supreme court last night, in a similar case. The petitioners asked their trial be postponed until after an appeal from a court order refusing to quash indictments against them had been disposed of by the higher court. The court refused to review the appeal from the lower court order.

The plaintiffs in the writ action were indicted recently by the Multnomah county grand jury on charges of devising a scheme to defraud David Garrett and Ralph Carper, former officers of the Prudential Savings and Loan association.

Johnson and Degraze appealed from a lower court order refusing to quash their indictments on the grounds they were not tried during the first term of court following the return of indictments. The members of the supreme court concurred in refusing the writ, but three separate opinions were written, the main one by Chief Justice Henry J. Bean.

Gold-Bearing Land Sold to Mining Co.

GRANTS PASS, Ore., July 12 (AP)—A \$600,000 deal involving 6000 acres of diversified gold-bearing properties located principally on Grove creek in Josephine county, has been completed according to W. A. Hutton, member of the state mining board.

Hutton said the Pacific Minerals, Inc., of Detroit, made the purchase and that the first payment has been made. He described it as one of the largest mining deals ever made in Oregon. W. F. Hayden, engineer for the Detroit company said an extensive survey of the property was made over a period of several months. The purchase includes water rights embracing 47 miles of flumes and ditches.

California Vets Fail in Effort To Camp On Lawn

WASHINGTON, July 12 (AP)—Police today balked an effort by California war veterans to camp on the capitol grounds until congress adjourns or pays the soldiers bonus.

Pelham D. Glassford, superintendent of police, stopped a parade of 450 marchers at the entrance to the grounds, pulling out their bed-rolls in the shadow of the dome.

Glassford conferred with Roy W. Robertson, leader of the group, after which the vets assented to the police proposal of taking their bedding back to their camp in a truck.

Action of the police chief was predicted upon an edict by Vice President Curtis, who ruled the veterans should not be allowed within the grounds with their bedding and camp kits.

Capitol police said that a few extra men had been placed on duty because of the parade.

To camp on the capitol grounds, it was added, would be against the law. The district law provides a fine and imprisonment for loitering on the capitol grounds.

Scores of the veterans trod up the hill to the capitol, accompanied by numbers of police.

They did not attempt to march in military formation, but went in straggling groups.

A petition urging immediate payment of the bonus was presented the vice president by Robertson.

The vice president told Robertson he would present the petition to the senate, probably this afternoon. Curtis advised him to get permission to appear before a committee and seek approval of a bill to authorize the payment sought.

After leaving the vice president's office a similar petition was presented to Speaker Garner's secretary.

Robertson said the delegation intended to sleep on the capitol grounds and remain there until there was some action on their demands.

POCATELLO, Ida., July 12 (AP)—The goose that laid the golden eggs had a rival in a little red hen owned by Thomas A. Marier of this city. Marier reported general excitement among his flock of Rhode Island Reds yesterday and upon investigation found a nest full of eggs.

The prize-winning product measured seven inches around and 7 1/2 inches long. Upon breaking the freak, a common size egg was found within.

Both eggs contained yolk and white.

Lamb Movement Is Toward California

CORVALLIS, July 12 (AP)—The movement of western lambs during the past week has been toward California cities on the coast and to mid-western points from Idaho and adjacent territory, according to a weekly review of the situation prepared by the federal bureau of agricultural economics and Oregon State college.

Better finished small lambs sold later 75 to 95 pound stock has been gathered up by Los Angeles and San Francisco killers from Humboldt county and Southern Oregon points.

Prices of \$3.25 to \$3.75 f. o. b. main line points have generally been paid. Range conditions over the intermountain regions are said to be very good which will doubtless assure heavier lambs with a larger percentage in killer flesh.

The demand for feeder lambs is practically absent now, and practically no lambs have been contracted for future delivery of sold direct in Western Montana or adjoining states, the review says.

TREATY NOT ULTIMATUM TO AMERICA

(Continued From Page One) for elections," he exclaimed. The prime minister asserted Lausanne marked an essential step toward world economic recovery and he expressed the hope the conference had put an end to the uncertainties from which business has suffered.

"Where would the world have been without Lausanne?" he demanded. So long as German reparations lasted, the prime minister said, there could be no complete economic recovery.

He ridiculed the idea that it would have been possible to put off settlement of the reparations issue until next March.

Just before Mr. MacDonald started his report to the house of commons on the negotiations which resulted in scaling down Germany's payments to three billion marks (approximately \$712,500,000), it was announced by an official source that there had been neither conversations nor agreements between British and American representatives regarding any revision of war debts in connection with the Lausanne treaty.

Consulted Americans Before the house of commons yesterday, the chancellor of the exchequer, Neville Chamberlain, asserted that before the gentlemen's agreement was reached at Lausanne there had been consultation with representatives of the United States.

der this "gentlemen's agreement" it is understood the Lausanne treaty will be inoperative unless the European nations obtain satisfactory reductions of their debts to the United States.

An authoritative spokesman declared Mr. Chamberlain made his assertion in the heat of debate and that it had been taken as indicating much more than he had intended.

According to this explanation, the debate yesterday started unexpectedly as a result of Winston Churchill's statement that the government had blundered at Lausanne. The government had intended to set aside today for a full dress debate on the subject.

When Mr. Chamberlain arose to answer, the authorized explanation has it, he did not have time to choose his words with the care he would have exercised in a formal speech.

The authorized spokesman said the United States had representatives at Geneva and the British Lausanne delegation met these representatives and strolled about with them among the hills and along the side of the lake. In these informal contacts, the spokesman continued, world problems were discussed solely as a matter of social interest.

The position of the British government was said to be the same now as it was a fortnight ago, when both the British and French foreign offices issued denials that a "gentlemen's agreement" in reference to war debts had been reached.

In his report to the house of commons today, Mr. MacDonald said he understood perfectly what "very tender spots" were being touched by the Lausanne agreement so far as America is concerned.

He wanted to make it quite clear, he said, that nobody had a right to blame America for taking the attitude she has taken.

Referring to the so-called "gentlemen's agreement," Mr. MacDonald said that Friday morning at Lausanne, in reply to a question by the German chancellor whether he would guarantee that a conference of powers would follow if the settlement plan failed, he publicly declared: "Certainly, that's what would happen."

Otherwise, the prime minister explained, it would be necessary to return to the Young plan.

NOTHING SAID, STIMSON SAYS WASHINGTON, July 12 (AP)—Secretary Stimson reiterated emphatically today that the United States had said nothing to the participants in the Lausanne reparations conference concerning a possible revision of war debts.

The secretary of state said that notwithstanding any statements made in the British parliament that conversations had been had with American representatives abroad, no authorized move had been made by United States diplomats abroad to this end.

SENATE REVERSES ITSELF WASHINGTON, July 12 (AP)—Reversing itself, the senate today voted for the administration plan of setting up a system of home town discount banks instead of creating a mortgage discount division under the reconstruction finance corporation.

By a vote of 47 to 23, the senate reconstrued its action of last week in substituting the Couzens bill for the administration sponsored measure.
