RESIGNS HIS OFFICE WITH BITTER WORDS

were some of the phrases that studded the statement he gave out on his resignation.

He announced the purpose of his resignation was to "change the venue."

"I can change it to the supreme authority, the people themselves," he said. "I can change the place of trial so as to take it away from a biased judge acting illegally and in an avowed usurpation of power, with a personal interest in the outcome that disqualifies him as a matter of common decency from acting as a judge in the matter."

Roosevelt Silent
"Nothing at all to say," was Gov. Roosevelt's only comment last night. But from Samuel Seabury, counsel for the Hofstadter legislative investigation committee which dug up the material on which the unfitness charges were based, came this statement:

"The charges against the mayor were fully proved and corroborated in many instances by documentary evidence which was undisputed, and by the admissions of the mayor."

"The mayor's resignation in the face of this record is equivalent to a confession of guilt."

"No intelligent person will be misled by the mayor's attempt to substitute for a defense an assault upon the good faith and the motives of the legally constituted authority to review his acts while in office."

"It is highly significant that this excuse is availed of by the mayor on the eve of the governor's inquiry into the relations between the mayor and his fugitive agent, Sherwood."

Walker Denies Charges
Seabury has charged that Russell T. Sherwood, accountant, "handled" the mayor's resignation. Walker denies the charges.

The mayor, who has become pale and ill, spent part of his last day in office at the funeral of his brother, George F. Walker, in St. Patrick's cathedral. His frail shoulders shook and tears streamed down his cheeks. He was no longer the chipper, gay

youth of 51 that New York and a large part of the world knew. After the funeral he dropped from sight for hours, while rumors that he would resign flew. At 10 p. m., he returned to the Mayfair house, where he lives, telling reporters he felt "grace."

"Get down to city hall," he told reporters, with a laugh. "There's a statement waiting there for you."

Half an hour later City Clerk Michael J. Cruise announced the mayor's resignation. Walker had submitted it after conferences with political leaders reported to include John F. Curry, leader of Tammany hall, and John H. McCooey, Democratic leader in Brooklyn.

The mayor's chief counsel, John J. Quinn, who battled for him before Governor Roosevelt, had written him a formal letter in which he said there were two courses open to him:

1. "To continue to submit to the illegal and unfair proceedings before the governor, in which may eventually be an illegal order of removal which would be void from its entry."

2. "To submit your case to the people of the city of New York, who, after all, are the ones most concerned."

Walker chose the latter course, declaring he was "submitting my case to the people who made me mayor, the people of the city of New York."

"Shall I permit myself to be lynched to satisfy a prejudice of political ambition?" he asked.

"A Mock Trial"
He called the proceedings at Albany "a travesty, a mock trial," a proceeding in comparison to which even the practice of drum-head court martial seemed liberal.

Walker, who became the city's chief executive in 1925 after a career as a lawyer, writer, assemblyman and Democratic leader of the state senate, is the first mayor of New York to resign under charges.

McKee, who succeeds him, has been called the handsomest and most scholarly of all city officials. He is 63 years old, a lawyer and graduate of Fordham university with the degrees of A. B., A. M., LL. Comrie Explains Why Sun Eclipse Was a Bit Late

CONWAY, N. H., Sept. 2 (AP)—L. J. Comrie, superintendent of the nautical almanac, the royal naval college of London, England, who made the first rigorous calculations of Wednesday's solar eclipse, said Thursday there were at least two general causes for the reported lateness of totality.

Comrie, who spends a large part of his time calculating eclipses, emphasized, in the first place, that predictions were based on theoretical assumptions that the moon is round and, in consequence, an average diameter is used in the calculations.

"In actual fact the edge of the moon," he said, "is mountainous in part while at other places there are lower levels represented by what we call seas or maria."

"These irregularities in the limb of the moon render extremely accurate prediction impossible. The margin of uncertainty due to this cause alone is usually stated as plus or minus one second."

"This phenomenon which we call Bailey's Beads makes the beginning of an eclipse very difficult to define, since you may be timing it from the lowest valley."

"Another cause of uncertainty in prediction is the limitation of accuracy of our knowledge of the position of the sun and moon. We cannot be sure of the relative positions of the two bodies in advance to within one-half a second of arc. Effect of that uncertainty again is about one second either way."

"The combined effect of the two causes might be as much as two seconds either way, although I do not think it could be greater unless the estimates had been based on comparatively old calculations. A greater error might have been possible unless the revised predictions issued a few weeks ago were utilized, but I do not think it likely astronomers

have failed to take advantage of the more recent figures."

Comrie, who is regarded as one of the greatest authorities in the world in mathematics of eclipses and who traveled from the west coast where he has lectured before astronomical students this summer, failed to see the eclipse whose path he charted in August, 1927. In general with astronomers here, he saw only the faint outline of the inner corona through a blanket of clouds.

Lateness of the eclipse was reported by the Van Vleck party of Westview, an university of Middletown, Conn., whose director is Professor Frederick Slocum, and by several groups at Fryburg, Maine.

Slocum said, in addition, that his preliminary calculations indicated the predicted duration of totality was too great by at least one second.
