(Continued from Page One) Before the jury came in Judge Frank H. Dunne announced he would appoint acting public defender, Gerald Kenny to represent Egan, in place of Attorney Vincent Hallinan, who was found guilty of contempt of court during the final arguments, and barred from further participation in the case. Egan protested against the appointment. The jury summoned a bailiff at 11:18 a. m., and announced a verdict had been reached, but because another trial was occupying the courtroom it was nearly half an hour before the verdict was actually returned. Hallinan Restrained. During that time Hallinan tried again to enter the courtroom, but was restrained by a bailiff. Dalmou then read the verdict finding Albert Tinnin also guilty and recommending life imprisonment. Egan heard the verdict with out flinching. (Continued from Page One) can work but such tantalizing things as one-piece meals and dinner ensembles that bake while she powders her nose, or cuts the flowers in her garden, or practices her golf stroke. Miss Gray comes to La Grande on Sept. 20, 21, 22 and 23 to conduct the Observer's cooking school. The sessions will be held in the Sacajawea ballroom from 3 to 4 o'clock on each of these afternoons. This expert home economist will conduct her sessions, she says, with the intention of creating the atmosphere of one neighbor dropping in on another and discussing cooking problems. Everything will be absolutely informal—nothing is to be of a technical nature. Miss Gray says that cooking is a real art and that if every housewife attacks her task with a spirit of dread, her work is bound to be poor—if she feels the thrill and intriguing capacity of cooking, her meals will be much better and she will get a great deal more enjoyment out of preparing them. Women, to whom cooking seems an enjoyment and who get their meals in such a short time, are usually those who take time to plan out their menus and shop wisely for days ahead of time, according to Miss Gray, and she will tell the housewives of La Grande just how they may do this. Miss Gray brings her ideas on home management, as well as a host of other things in her long-heralded series of culinary programs, the "Kitchen Chautauqua."

Later he said they cast the body in a street to make her death appear to have been a hit-and-run accident. Tinnin, former Folsom penitentiary saxophone player, frowned and gripped his hands tightly as the verdict was read.
