MARY C. PIPES DIES  
PORTLAND, Sept. 28 (AP) — Mary C. Pipes, 77, widow of the late Judge Martin L. Pipes, died at her home here last night. Judge Pipes, one of the best known attorneys in the state, died in July, 1932.

FIRE FATAL TO WOMAN  
BEND, Ore., Sept. 28 (AP) — Mildred Sperry, 25, lost her life here today in a fire which swept through her apartment shortly before daylight. Her body was found a few feet from the second floor window through which she probably had hoped to escape.

The crowd demanded the right to be heard on relief plans, and four speakers were admitted to the committee room. They were introduced by J. E. Look who said he was chairman of the "federated unemployed," a group representing various unemployed organizations of Portland and Multnomah county.

One unemployed family with several children was offered as an "exhibit." The speakers declared \$45 a month for each unemployed family must be provided in some way by relief agencies this winter.

Fred E. Kiddle, of La Grande, president of the state senate, presided at the meeting of the committee of 32 members which is attempting to find some plan to be recommended to a special session of the legislature so that relief funds may be available.
