WELL DESERVED HONOR

When 460 men and women gathered in the Sacajawea Inn ball room for a dinner, program and dance last night honoring Martin King, George Nelson and M. Weis, railroad men who go on the pension roll this year, all local records for events of this kind went into the discard. It was perhaps the largest banquet attendance ever served in La Grande.

Townpeople and railroad men and women from far and near mingled in fine fellowship and enjoyed the splendid dinner and entertainment. Well-earned tributes were received by the three retiring railroaders, and by other pensioners who also were on the honor-guest list. Their records were glowingly recalled by able speakers and encomiums were heaped upon their heads.

Significant, also, was the large attendance of townspeople, showing again that La Grande and its neighbors fully realize the part the Union Pacific has played in the upbuilding of this country. Lastly, the enthusiasm of all at this railroad event gave promise of even greater gatherings here next July, when the city will celebrate the 50th anniversary of the arrival of the first "Iron Horse."

CHEERING NEWS

Protests voiced by sportsmen of Eastern Oregon and by others this last week apparently have borne fruit. Evidently the state game commission has decided that all was not serene and quiet during the elk season here last week.

Cheering word as to the future comes from a representative of the commission who, in a telephone communication with the Observer yesterday, said that if there was an open elk season set by the legislature next year, the commission would recommend it be later than the deer season. Indications also were given that the commission, regarding the season this year as somewhat of an experiment, is conscientiously attempting to profit by any mistakes that may have been made this fall.

that in the Beaver Basin country he saw 29 carcasses of bull elk, elk calves, black deer and deer fawn. From four of the bull elk the heads had been taken, and from one or two of the deer one back quarter had been taken. All other carcasses were left as they had been shot down.

P. J. Steffen swore to an affidavit that on the Hoo Doo trail he saw carcasses of eight bull elk with nothing taken from any of them but the teeth and the heads of two. "There was no way to get them out without cutting a trail for nearly a mile," he said.

339 Elk Killed
At least 339 elk were killed in Union and Umatilla counties during the open season. This was learned today when County Clerk C. K. McCormick reported about 160 elk killed in this county, according to reports made to him. Tuesday County Clerk E. B. Casteel in Pendleton, reported at least 160 elk killed in Umatilla county.

Authentic reports have not been received as yet from Baker and Walla-walla counties.
A few days ago the state game commission estimated about 300 elk killed in Union, Umatilla, Baker and Walla-walla counties.
A committee, composed of J. H. Peare, Dr. G. L. Biggers, P. N. Lanning and Angus McAllister, appointed by the U. S. Game Warden, E. P. O. E., conducted an extensive investigation of the killing of elk and deer and leaving them in the hills to spoil.

For example, Oregon State tied the mighty U. S. C. eleven and defeated University of San Francisco 12-7. It closes its season against Fordham in New York after playing Oregon. The Beavers also have defeated Washington State, Montana and Gonzaga.

Oregon walloped U. C. L. A. 7 to 0, and humbled two other out-of-state teams in Washington and Idaho. The Webfeet still must meet St. Mary's and Southern Cal., so there is a chance the Oregon record will not stand.

Washington teams also are getting the fever. The Huskies whipped Stanford 6 to 0 and won over Idaho. Washington State broke the charm which the team had in the past by beating the only major loss to a California team by a northwestern aggregation this fall!

Even the smaller schools are getting the habit. Monmouth won from Stagg's College of Pacific 12 to 0. And the E. O. N. in playing one Washington and two Idaho elevens, defeated Whitworth and Lewiston and tied with College of Idaho.

WASHINGTON (AP)—Attorney General Cummings in an opinion submitted to Secretary Ickes ruled that ex-service men with dependents who are members of a union should have preference for jobs financed by public works funds over union members who were not in war service.

Ickes had requested the opinion because of a clause in the national recovery act, establishing a "preference" for ex-service men on work financed from the public works fund.
