"This is the first call for united effort," explained Mrs. Hanley today. "Every household should send at least one letter, written in the party's own words, asking some friend or relative to pay the city a visit at that time, with special care to include in the list persons whose homes have never been here.

"The committee will not be satisfied until 1500 families have invited and urged some relative or friend to come to La Grande as their guests for the celebration.
