Cost of collection, Walch said, has been reduced to \$121 per \$100, just a little over one per cent.

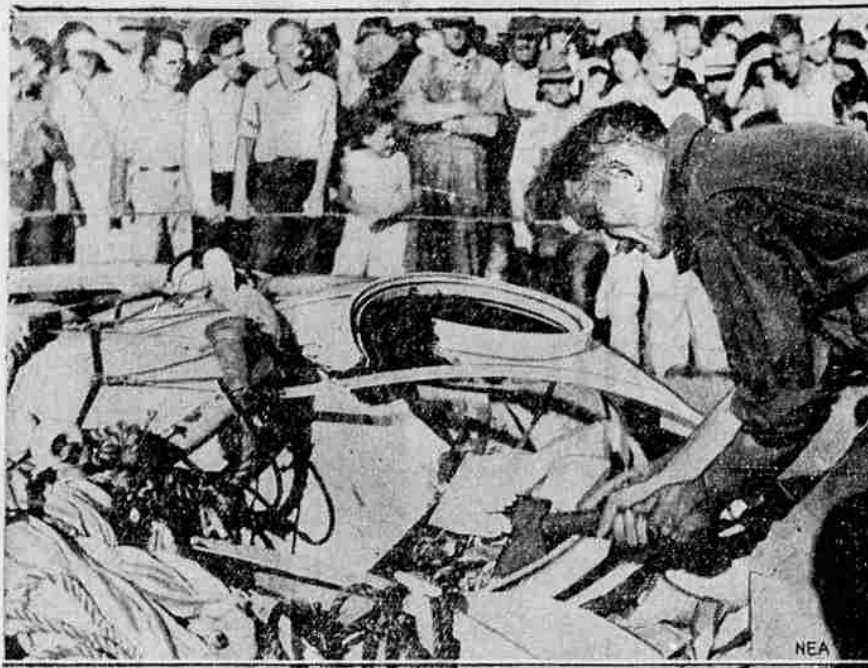
One tax that is particularly interesting and which is causing some difficulty is the capital stock tax, originating in the recovery act of 1932, he said.

casting office. That, interesting as it is, is rather prosaic, relatively speaking. The girl is, you might say, a scream. It all began—but let her tell about it.

"I started as an extra," she says. (Just one of the mob, you see, with nothing—as yet—to distinguish her from the rank and file. This is a true success story.)

"One day the director needed somebody to yell for help. It had to be a good, healthy scream. He tested several girls, me among them. My scream won. It seems my voice records better than it sounds, say, to you."

"That started it. Whenever they put the sound effects in afterward, as they often do, I help. No, not just screaming."

Soup Plate "Swimming"
"Swimming. I've been swimming in a soup plate. Honest! It was a scene showing a girl swimming, breathing hard as she made the long strokes. You know how it sounds, the gurgling and lapping. I put my face in the soup plate filled with water, and just breathed rhythmically as I ducked and came up."

"You'd be laughing, seeing in work. The time I talked to myself—I was a 'crowd' in a foreign city. Saying things in no language at all. In a lot of different voices. That was easy—it had to be an unrecognizable language, just gibberish."

"I've beaten myself black and blue—for fighting sounds. There was one fight sequence not long ago that needed four of us—three boys and myself. We got on the stage, and awing our arms, hitting ourselves like this—'Thud! Thud! Thud!'

Meowed in 'Black Cat'
"And—oh, yes! I was the cat in 'The Black Cat.' He had to be thrown down hard, and cut off in the middle of a me-ow. I gave 'em a my-ah sound—a me-ow sounds too human."

"It's fun. I wish they needed more sound effects. I'm crazy about 'em!'
