"Hitler to Become Supreme Dictator for Rest of Life" says a news headline. The way things are going in Europe, that may not be long—Childwell (Idaho) News-Tribune.

The Astorian-Budget argues that since Gen. Martin rates so high with all members of the cabinet, with the heads of bureaus and boards, with the administrator of the many branches of the "new deal" and with the members of both houses of congress, that he is precisely the man for Oregon to elect governor. Our wonder is, if he was so influential in Washington, that Portland ever let him escape from congress, because a congressman is far more effective in Washington getting something for the state than a governor, especially if the congressman is "cupbearer to the king" as the Astoria paper refers. — Salem Statesman.

The Pendleton East Oregonian, citing some of the benefits attributable to President Roosevelt, mentions the price of wheat. It has gone from around 26 and 30 cents a bushel two years ago to 77 1/2 cents. Since a good part of the increase is the result of the short crop in the drought area that claim on the part of the Pendleton paper comes perilously near to accepting democratic responsibility for the drought. — Bend Bulletin.

Bad news for the country and for hopes of recovery. Senator Cutting, one of the so-called "Progressive senators," in an interview with Dave Hazen Sunday said that the best Congress must appropriate billions of dollars to continue the work of the "New Deal." He says that the only recovery noticeable is that caused by the expenditure of public funds. We think that is true, and we think too that the scandalous expenditure of public funds is the one thing that is holding back normal recovery and that the payment of the debt will retard it many years. — Corvallis Gazette-Times.

The president, as it seemed from reading the press dispatches, was particularly impressed by the vast space in the western country as compared with the east. That led to his suggestion that many more families will come to settle in this more open country, a hint at the decentralization of population which many believe is store for this nation. — Klamath Falls Evening Herald.

While the president was away politics and administrative changes took a sort of vacation, though other developments such as strikes, a rather sharp drop in business and a new European crisis, did not. Now that Mr. Roosevelt is nearing Washington we may expect further moves in the new deal. — Baker Democrat-Herald.

OREGON PARKS NEAR TOP

SALEM, Aug. 10 (AP) — Only two states, New York and California, have a better rating of state park systems than Oregon, Dr. John H. Merriman, representing the Carnegie Institute, stated in a letter to Sam Boardman, Oregon state park engineer. Merriman had recently completed an inspection of parks in all sections of the country. The most outstanding series of state parks was credited to the state of New York, and the second best system to California. The former was reported as having spent \$100,000,000 in acquiring tracts and improvements. California \$38,000,000 and Oregon \$380,000.

Yellowstone Park Travel Is Showing An Amazing Gain

YELLOWSTONE Wash. Special) — Travel into Yellowstone Park continued its amazing increase and is still 10,000 greater than 1929, the largest travel year in park history, according to monthly summary up to August 1st, released by Roger W. Toll, park superintendent. Visitors to Yellowstone to August 1st numbered 149,403, compared with 94,255 last year and 139,831 to August 1st, 1929. Splendid increases are also shown at Glacier National Park and Rainier National Park indicating that the people of the United States are giving a magnificent response to the program of the secretary of Interior in announcing the year 1934 as National Parks Year.

DUCK SEASON DATE CHANGE IS REQUESTED

The last of the migratory birds heavy frosts kill all vegetation on which ducks feed and birds leave even before the freeze-up occurs. We know from experience that we have had many seasons in the past that we have had very little, if any, duck shooting after Nov. 1, due to cold and freezing weather conditions.

"We therefore ask the game commission to change the opening date to Oct. 1, as recommended in June 2, by More Game Birds in America, Inc." We also recommend that open days for duck shooting be on Wednesdays and Sundays of each week during the open season.

"We the undersigned legislative committee on fish game and birds have spent the last several days interviewing sportsmen in this locality and find that they are very much disappointed in opening the season as late as this. Therefore we urgently request your honorable body to give this matter your immediate and earnest consideration."

10,000 BASS AND CRAPPIES FREED TODAY

An average of 500 fishermen per day fish for the finny treasures during most of the year. They are similar to salt water perch.

The bass, which are unlawful to catch if under six inches in length, are noted throughout the world as a game fish and an excellent dish. The bag limit is the same as trout.

The big bullfrogs, which grow to two pounds in weight or more, are the same as those which furnish frog legs for epicureans the world over. Many catch them with a piece of red flannel on the end of a large hook.

The bullfrogs taking it like a fish will fly in some sections where they can be retrieved easily, 22 caliber rifles are used to hunt them with.

In the load also were some 500 catfish, the first to be placed in Morgan lake.

Both crappies and bass are of a cannibalistic nature, and it is expected the perch now in the lake will make many a meal for the game fish.

As an example of how the bullfrogs increase and migrate, 10 pair of them were released near the Portland union stockyards ten years ago, and now they are being caught all the way from The Dalles to Astoria.

When the fish were liberated this morning, the temperature of the lake was 50 degrees, just two degrees cooler than the temperature of the can in which the fish were kept. The only loss in the long trip was 47 crappies—none of the bass, tadpoles or catfish dying en route.

The state police today urged all who fish at the lake this year or in previous years to throw back all fish under six inches in length. They expect to keep a fairly close watch on the lake to see that the game laws are respected.

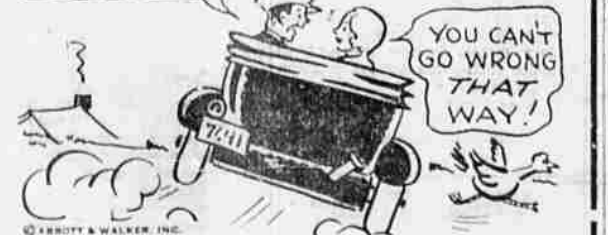
CLERGYMAN APPROVES OVERTURES IN CHURCH
