Nelson Re-Injures Back in Taking Lead in Meet

One Stroke Up On Ben Hogan In Big Open

CHICAGO, July 27 (UP)—Byron Nelson's fiery competitive spirit today apparently was about to cost him golf's richest prize, the all-American open championship.

As the three in one all-American tournaments entered the second round at the Tam O'Shanter club, Nelson once again was leading the field in the rich \$57,733 men's open of which he is defending champion. But he had to stage one of the most spirited rallies yesterday to get there, shooting a 36-30—66 to take a one stroke lead over his fellow Texan and oldtime caddy pal, First Lt. Ben Hogan.

Nelson gave it all he had on the back nine—shaving six strokes from par—to get in ahead of Hogan's crackling woods and precision iron.

But the fighting Nelson heart, which carried him to all-time winning streak of eight straight individual tournaments, may have taken too much out of the greatest golfing machine the game has ever known.

In shooting that brilliant nine holes, in which he made one eagle and four birdies, Nelson pulled back muscle which has kept him on the sidelines for the past week.

"Yes, I didn't do my back any good. It hurts," he said. "And frankly, I don't think I'm going to win this one. I'm afraid I shot my best round—I gave it too much."

33 Restaurants In Olympia Opened

OLYMPIA, July 27 (UP)—Thirty-three Olympia restaurants reopened today, ending their five-day strike in protest against a shortage of meat ration points.

OPA Cuts Points On Juices, Chili Sauce, Catsup

Raises Point Value On Six Others, However

WASHINGTON, July 27 (UP)—The office of price administration today cut the blue ration point values of grapefruit juice, orange and grapefruit juice blends, tomato catsup and chili sauce. It raised the values of six other canned foods. Changes are effective Sunday. New values will last until Saturday, Sept. 1.

The foods on which the blue values were raised are canned spinach, asparagus, applesauce, apples, apricots and grape juice.

Speed Up

The increases were ascribed to the necessity of conserving dwindling supplies.

Conversely, the lowering of values on grapefruit juice, catsup and chili sauce were to speed up movement of these products.

Values of other canned foods were not changed.

Ten points were added to these popular size canned foods: Spinach and asparagus, No. 2 cans, increased to 30 points; apple sauce and apples, No. 2 can, will be 20 points; grape juice, pint, will be 40 points.

20 More

Twenty more points were placed on spinach, No. 2 1/2 can, and apricots, No. 2 1/2 can, will be 50 points; and grape juice, quart size, will be 70 points.

A reduction of 10 points was made on: grapefruit juice, 46-ounce can, dropped to 10 points; grapefruit juice, No. 2 cans, reduced to two cans for 10 points; orange and grapefruit juice blended, 48-ounce can, down to 10 points, No. 2, to two for 10 points; and tomato catsup and chili sauce, 14-ounce size, to 10 points.

Markets

Stocks Regain Part Of Thursday Losses

NEW YORK, July 27 (UP)—Stocks regained part of yesterday's losses in a quieter session today.

Railroads made the best showing in the major sections. They had gains running more than a point while the industrial component showed a small decline because of losses of a point or more in a few leaders, including DuPont and Johns-Manville.

Airline stocks strengthened. Motors improved under the lead of Chrysler in point of gain and of Graham-Page in turnover. The latter equaled its high for the year. Aircrafts came back as much as 2 1/2 points in Douglas. Steels improved late in the day. Schenley gained more than a point in an irregular liquor section. Sweets company led the specials with rise of nearly 5 points to a new high.

Mill Buying Aids Futures in Wheat

CHICAGO, July 27 (UP)—Mill-buying against increased trend in wheat futures on the flour business imparted a firm board of trade today late profit-taking pared gains, other grains excepting oats ruled steady to firm.

Wheat finished the day up 1/2 to 1 1/2 cents a bushel; corn unchanged to up 1/4; oats off 1/4 to 3/4; rye up 1/4 to 3/4; and barley up 1/4 to 3/4.

Belief that the government August subsidy to mills will be cut stimulated flour business. Larger chain bakers and family trade also showed a more active demand. The trade regarded government buying of cash wheat in store as tempering the predicted subsidy cut next month.

Japanese Ignore Ultimatum Of Three Powers

Last Chance To Save National Existence

WASHINGTON, July 27 (UP)—Japan rejected the American-British-Chinese surrender ultimatum today despite the clear warning she now faces "prompt and utter destruction" by the mighty allied land, sea and air forces assembled in the Pacific.

The Japanese stand was announced by the government-controlled Domei news agency in a dispute haying Japan will ignore the allied ultimatum issued yesterday in Potsdam and will fight on "to the bitter end."

By its stand, the Japanese government itself rejected the last opportunity to halt the war without ending Japan's national existence and without bringing untold misery and suffering to her people.

President Truman, former Prime Minister Winston Churchill and Chinese Generalissimo Chiang Kai-Shek made clear yesterday what Japan will receive if she rejects their final terms for ending the war.

Pointing out that swarms of allied aircraft and hundreds of thousands of new troops were moving into the Pacific from the European theater, the three leaders said:

"The might that now converges upon Japan is immeasurably greater than that which, when applied to the resisting Germans, necessarily laid waste to the lands, the industry and the method of life of the whole German people."

"The full application of our military power, backed by our resolve, will mean the inevitable and complete destruction of the Japanese armed forces and just as inevitably the utter devastation of the Japanese homeland."

Blind Man Denies Hospital Attack

SEATTLE, July 27 (UP)—The charge by Rep. Jack Anderson, R., Calif., that blind veterans at Dibble hospital in Menlo Park, Calif., are treated as social outcasts is "an insult" to the hospital, a patient said today.

Pfc. Joseph Dillon, Portland, here on furlough, said he spoke for 150 blind patients. The doctors, he said, are doing everything they can "to improve our condition."

"Rather than call us 'social outcasts' we should be named 'honored guests,'" he said. "We can have furloughs whenever we are not under treatment. We can choose any traveling companion and all expenses, first class, are paid for both of us."

Dillon said the blind patients are fed ahead of all others, and attended classes for training in hobbies.

Seattle Slashes Beavers' Lead To Six Games

The second-place Seattle Rainiers moved up from seven to six games behind the league-leading Beavers Thursday night with a 7 to 1 win. The victory gave them two to Portland's one in their current series.

Elsewhere on the coast circuit the rampaging Hollywood stars downed Los Angeles 7 to 3. The San Francisco Seals took their game from Oakland, 6 to 3, and Sacramento edged out San Diego 10 to 7.

Right handed Joe Demoran, hurling his 11th win, allowed the Beavers eight hits, but he stopped Portland center fielder Frank Shone, who had hit in 39 consecutive games. Shone made four trips to the plate without a hit.

Sacramento cut its game-behind figure to 14 with its victory over the Padres by turning 14 hits into 10 runs while San Diego was able to collect only 7 tallies with the same number of hits.

General Commends Oregon Infantry

SALEM, July 27 (UP)—The 162nd infantry regiment, part of "Oregon's own" 41st national guard division, recently received a letter of commendation from Maj. Gen. F. C. Sibert, commanding the X corps of the 8th army, the state guard office here said today.

Railroads Face Two Postwar Problems

WASHINGTON, July 27 (UP) PORTLAND, after the war, either will have to cut wages and pay less for the things they buy or increase the rates they charge, a senate committee was told today.

J. M. Souby, general counsel for the association of American railroads, testified before a senate commerce subcommittee against a proposal to increase benefits provided workers under the railroad retirement act.
