Four Loyal Lieutenants 'Run' Things In Moscow For Nikita

By HENRY SHAPIRO UPI Staff Writer PITTSBURGH (UPI)—In the absence of Premier Nikita Khrushchev from Moscow, his enormous powers—leadership of the Communist Party and of the Soviet government—are exercised by a group of four trusted lieutenants.

The Council of Ministers, or Cabinet, is in the hands of Khrushchev's two first deputy prime ministers of equal rank. They are Anastas I. Mikoyan and Prok Kozlov, both of whom toured the United States earlier this year and paved the way for Khrushchev's visit.

In accordance with previously established practice, Mikoyan is responsible for foreign affairs and Kozlov manages internal administration.

Khrushchev is the first secretary of the Central Committee in which his two ranking deputies are Secretaries Mikhail Suslov and A.I. Kirichenko. Of the two, Suslov handles ideological and propaganda affairs while Kirichenko runs the vast administrative apparatus of the 133-man Central Committee.

Khrushchev's top four lieutenants are members of the Presidium and formally share power with the other 11.

In Khrushchev's absence they

are the dominant figures in the world's most centralized state.

The Central Committee and the Council of Ministers has the constitutional and effective authority to make major decisions of policy and administer routine affairs of state and party.

Unlike Stalin who held all the reins of power tightly and jealously, Khrushchev, ever when he is in Moscow, is known to delegate considerable authority to his subordinates.

The base of the pyramid structure of Soviet power has been broadened since Stalin's death and the Central Committee meets fairly regularly to discuss and initiate major policies.

Khrushchev told this correspondent in a private interview in 1957 that the Central Committee now constitutes the "collective leadership" of the party.
