#### **TODAY'S HIGHLIGHT**

On July 13, 1960, John F. Kennedy won the Democratic presidential nomination on the first ballot at his party's convention in Los Angeles, outdrawing rivals including Lyndon B. Johnson, Stuart Symington and Adlai Stevenson.

#### ON THIS DATE

In 1787, the Congress of the Confederation adopted the Northwest Ordinance, which established a government in the Northwest Territory, an area corresponding to the eastern half of the present-day Midwest.

In 1793, French revolutionarv writer Jean-Paul Marat was stabbed to death in his bath by Charlotte Corday, who was executed four days later.

In 1863, deadly rioting against the Civil War military draft erupted in NewYork City (The insurrection was put down three days later.)

In 1923, a sign consisting of 50-foot-tall letters spelling out "HOLLYWOODLAND" was dedicated in the Hollywood Hills to promote a subdivision (the last four letters were removed in

In 1939, Frank Sinatra made his first commercial recording, "From the Bottom of My Heart" and "Melancholy Mood," with Harry James and his Orchestra for the Brunswick label.

In 1965, President Lyndon B. Johnson nominated Thurgood Marshall to be U.S. Solicitor General; Marshall became the first black jurist appointed to the post. (Two years later, Johnson nominated Marshall to the U.S. Supreme Court.)

In 1972, George McGovern received the Democratic presidential nomination at the party's convention in Miami Beach.

In 1977, a blackout hit New York City in the mid-evening as lightning strikes on electrical equipment caused power to fail; widespread looting broke out.

# **Juvenile arrested in arson case**

The La Grande Police Department arrested a juvenile in connection to a series of arson fires in the downtown area over the last several weeks.

The 15-year-old male was arrested on charges of seconddegree arson, first-degree criminal mischief and eight counts of reckless burning.

Eight fires were set on two separate nights, according to a press release from the LGPD. Three were set June 28 and five more were set July 9.

The escalation of the situation was extremely concerning to LGPD.

"After the second fires downtown the priority level changed," LGPD Lt. Gary Bell told The Observer. "The investigation got the highest priority investigation in our (detective) section because we were concerned someone was going to get hurt."

One of the locations of the fire, according to Bell, was between the gas pumps at Safeway.

"The fire had completely melted down the garbage can between the gas pumps," he said. "Fortunately it didn't cause damage there."

Bell said the close proximity to the gas pumps could have made that situation catastrophic.

Additionally, fires were set behind Goss Motors, the Hideout Saloon, Century 21 and Dawn's Delights, among others.

The fire at Goss Motors scorched the side of the building, he said.

"That could've very easily caught the entire building on fire," Bell said. "There were flammable materials within the room and the fire had caused the windows to break."

Bell said there are apartment buildings in the downtown area and the police were very concerned that, given the escalation, the perpetrator would move from setting dumpsters on fire to buildings.

The fires also seemed to be set

consecutively, forcing the fire department to respond to multiple at once.

"On June 28, when the initial 911 calls came in for the first fire, it was at 3:38 a.m. The fire was reported at the Hideout Saloon. Immediately upon the response, the (fire department) identified the second and third fire. The truth is, we don't know which fire was lit first."

Bell said the fires set on July 9

were the same. "When the 911 call came in for the Safeway fire, (the fire department) responded to that one. They were in the process of extinguishing it and the officers were leaving the scene when they spotted another fire behind Century 21. That same period of time, two more fires were identified and then a third behind Dawn's Delights. All of them were

in the alleyway," Bell said. LGFD Fire Chief Les Thomas said he responded to the second round of fires on July 9 and saw the firefighters pulling their hose lines from one fire to another.

"They were literally dragging them ... from dumpster to dumpster,"Thomas said. "It was very labor intensive. They did a good size-up of which fires were priority."

Bell said the police relied heavilv on the community and the businesses' surveillance footage to catch the juvenile responsible. The community did a tremendous job, he said.

"The surveillance played a significant role in this," he said.

While the investigation is ongoing, he does not believe there is additional risk.

"We believe that we have the one person responsible for this," he said.

Thomas also wanted to commend the police department on their abilities for this investigation and how quickly it progressed.

"I applaud them for their efforts and we are very happy and thankful for the citizens who got involved," Thomas said.

The Union County Sheriff's Office also helped in this investigation.

## Blockbuster is down to one store, which is in Bend

Alaska's last two Blockbuster video stores are calling it quits, leaving just one store open in the U.S.

The stores in Anchorage and Fairbanks will close for rentals after Sunday night and reopen Tuesday for video liquidation sales through the end of August, said Kevin Daymude, general manager of Blockbuster Alaska.

"It's going to be crazy," Daymude said of the temporary reopening. He said residents were sad when they heard the news and many people have been reminiscing about their Blockbuster memories.

The news was announced to Alaskans on Blockbuster Alaska's Facebook page.

The closures come just two months after the host of HBO's "Last Week Tonight with John Oliver" sent a jockstrap worn by Russell Crowe in the 2005 movie "Cinderella Man" and other items to the Anchorage store, which displayed it in an effort to ramp up business.

Daymude says the buzz from the Oliver connection brought more people to the store.

"You would not believe how much business we got just from that memorabilia alone," he said. "I can't thank John Oliver or his show enough."

But it wasn't enough to counter a planned lease increase at both Alaska

The jockstrap will probably go to the franchise owner, Alan Payne, who lives outside Austin, Texas.

A request for comment from HBO was not immediately returned.

In its heyday, Blockbuster had 15 stores in Alaska, Daymude said. Some stores in more remote, less populated parts of the state began closing in the early 2000s.

The closures will leave the Blockbuster in Bend as the sole holdout.

"How exciting," said the Bend store's general manager Sandi Harding. "It might end up being a little chaotic for a couple of

As for the fate of that store, the future looks good.

## School employees to receive raises

The Union School District's administrators and confidential staff will receive

pay increases in 2018-19. The Union School Board voted Wednesday to give 1.5 percent pay raises to the school district's two administrators and two confidential staff members, said Superintendent Carter Wells.

Wells and grade school principal Chris Dunlap are the school district's administrators. Its confidential staff is composed of Deputy Clerk Mendy Clark and maintenance supervisor Jack Aldrich. Confidential employees are those who are not administrators or members of the school district's teacher or classified staff bargaining units.

The administrators and confidential staff members also received a boost of \$40 per month in the money they receive to pay for health insurance premiums.

Wells noted the pay and benefit increases received by the administrators and confidential staff are the same as those received by its teachers and classified staff. Classified staff employees include cooks, secretaries, custodians, grounds crew members and education aids.

In other matters at Wednesday's meeting, the school board spoke with Union County Sheriff's Deputy Tony Humphries about the work he will do as the district's new school resource officer in 2018-19. Humphries will provide at least 10 hours of service a week to the Union School District, which is believed to have never had a school resource officer until now. Humphries will also serve as SRO for the North Powder, Cove and La Grande school districts, who are pooling funds to pay for Humphries' services.

In La Grande, Humphries will assist Cody Bowen. Also a Union County Sheriff's Deputy, Bowen is the La Grande School District's full-time school resource officer.

Wells said Humphries will help train staff for emergency situations and work with students.

"He will be making sure we create as safe an environment as possible for our students and staff," the superintendent said.

Wells said Humphries is an ideal fit for the Union School District. He noted Humphries lives in Union and already knows many students in the school district because he has taught sixth grade Drug Abuse Resistance Education classes there.

"He will be a valuable asset to the school district," Wells said.
