Open flame restrictions increase

LA GRANDE — The City of La Grande Parks & Recreation Department announced that as of July 24, all fires are banned at Morgan Lake due to high fire danger. For more information, call the department at 541-962-1352.

On July 19, the Oregon Parks and Recreation Department prohibited all campfires and open flames in all state park properties in response to Gov. Kate Brown's declaration of a fire emergency. The campfire and open flame ban includes campgrounds, day-use areas and all areas of the Ocean Shore and beaches managed by OPRD. The fire ban applies to wood, charcoal

and other flame sources that cannot be turned off with a valve. Liquid fuel stoves or cooking devices that can be turned off with a valve are permitted, but cannot be left unattended.

The OPRD fire ban is expected to last at least one week and will be evaluated based on weather, resource conditions and input from Oregon Department of Forestry and other state and local fire officials.

Huckleberry Festival includes annual run/ walk

NORTH POWDER — The fourth annual Huckleberry Festival Run/Walk and Duathlon in North Powder is set for July 28. There will be a one-mile, 5K, 10K and a duathlon (12-mile bike ride and 5K run). Springfield police euthanize cougar sighted in backyard

■ Police enlist help of local big game tracker and his dog

SPRINGFIELD— Oregon police said they shot a cougar that was seen inside a fenced backyard stalking children while they were playing in a swimming pool.

Springfield police Lt. Scott McKee said they used a dog to track the cougar.

The dog chased the cougar up two trees where it was shot and killed.

Police said they decided to put down the 2-year-old, 70-pound (32-kilogram) cougar after the Oregon Department of Fish and Wildlife concluded that it was the only safe option.

Springfield police believe it was the same cat that was sighted on Sunday.

The animal's body was taken to the fish and wildlife department for a necropsy, or autopsy for animals, to determine if

it was in the area because it was sick or in search of prey.
